Tuesday, March 15, 1988

The Senate of the Fourteenth Legislature of the State of Hawaii, Regular Session of 1988, convened at 11:40 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by the Reverend Alex Vergara, Waianae United Methodist Church, after which the Roll was called showing all Senators present with the exception of Senator Hee who was excused.

The President announced that he had read and approved the Journal of the Thirty-Second Day.

The following introductions were then made to the members of the Senate:

Senator Solomon, on behalf of the President, introduced the California-Nevada-Hawaii Kiwanis District Governor Bob Jolley, Ms. Lynda Kim, governor of the Kiwanettes, California-Nevada-Hawaii District, and Mr. Ansel Kickbush, lieutenant governor of Kiwanis Hawaii, who were accompanied by Mrs. Marcia Jolley and Mrs. Virginia Kickbush.
