Senator Solomon rose on a point of personal privilege and stated:

"Mr. President, I am pleased to bring to the attention of the Senate the prominent position of the University of Hawaii, particularly the College of Tropical Agriculture and Human Resources, as recipients of international development contracts and grants.

"The University of Hawaii at Manoa ranked eighth in the nation by currently implementing international development contracts and grants with an aggregate value of well over \$45 million. The College of Tropical Agriculture and Human Resources accounts for over half of this figure with a total volume of business of well over \$23 million. We can deduce from these numbers that tropical agriculture is the main reason that Hawaii could claim to have its international university.

"I also bring to the attention of the Senators -- thank you for your generous support -- that Hawaii's agriculture agri-business benefits from this research, development and training conducted under these international contracts and

grants. For example, the state now has available technology to predict the quantity and the performance of crops in the numerous agricultural climates available to our islands.

"Also, Mr. President, Hawaii's capability to use biological means of providing nitrogen nutrient to crops and pasture plants as a substitute for chemical fertilizer comes from an international project which will be located on Maui.

"In addition, perhaps Hawaii's most effective linkage with its neighbors in the island nations of the South Pacific is through international agricultural programs.

"Mr. President, I am very pleased to announce to this Senate that we have received communication from our Congressional Delegation who are very much interested in giving a federal appropriation to accommodate our university's College of Tropical Agriculture and Human Resources for their new endeavor to establish a Center for Tropical and Subtropical Agriculture within the college to serve local, national and international needs. Thank you."
