

## FORTY-SIXTH DAY

Tuesday, April 4, 1989

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:38 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by Lt. Dayne Nix from the Office of the Chaplain, Naval Submarine Base, after which the Roll was called showing all Senators present with the exception of Senators Aki and Cobb who were excused.

The President announced that he had read and approved the Journal of the Forty-Fifth Day.

The following introductions were made to the members of the Senate:

Senator Tungpalan introduced Dr. W. Donald Duckworth, administrator of Bishop Museum and said: "Dr. Duckworth has added prestige to the museum and has aided in expanding the program of the museum to involve the residents of Hawaii on 'Family Sundays.' It is with pleasure that we recognize him at this time when we are celebrating the 100th anniversary of the founding of the Bernice Pauahi Bishop Museum. Dr. Duckworth is accompanied by his wife, Sandra, Mr. Philip Ching, vice president of the museum board, Mr. Kenneth Brown, chairman of the board, and Mr. John Dominis Holt, member of the board and cousin to Senator Holt."

Senator Levin then added:

"Thanks to Senator Tungpalan for allowing me to participate in this presentation. Each of us was a former Culture and the Arts chair in the House and with that background I was particularly interested in assisting today. Senator Tungpalan has already indicated that Bishop Museum is celebrating its 100th anniversary and in that regard we would like to present a Senate certificate not only to Dr. Duckworth but to Bishop Museum congratulating it and thanking it for the services it has performed to the State of Hawaii over these many years."

The honoree and his group rose to be recognized and were presented the congratulatory Senate certificate and leis.

Senator Solomon introduced Pastor Mealii Kalama of Kawaihau Church and said: "Mr. President, this is kind of a personal introduction because, believe it or not, when I was eight years old my mother sent me to Kawaihau Church to learn how to quilt and Pastor Kalama was my 'kumu'. (That means teacher in Hawaiian). I don't think that I was really recognized at that young age for my quilting capability but I must admit that under Pastor Kalama's direction, she taught me the discipline as well as what it takes to put together a beautiful Hawaiian 'kapa.' Incidentally, it is the same discipline that I use when I create my pieces of legislation."

"Pastor Kalama was recognized in the Senate of the United States as the 1985 Master Traditional Artist by the National Heritage Fellowship of the National Endowment for the Arts. Pastor Kalama is a lay pastor and for fourteen years has been encouraging and empowering members and friends in to the faith of God. Pastor Kalama not only is noted for her quilting skills, but also has perpetuated the Hawaiian language by teaching Bible classes in Hawaiian, teaching individuals and groups the Hawaiian interpretation and translation, and offering the meditation in Hawaiian language at the church."

"Pastor Kalama's quilts will be on display at the Smithsonian Institute in Washington, D.C., in June, and the Japanese Government will also have them on display for seven months in Japan."

Pastor Kalama rose to be recognized and was presented the Senate certificate of recognition and a lei.

Senator Crozier then introduced a group of "Friends of the Bishop Museum" who were seated in the gallery.

Senator Matsuura introduced Rashida Harris from Hong Kong, Linda Heindman from Minnesota, and Yolanda Alanez from Texas, who are with the Naval Reserve Training Center in Pearl Harbor, accompanied by his aide Ms. McKenzie.

Senator Fernandes Salling then made the following introduction:

"Mr. President, it gives me great honor to introduce to this body Mr. Walter 'Freckles' Smith Jr., much better known as 'Freckles' on Kauai. He is presently the president of Smith's Motorboat Service operating on the Wailua River. 'Freckles' was recently selected as Hawaii's Small Business Person of the Year for 1988. He has continued to successfully diversify and expand Smith's Motorboat Service by drawing upon values taught him by his father Walter Sr. and his mother Emily who is also with us here today. They started the business over 42 years ago."

"Walter has staged numerous promotional activities throughout the world to the great mutual benefit of the State of Hawaii, the Island of Kauai and Smith's Motorboat Service ... I would like this body to recognize Walter 'Freckles' Smith Jr. He is accompanied by his wife Moki, his mother Emily Smith, Mr. Whitney Smith, and his son Walter Smith III."

The honoree and his family rose to be recognized and were presented the congratulatory Senate certificate and leis.

Senator Fernandes Salling also introduced the following:

"Mr. President, I'm pleased to introduce and recognize, on this Senate floor, Mr. Richard Maeda. Richard was just recognized for being Kauai's Small Business Person of the Year for 1988."

"Richard is the president of Kauai Builders Ltd., a general contracting business which specializes in masonry and concrete work on the Island of Kauai ... His impressive list of achievements include his serving as past director of the Kauai General Contractors Association and a former director of the Kauai Chamber of Commerce. Richard is currently director of the Construction Industry Legislative Organization (CILO). He also serves on the Kauai Liquor Commission. Mr. Maeda is accompanied by his wife Yukie, and his daughter Sandy."

The honoree and his family rose to be recognized and was presented the congratulatory Senate certificate and leis.

At 11:53 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:00 o'clock p.m.
