The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:43 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by the Reverend Nathan Mamo, St. John Vianney Parish, after which the Roll was called showing all Senators present with the exception of Senators Cobb and Holt.

The President announced that he had read and approved the Journal of the Forty-Eighth Day.

At this time, Senator Reed rose on a point of personal privilege and remarked:

"Mr. President, there is a very brief editorial in this morning's Advertiser that I'd like to share, both because it is so rare that I agree with the positions taken by those who earn a living writing for the editorial staff of the Advertiser, and, also, because it addresses an issue that I believe deserves some serious policy discussion by this body in the future, perhaps next year. So I'll just read this editorial.

"It's entitled 'Fund-raising season... It's no coincidence that many state legislators hold fund-raisers when the session is nearing its end and lobbyists and others are most eager to get their bills passed.

"Talk about a captive audience, these are captive donors. And the system again favors incumbents.

"The Legislature should pass a bill banning fund-raisers during its sessions. But don't bet on it."
