# Thursday, April 13, 1989

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:43 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by Daiva Das, Iskcon Hawaii Inc., after which the Roll was called showing all Senators present with the exception of Senators Cobb, McMurdo and Nakasato who were excused.

The President announced that he had read and approved the Journal of the Fifty-Second Day.

The following introductions were then made to the members of the Senate:

Senator Solomon introduced Mr. and Mrs. Piset Buranasombati from Bangkok, Thailand, who were seated in the gallery. Senator Solomon said, "Mr. Buranasombati's family owns the Bangkok Business College, the largest and most advanced business college in Thailand. The college has an enrollment of over 4,000 students and the curriculum and equipment are geared toward international business."

Senator Koki then introduced Miss Jancy Kuwasaki who was seated in the gallery and said, "Jancy has been extremely helpful to me in my freshman term here in the Senate. She has been able to direct my attention to important dates, bills and many other things related to my senatorial duties. I really don't know how I would have gotten along without her."

Senator George introduced a group of 5th grade students from Aikahi Elementary School and their teachers, Joyce Trask, Charmen Olkowski and Miss Celina.

Senator Reed then introduced Margaret Miyashiro, "a dear friend from Molokai who many of us see here fairly regularly testifying and lobbying on behalf of the Hawaiian community for health care and other issues important to the Hawaiian people."

Senator Holt, on behalf of the Senate, introduced a group of 4th grade and special education students from Royal Elementary School, celebrating their 150th anniversary. The students were accompanied by their teachers, Karen Ginoza, Donna Higashi, Denise Nakata, Kim Ocvirk and Donald Sharp.

Senator Crozier, on behalf of Senator Aki and himself, introduced Mr. Joe Keliikoa, "an Army retiree who now works for the Air Force. He came all the way from Waianae to help me continue my record (of introductions). He is accompanied by his wife Germaine who is a member of my staff."

Senator Menor then introduced his student "shadow" Matthew Fabella from Wheeler Intermediate School.

Senator Fernandes Salling then made the following introduction:

"Mr. President, today, we have a young man sitting here on the floor that we would like to recognize and his name is Jade Charles.

"Jade is the son of Roberta and William Charles and is a 6th grader at Koloa School on Kauai. Jade was recently awarded first prize for his entry in the Mothers Against Drunk Driving (MADD) national poster-essay contest. And, as you can see, he's brought a photograph of the poster with him here today.

"Out of a total of 45,000 entrants, nationwide, Jade's entry captured first place in the poster division for grades 4 through 6. On April 4, he and his mother travelled to New York City to attend a special awards presentation commemorating his achievement. Jade is a well-rounded student and he also recently qualified to compete in the state physical fitness competition and because of his creative writing skills he was selected to represent his school in the language arts symposium, both of which were held in Honolulu.

"I'd like the Senate to recognize and honor Jade Charles on winning first prize in this contest and to wish him continued success in his future endeavors."

Jade Charles rose to be recognized and was presented the congratulatory Senate certificate and lei.

Jade was accompanied on the the floor by Carol McNamee of the Hawaii Chapter of MADD, and in the gallery, Rene Waldo, Ella Edwards and Anita DiMaura.

At this time, Senator Solomon rose to speak on a point of personal privilege as follows:

"Mr. President, at the request of Senator Richard Wong, I am circulating for the Senators' consideration a testimony that was put together in support of the Native Hawaiian Health Act that is being considered in the United States Senate. I am asking the Senators to please sign in support.

"As you know, Mr. President, the Hawaiians have one of the lowest life expectancy rates in the nation. Major causes of illness and death stem from partially preventable conditions such as heart diseases, cancer, diabetes. Also, infant mortality rates are higher than the national average.

"The Native Hawaiian Health Care Improvement Act report to the 100th Congress, Second Session, documents the health status statistics of the native Hawaiians. I am asking the Hawaii State Senate to endorse the report findings.

"Mr. President, the native Hawaiians represent approximately 19 percent of Hawaii's total population. Their extraordinary cultural values and unique medicinal practices need to be incorporated in the health and social services system which will nurture the strength of their culture while improving their health status.

"The State of Hawaii has developed programs which address community problems which may be a part of the native Hawaiians health and social services needs. For example, Mr. President, presently we are including some of these health practices in our child and maternal health programs available to the general public through the Department of Health. However, as you well know, such programs have limited resources and are unable to devote themselves to the integration of the important cultural needs of the native Hawaiians in service delivery.

"The purpose of this testimony is to support federal appropriations that would help us with these delivery services. So I'm asking all my fellow colleagues if they will take that into consideration as the Sergeant-at-Arms circulates the document for signature."

At 12:04 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:06 o'clock p.m.

At this time, Senator Holt, chairman of the Committee on Tourism, Recreation and Planning, requested a waiver of the 48-hour Notice of a Public Hearing on Gov. Msg. No. 304, and the Chair granted the waiver.
