

## SIXTIETH DAY

Monday, April 24, 1989

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 10:20 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by the Reverend George Toda, Honolulu Christian Church, after which the Roll was called showing all Senators present with the exception of Senators Cobb and Fernandes Salling who were excused.

The President announced that he had read and approved the Journal of the Fifty-Ninth Day.

At 10:22 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 10:43 o'clock a.m.

The following introductions were then made to the members of the Senate:

Senator Mizuguchi introduced Senator Crozier and said:

"Mr. President, this being the 60th Day, it's really an important and historic day for the Senate because our Senator from Makakilo will be making his 60th introduction today and, by making this introduction, he will have broken former Representative Ike Sutton's record for the most introductions during the legislative session. Today, he will be introducing someone very important to us.

"At this time, I would like to introduce the Senator from Makakilo, Senator Mike Crozier, to make his introduction."

Senator Crozier introduced "Aunty" Mary Gregory as follows:

"Mr. President, on behalf of all the members of the Senate, I would like to introduce a very special lady who has participated in the legislative process longer than any one of us in this room, including you, Mr. President, and you've been around for the longest time. I take that back; Senator Yamasaki's been here longer. I apologize.

"This woman, Aunty Mary Gregory, started off working at the printshop, I think, when the building first opened in 1969, and she's been here ever since. And she has become as much a part of the institution as the institution itself. Anytime anybody works in the underground section of the building, they all know Aunty Mary. They are always discussing with her the many concerns of the Legislature from the real grassroots perspective.

"She has spent many years in the Democratic Party as well, working again as a grassroots volunteer, all the way back to helping Governor Burns become the governor, then Governor Ariyoshi and also Governor Waihee. Aunty Mary has contributed quite a bit to the community and to the people of Hawaii.

"I would like my fellow colleagues to join with me in honoring Aunty Mary for 30 years of meritorious service here at the Senate printshop. Aunty Mary, please stand to be recognized."

Aunty Mary rose to be recognized and was presented the congratulatory Senate certificate and lei.

Senator Crozier also introduced a group of her friends and family who were seated in the gallery.

Senator Matsuura also rose to extend his congratulations to Aunty Mary Gregory.

Senator Chang then said:

"Mr. President, I'd just like to add that it's a particularly poignant moment for many of the Senators here because we knew Aunty Mary as young squirts on the Senate staff. These included Senators Russell Blair, Ann Kobayashi, myself, Senator Mizuguchi, Senator Holt, at least, as young squirts running around trying to learn the ropes from veterans like Aunty Mary, and I want to say, on behalf of all of us, thank you very much."

Senator Tungpalan introduced Mrs. Dolly Ching and Ms. Diane Plotts who were seated in the gallery.

Senator McCartney, on behalf of Senator Ann Kobayashi and himself, then introduced his pastor, Pastor George Toda, who gave the invocation today, and his wife Pat Toda.

Senator Blair introduced the following and said:

"Mr. President, I almost spent the whole session without introducing anyone. So as not to create a new record which couldn't be beaten by Senator Crozier next year, and knowing full well that he intends to break it, I would like to make my introduction for this session.

"In the tradition of Frank and Jesse James we have two distinguished brothers in the gallery, Steven and Russel Nagata, if they will please rise to be recognized.

"Mr. President, it's a very important introduction because we may at some point in the near future be voting on legislation which will affect the salary of one of the two brothers. It's important to point out that they are both very distinguished members of the bar. One of them works for the State of Hawaii and is often down here lobbying. The other has recently been made a partner in a very prestigious law firm and is also down here lobbying on a regular basis. I'm wondering if at some point they could both disclose their pay stubs so we'll see if the employees of the state are being overpaid or underpaid. Thank you."

Senator Levin then introduced Miss Ella Distajo and said, "... she is one of Aunty Mary's relatives who was very instrumental in my getting elected and being here."

At 10:52 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 10:59 o'clock a.m.

Senator Solomon rose to speak in support of the nominees as follows:

"Mr President, I am speaking in support of Gov. Msg. No. 315.

"Mr. President, as you well know, your Committee on Higher Education did waive the 48-hour notice so that we could accommodate the public and have a public hearing for the two nominees that are before this body's consideration, Momi Cazimero and Diane Plotts.

"Mr. President, your chairman on Higher Education takes the State Constitution very, very seriously, especially the part that provides authority for the governor to nominate persons to serve on various state boards and commissions, and by and with the advice and consent of the Senate, appoint all officers. The final point, Mr. President, on every nomination shall be, by and with the advice and consent of the Senate."

"As well you know, Mr. President, the timetable may be such that input from the public often comes on the day or even up to minutes before the hearing that the nominee is considered. As a custodian of the public trust, we legislators must often delay decisions on the nominees until we have some feeling that the public has had adequate chance for input. Such delays are not to be construed as actions to humiliate, nor are they questioning the qualifications of the nominee. If there is no advice and consent, Mr. President, then the governor could make any appointment with no vehicle for input from the public.

"Needless to say, Mr. President, your chairman was quite disturbed at the editorial that appeared in the Advertiser last Saturday on 'University matters.' Under the subtitle 'Respect for regents,' it says, 'There's no better way to discourage good people from serving on government boards than to subject them to a capricious, unpleasant "advise and consent" process.' Mr. President, I beg to argue the point.

"In deliberating a decision, Mr. President, on the nominees, your Committee on Higher Education had to take the following into consideration:

'The Powers and Responsibilities of the Board of Regents, the State Constitution, Article X, Section 5: "The University of Hawaii is hereby established as the state university and constituted a body corporate. It shall have title to all the real and personal property nor or hereafter set aside or conveyed to it, which shall be held in public trust for its purposes, to be administered and disposed of as provided by law."

"Mr. President, Article X, Section 6 defines the powers of the Board of Regents as follows: '... The board shall have the power, as provided by law, to formulate policy, and to exercise control over the university through its

executive officer, the president of the university, who shall be appointed by the board; ....'

"It continues, Mr. President, in the Hawaii Revised Statutes, stipulated in Chapter 304 and extends through Chapter 310. Specifically the powers provided the Board are:

'To adopt, amend, and repeal bylaws governing the conduct of its business and the performance of the powers and duties granted to or imposed upon it by law.

'To acquire in any lawful manner any property, real, personal, or mixed, tangible or intangible, or any interest therein; to hold, maintain, use and operate the same; and to sell, lease, or otherwise dispose of the same at such time, in such manner, and to the extent deemed necessary or appropriate to carry out its purposes.'

'To enter into and perform such contracts, leases, cooperative agreements, or other transactions as may be necessary in the conduct of its business and on such terms as it may deem appropriate, with any agency or instrumentality of the United States, or with any state, territory, or possession, or with any political subdivision thereof, or with any person, firm, association, or corporation.'

"Mr. President, it continues to read:

'To determine the character of and the necessity for its obligations and expenditures, and the manner in which they shall be incurred, allowed, and paid, subject to provisions of law specifically applicable to the university.

'To execute, in accordance with its bylaws, all instruments necessary or appropriate in the exercise of any of its powers.'

'To take such actions as may be necessary or appropriate to carry out the powers conferred upon it by law.'

"The board also, Mr. President, is to appoint, terminate, support and monitor the president; clarify the institution's mission; and approve the institution's statement of mission.

"Insofar as planning is concerned, Mr. President, the board is not to draft the strategy, but to insist that the administration do so and in a manner that would properly serve the institution.

"In overseeing the Education Programs, the president must cope with demands of students, faculty, parents, and the local community but it is the board that must decide the institution's direction; what new programs will be added and what obsolete ones, if any, to be abandoned.

"It continues, Mr. President, to read, 'to Ensure Fiscal Solvency, it is the responsibility of the board to prudently manage all institutional finances.'

"It continues, 'to Ensure for Development and Maintenance of the Physical Plant, the board has overall responsibility for the physical condition of the institution.'

"It continues, 'to Interpret the Institution to the Community, the generating of trust in the institution by the public is a tough responsibility. The board should be actively working to interpret the campus to the community and defend the institution against outside pressure.'

"It reads on, Mr. President, under 'Tomorrow's Demands. To Ensure for Fair and Equitable Treatment, it is the board's responsibility, therefore, in light of its final decision-making power to insure that their delegated authority accords fair and equitable treatment to all members of the university community.'

"Mr. President, for a 'Bridge between Community and Campus the board must insure that their institutions serve the social purpose of the State of Hawaii.'

"It continues to read, Mr. President, under 'the Assessment of Institutional Performance,' the board even has the prerogative to come up with its own self evaluation.

"Mr. President, need I say more.

"The editorial continues and I read, 'Senators should make sure appointees are qualified, without obvious conflicts and with the interest of the institution they serve at heart. But the process can be abused when it even temporarily becomes a question of personality and style ....'

"Well, Mr. President, if you read the responsibilities that the board has, it is quite obvious that character and a regent's understanding to what Hawaii is all about is eminent and important.

"This is why, Mr. President, your Committee on Higher Education regarding the committee report on the governor's message just included one paragraph that says, 'Your Committee on Higher Education, after full consideration of the background, character, experience and qualifications of the nominees, has found the nominees to be qualified to the positions to which nominated and recommends that the Senate advise and consent to the nominations.'"

Senator Tungpalan also in support of the nominees said:

"Mr. President, I'd like to have the remarks of Senator Solomon entered into the Journal as though they were my own because I also feel that the Senate should have the right to advise and consent."

"Mr. President, S.B. No. 42 was introduced on behalf of Stephen Kahikinaokalamehana Enos. Mr. Enos was just a fetus when this bill was introduced, but he was the chief impetus for its introduction.

"In anticipation of his arrival, Stephen's mother, like most young mothers in Hawaii, began to plan the balancing of her roles as Stephen's mother and as a necessary contributor to the household's income. Her heightened awareness of the importance of affordable child care for working mothers precipitated a heightening of my own awareness. In response, I drafted and introduced S.B. No. 42 which increases the income tax credit for household and dependent care services necessary for gainful employment.

"This bill will materially assist single parent households and families with both parents employed. In Hawaii, economic necessity has put almost all of our young families into these categories.

"This bill increases the tax credit by increasing the percentage of the expenses which can be claimed. The current law allows between 10 and 15 percent of the expense. This bill increases those percentages to between 15 and 25 percent. Regrettably, the dollar limit, or cap, has not been raised. While the bill has been amended several times and, in the process, made less generous than when introduced, it is still a substantial improvement on the current law. I wish to thank everyone who helped, but especially Senator Yamasaki and Representative Arakaki.

"I would also like to serve notice of my intent to come back next year with a new bill to simplify and further expand this credit. In addition, I will be working with the Chamber of Commerce and the Office of Children and Youth to encourage businesses to support child care in or near the work place.

"As the employer of Stephen's mother, I was happy to be able to provide the informal child care that allowed me to retain my most valuable staff member. I look forward to the day when the Legislature and most other employers will provide appropriate, accessible child care at an affordable price.

"On behalf of Stephen Kahikinaokalamehana Enos and all the children of Hawaii, I commend S.B. No. 42 to my

colleagues and ask for your affirmative vote. Thank you."

Senator McCartney then requested of the Chair as follows:

"Mr. President, on behalf of Senator Holt and the State Senate, I would like to extend our congratulations to a member of Senator Holt's staff, Daynin Allosada, who won the Miss Philippine-America contest in Atlantic City this weekend.

"Daynin asked if we could read a message to the Senate for the Journal. May I do so, Mr. President?"

The Chair permitted Senator McCartney to read the message.

Senator McCartney read the message as follows:

"Your words and encouragement have given me the boost of confidence I needed to take with me to Atlantic City. I dedicate my title to you all and thank you again for your help and the wonderful reception before I left. As I continue this next year representing the Filipino people of America, I too will be representing the Fifteenth Legislature of the State of Hawaii and I am honored and proud to have been a part of it. Thank you again and I hope to see you all when I return. Aloha, Daynin Allosada."

Senator Reed then rose to speak on a point of personal privilege as follows:

"Mr. President, I rise on a point of personal privilege. Although the graying Senator who sits directly behind me has evidently been lobbying for an extended session for purposes of establishing a new introduction record, I'd like to briefly express some remarks in opposition.

"The failure to allow for genuine public involvement in the legislative process and the annual need for extending the session makes it incumbent on this body to consider reform measures including the following:

Year-round introduction of legislation with a limit on the number of bills each legislator can introduce;

Longer periods for review and discussion of proposed legislation; perhaps by extending the recess; and

A change in the dictatorial practice of giving virtually total control to committee chairmen.

"Last year there were promises to change the system of powerful chairmen. The system was not changed. In

fact, it has become worse. The placement of so much authority and decision-making responsibility in the hands of committee chairmen is a primary reason this Legislature regularly violates the Sunshine Law. This system of power chairmen is also the key reason this body has once again failed to finish its business on time.

"Any objective observer of this legislative session has to be dissatisfied with both the process and the product. I speak against the extension and for legislative reform."

Senator Blair responded as follows:

"Mr. President, I rise on a point of personal privilege to echo many of the sentiments of the previous speaker.

"I believe we should look seriously at year-round bill introduction, as well as a more liberal -- if you will pardon the use of the word -- use of recess periods to give us time to be more deliberative as there are many other procedural improvements which can be made. I assure Senator Reed that the commitment of the majority caucus continues and we will try to work with him during the interim so that we can improve matters. The Democratic majority is committed to an open and accountable process.

"I differ only on a technical point, Senator Reed's continuing assumption that there have been violations of the sunshine law. I thought his misunderstanding of the nonapplicability of Chapter 92 to legislative proceedings had been put to rest. I do not concur in that portion of the previous speaker's remarks."

Senator Crozier rose on a point of personal privilege as follows:

"Mr. President, when the Senator from the Island of Maui commented on the graying Senator, I assume he was talking about my jacket. Because, compared to other individuals in this process, I have a long way to go before I arrive in gray, Sir." (Laughter.)

At this time, Senator Chang introduced to the members of the Senate Miss Sunny Jones from Piedmont, California.

Senator Ikeda also rose to speak on a point of personal privilege as follows:

"Mr. President, I rise on a point of personal privilege.

"Mr. President, I hate to inform you or regret to inform you that there will be no more discussion nor corrections of technical flaws with S.B. 667 having to do with the natural area reserves.

"I have spoken to my House counterpart, Representative Mark Andrews, who is the chairman of the House committee managing this bill. He informs me that they recommitted the bill not because of the technical flaws, but because it didn't have a proper public hearing. That was done, Mr. President, despite the fact that late April 21st he sent me the following memo and I'd like to read it to you.

"After reviewing your proposed amendments to S.B. No. 667, S.D. 1, H.D. 2, we feel that the proposed draft is acceptable. Upon completion of a conference draft please deliver copies to my staff and we will circulate them for signatures.

"Regarding S.B. No. 1344, S.D. 1, H.D. 1, as discussed in conference on Thursday afternoon I am willing to accept the Senate's proposed amendments."

"I might add at this point, Mr. President, that the Senate did not have any amendments to offer at that point in time. The memo continues:

'Given the merits of the bill and closeness of positions between the House and the Senate, I believe the members of the conference committee, myself included, are more than willing to accept the proposed Senate amendments and any other clarifying amendments. Again, please have a conference draft prepared and delivered to my staff for House signature.

'If time is a problem my staff is available for any type of drafting or clerical assistance.'

"Mr. President, both bills were taken up at that Thursday afternoon and agreement was, the deferral was made on the part of the House at the request of the House to come up with amendments. The Senate then moved to draft its proposed amendments on both bills since no discussion took place on either one of the bills.

"Now, to find out after having this written agreement that the House has recommitted the bill because of the fact that it lacked a proper public hearing, it also puts a cloud on S.B. 1344 because that bill too lacked a proper public hearing.

"I am not suggesting, Mr. President, that the House recommit both bills. But, if the (House) chairman of the Committee on Planning, Energy and Environmental Protection, number one, is good for his word then both bills should be passed. If he isn't, and a public hearing or the lack of it is a problem, then both bills should have been recommitted by the House.

"Thank you, Mr. President."
