

## THIRTEENTH DAY

Tuesday, February 6, 1990

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1990, convened at 11:35 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by the Reverend John B. Connell, St. Barnabas Episcopal Church, after which the Roll was called showing all Senators present with the exception of Senators Aki and Koki who were excused.

The President announced that he had read and approved the Journal of the Twelfth Day.

The following introductions were then made to the members of the Senate:

Senator McCartney introduced Mr. John Radcliffe, former executive secretary of the Hawaii State Teachers Association, who was seated in the gallery.

Senator A. Kobayashi, on behalf of Senators Matsuura and Yamasaki, introduced Mr. Ryotaro Sugi, movie actor and television star in Japan, who was seated in the gallery with Mr. Richard Fukuda, his attorney, and accompanied by a Mr. Endo. Senator A. Kobayashi added: "Mr. Ryotaro Sugi is a philanthropist who travels around the world trying to make life better for people. He has donated thousands of dollars to charities here in Hawaii and he is here again this year to look over different charities to help."
