## SIXTEENTH DAY

## Tuesday, February 12, 1991

The Senate of the Sixteenth Legislature of the State of Hawaii, Regular Session of 1991, convened at 11:40 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by the Reverend E. Daniel Smith of St. Christopher's Episcopal Church, after which the Roll was called showing all Senators present with the exception of Senator B. Kobayashi who was excused.

The President announced that he had read and approved the Journal of the Fifteenth Day.

Senator Chang then introduced to the members of the Senate Mr. Stasys Kasauskas, member of the Lithuanian Parliament, who was seated in the gallery. Senator Chang said, "Mr. Kasauskas is a highly acclaimed author and is visiting Honolulu as a guest of the Lithuanian community. He hopes to gain support from the people of the United States and especially the Hawaii State Legislature for the Lithuanian independence movement."

Senator Cobb greeted Mr. Kasauskas, in Russian, translated as follows: "Mr. Kasauskas, I wish you Aloha on behalf of all the members of this Senate and I wish you the very best of luck in your endeavor towards independence."
