Friday, February 15, 1991

The Senate of the Sixteenth Legislature of the State of Hawaii, Regular Session of 1991, convened at 11:35 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by Sister Kathleen Marie Shields, St. Stephen's Diocesan Center, after which the Roll was called showing all Senators present with the exception of Senators Cobb and McMurdo who were excused.

The Chair announced that he had read and approved the Journal of the Eighteenth Day.

The following introductions were then made to the members of the Senate:

Senator George introduced Ms. Carmelle Cerivellione, seated in the Senate gallery, as follows:

"Mr. President, I have the pleasure this morning of introducing my shadow. Her name is Carmelle She is a participant of Class 4 of the Cerivellione. Agricultural Leadership Foundation of Hawaii. The foundation was established to develop and support effective leaders in the agricultural industry, a very important agricultural industry. The goal of the foundation is to provide experiences to promote positive problem solving, build confidence, gain access to beneficial broaden and participants' resources, prospective of statewide agriculture."

Senator A. Kobayashi then welcomed and introduced Congressmen Eni F.H. Faleomavaega and Donald Payne of the Congress of the Territory of American Samoa who were seated on the floor of the Senate. Senator Kobayashi said Congressman Faleomavaega was born and raised in Hawaii and graduated from Kahuku High School.

The gentlemen rose to be recognized and were greeted by the members of the Senate.

At this time, the Chair introduced a group of 13 students from the Hawaii Competency Base High School Diploma Program of Waianae High School and their teachers, Mrs. Neddie Waiamau-Nunuha, Mr. William Keola and Mr. Ignacio, who were seated in the gallery.

Senator Chang then introduced Mr. Alan H. Gottlieb, seated in the gallery, as follows:

"Mr. President, my intern from the Agricultural Leadership Foundation of Hawaii is Alan Gottlieb. Alan is a graduate of the University of Hawaii, Manoa, with a bachelor's in business administration and accounting. He is the vice president and general manager of Kahua Meat Company and is responsible for overseeing the procurement and deeding of cattle and the overall planning, organizing and controlling of their beef fabrication plant and multi-species slaughterhouse. He is an active member in cattle and meat industry associations in Hawaii and on the Mainland."

Senator McCartney, on behalf of Senator Koki and himself, introduced Mr. Fred Shiroma, also seated in the gallery, their intern from the Agricultural Leadership Foundation of Hawaii. Mr. Shiroma is a banana farmer from Luluku in Kaneohe. Senator McCartney then introduced representatives of the Junior Achievement Program, seated on the floor of the Senate, as follows:

"Mr. President, I am pleased and honored today to recognize the Junior Achievement Program. As you know, this month has been proclaimed by Governor Waihee as Junior Achievement Month in Hawaii and today we have representatives from the program to be recognized by the Senate.

"Junior Achievement was set up to provide young people with practical economic education programs and experiences in the private enterprise system through a partnership with business and education communities. Junior Achievement is the oldest and largest and fastest growing business and economic nonprofit educational organization in the world.

"Junior Achievement of Hawaii was organized locally in 1957 and originated as a juvenile delinquency venture program. Since then, Junior Achievement of Hawaii has expanded into four programs and places over 200 volunteers in businesses and classrooms on five islands with an outreach of more than 600 students statewide this academic year.

"On behalf of the state Senate we'd like to congratulate and recognize Junior Achievement of Hawaii for its outstanding achievements in economic education and commend them for their commitment to community service.

"Mr. President, today we have from Junior Achievement of Hawaii: Mr. Dennis Reeves, chairman of the board; Mr. Blair Craig, president; Education Services Officer Dina Lewandowski; Ms. Marilyn Tomita from Kaimuki High School, an applied economics teacher; Mr. John Panoke, student from Kaimuki High School; Mr. Michael DeSalles, programs consultant; Superintendent of Education Charles Toguchi; Ms. Jan Ohtani, Hawaii director; and Ms. Sharon Paik, Hawaii marketing manager."

The representatives from Junior Achievement of Hawaii rose to be recognized and were presented the congratulatory Senate certificate and leis by various Senators.
