### FORTIETH DAY

## Thursday, March 28, 1991

The Senate of the Sixteenth Legislature of the State of Hawaii, Regular Session of 1991, convened at 11:39 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by Bishop Toshimasa Nakanishi, Honpa Hongwanji Mission, after which the Roll was called showing all Senators present with the exception of Senators Holt, Matsuura and Reed who were excused.

The Chair announced that he had read and approved the Journal of the Thirty-Ninth Day.

The following introductions were then made to the members of the Senate:

Senator McMurdo introduced the following cadets of the Junior ROTC Programs of Hawaii, seated in the gallery, who were selected for the 1991 Spring Camp Daedalaen Award: Jerry Agustin of Farrington High School; Eric Marshall of Leilehua High School; Scott Mallon of Konawaena High School; Loren Aquino of McKinley High School, Corey Wardell of Roosevelt High School; Beverly Gaboya of Waianae High School; Daniel S. David of Kailua High School; Steve Smith of Radford High School; Daniel S. Ryan of Kamehameha Schools; and Allen Alford and Allen P.A. Alford of Damien High School. The cadets were accompanied by Mr. Hank English and Major Gary Danio, ROTC instructor at Farrington High School.

Senator McMurdo said that the cadets will be flying gliders, and receive hands-on experience at Dillingham Airfield as part of this youth aviation education program and will be taken on a tour of the 15th Air Base Wing at Hickam Air Force Base, Pacific Air Force Command, and the Hawaii Air National Guard.

Senator Solomon then recognized and introduced Mr. Kenneth F. Brown, seated on the floor of the Senate, as follows:

"Mr. President, it gives me great pleasure, today, to present a Senate certificate honoring Kenneth F. Brown. I would like to read the certificate because the words are very meaningful.

'Kenneth F. Brown, a native son and lifelong resident of Hawaii, has devoted his life to serving his community in a number of important roles including state Senator (1968 to 1974) and chairperson of the boards of Queen's Medical Center, the Pacific Ocean Research Foundation, and the Bishop Museum. He was named Outstanding Businessman of 1983 and Hawaii's Humanitarian of the year, characterized as a "Living Treasure" by the Honpa Hongwanji Mission, and received the Na Po'okela Award. But perhaps Mr. Brown's greatest achievements have come through his efforts, as a practicing ambassador of Aloha, to (in his own words) "forge a dynamic and yet coherent harmony in today's contentious world."

'Kenneth F. Brown will retire from the Board of Governors of the East-West Center in June 1991 after nine years of exemplary service. The Senate of Sixteenth Legislature of the State of Hawaii, Regular Session of 1991, expresses deep appreciation and gratitude to Kenneth F. Brown for his lifetime of service to the people of Hawaii, and wishes him happiness and fulfillment in all his future endeavors.'"

Mr. Brown, accompanied by his wife Joan, rose to be recognized and was presented the congratulatory Senate certificate. Leis were presented to Mr. and Mrs. Brown.

Senator Solomon continued:

"Mr. President, as you know, doing business in Hawaii has changed quite dramatically. We are moving away from the philosophical spirit of Aloha as we move into the year 2000. The Hawaiian spiritual values such as 'lokahi,' such as 'laulima,' such as 'hoowai,' which means to enrich all of those around us, are essential. So essential, Mr. President, that the Hawaii State Legislature did pass a bill encouraging all of us to remember these spiritual values as we conduct our legislative affairs as well as we conduct our commercial business in the State of Hawaii.

"Accompanying Kenny Brown are his dear friends and, of course, all of you know who they are. But in my mind, Mr. President, these three individuals possess and continue to practice those spiritual values in their own respective fields: Aunty Gladys Brandt, an educator and former chairman of the University of Hawaii Board of Regents; Mr. Keiji Kawakami, retired businessman of family-owned Iolani Sportswear, who, in presenting the image of the aloha shirt, I'm sure is responsible for Aloha Friday in the State of Hawaii; and of course, our chief judge of the Intermediate Court of Appeals, Judge James Burns."

Mrs. Brandt, Mr. Kawakami and Judge Burns all rose to be recognized and were presented leis by various Senators.

Senator McMurdo, in observance of Doctors' Day, March 30, 1991, and throughout the year, introduced a group of Hawaii doctors representing the Hawaii Medical Association as follows:

"President George Bush has officially proclaimed March 30, 1991, as 'National Doctors' Day,' culminating the efforts of the United States Senate and the House to establish a day of recognition for the valuable contributions that physicians have made to the nation and continue to make in their practice of medicine.

"Since March 30, 1933, which is the first observed Doctors' Day, physicians throughout the country have been honored with a special day for their efforts to improve the science and art of healing through their contributions to advancing scientific knowledge, to using their knowledge in the never-ending fight against disease and toward the improvement of health.

"In honor of Hawaii's nearly 5,000 doctors, Governor John Waihee has declared Saturday, March 30th, to be 'Doctors' Day in Hawaii' to pay tribute to Hawaii's own physicians for their special empathy and compassion while ministering to the sick and alleviating human suffering.

"The Sixteenth Senate, Regular Session of 1991, salutes Hawaii's doctors for their tremendous efforts and results in continuing to keep Hawaii the healthiest State in the Union and congratulates them on their special day.

"Seated with us on the floor today, representing the Hawaii Medical Association are: Dr. John T. McDonnell, president of the Hawaii Medical Association (HMA); Dr. Stephen Wallach, president-elect of HMA; Dr. Calvin Wong, representing Honolulu County Medical Society; Dr. George Takushi, legislative committee chair;

Dr. George Starbuck, physician of the year, 1990-91; and Dr. Charlotte Florine, senior physicians committee."

The honorees rose to be recognized and were presented the congratulatory Senate certificate and leis were presented by Senators A. Kobayashi, George, Ikeda, Fernandes Salling, Solomon and Levin.

Senator McMurdo also introduced Ms. Jan Estioko, director of communications for HMA, and Ms. Maureen Lau, president of the HMA Auxiliary, who were seated in the gallery.

Senator Nakasato then introduced a group of 17 Young Friends of Adult Friends of Youth which is an agency providing unique outreach services, especially in the Kuhio Park Terrace area, accompanied by staff members, John Horsfall and Pasimi Hingano.

Senator Tungpalan then extended her congratulations to Mr. Kenneth Brown as follows:

"Mr. President, I feel I will be remiss if I didn't add a few words of praise to our honoree Mr. Brown.

"Last night, I met Mr. Brown for the first time and had a chance to engage in conservation for maybe a half-anhour. I felt at the end of the half hour that I knew this man for all my life. It's amazing how warm and wonderful a person he is. Mr. Brown, is all the things that our Senator from Kohala mentioned.

"But I want to share with him my aloha for giving me that opportunity to get to know him a little better. I did have an opportunity to share with our Culture, Arts and Historic Preservation Committee some of the ideas that he espoused and will look forward to working with him in making that dream come true. I'm talking and referring to Waipio Valley as a future site for dispute resolutions. Hawaii should be, I think, known for its inherent quality of peace and harmony, and I certainly want to assist Mr. Brown and anyone in our community and in our nation and world who would like to meet that endeavor to bring peace and harmony to our world. Certainly, Waipio is the place we can start. Thank you very much."

Senator Solomon, on behalf of Senator Yamasaki, Senator Reed and herself, introduced the delegation of the Upward Bound Project of Maui Community College: students - Sue Akuna, Heather Boynthon, Uilani Keliikoa, Davenat Kama, Lalena Dutro, Josephine Censer, Jason Archangel and Lee-Taylor Peterson; advisors - Nancy Hasenpflug, Mary Ann De Cambra, Lucille G. Medeiros, Diana Harris and Brian K. McKinnon.

Senator McCartney then introduced Salina Nau and Margaret Britche, his student "shadows" from Kahuku High School who were seated in the gallery.
