

## FIFTY-SIXTH DAY

Tuesday, April 23, 1991

The Senate of the Sixteenth Legislature of the State of Hawaii, Regular Session of 1991, convened at 11:42 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by Chaplain Richard Spearman Jr., U.S. Air Force, after which the Roll was called showing all Senators present with the exception of Senators Chang, McMurdo and Wong who were excused.

The Chair announced that he had read and approved the Journal of the Fifty-Fifth Day.

The following introductions were made to the members of the Senate:

Senator A. Kobayashi introduced a group of 64 second grade students from Kuhio Elementary School, seated in the gallery, accompanied by Mrs. Alice Hirashima, Mrs. Ono, Ms. Anderson, Mrs. Chun and Ms. Kimizuka.

Senator Tungpalan then introduced Mrs. Momi Lum and Father Clark Horan who were also seated in the gallery.

Senator Levin then recognized Mental Health Month and introduced Dr. Marvin Mathews as follows:

"Mr. President, each year the month of May is recognized as Mental Health Month. Since the Legislature has vowed to adjourn on time on April 29th, we would like to issue our proclamation today to acknowledge the importance of this issue to bring attention to the needs of our community, and to thank those who work so hard to improve the mental health of our people.

"With us today to accept the Senate certificate as well as our gratitude is Dr. Marvin Mathews, who is the chief of the Child and Adolescent Mental Health Division of the State Department of Health.

"We all know that Hawaii is ranked No. 51 in mental health. This gentleman and his staff, as well as innumerable private health care providers, are doing far more than their share to turn this situation around and we in the Legislature, including Senator Yamasaki and Senator McMurdo, are committed to doing our part as well.

"Dr. Mathews may I ask you to please stand to be recognized."

Dr. Mathews rose to be recognized and was presented the Senate certificate proclaiming "May is Mental Health Month" by Senator Levin.

At 11:46 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:51 o'clock a.m.

## STATEMENT OF OBJECTIONS TO HOUSE BILL NO. 275

Honorable Members  
Sixteenth Legislature  
State of Hawaii

Pursuant to Section 16 of Article III of the Constitution of the State of Hawaii, I am returning herewith, without my approval, House Bill No. 275, entitled 'A Bill for an Act Relating to the Western Interstate Commission on Higher Education.'

The purpose of House Bill No. 275 is to expressly state that a member of the Western Interstate Commission on Higher Education ('WICHE') does not hold a public office so as to permit legislators to serve as commission members.

Section 8 of Article III of the Constitution of the State of Hawaii precludes legislators from holding all but three types of public offices of the State. The constitutional debates on that section indicate that the delegates did not intend to allow the Legislature to add to the list of offices excepted from the 'no other public office' disqualification imposed by Section 8. Accordingly, the amendment to section 310-4, Hawaii Revised Statutes, to be made by this bill is not a rightful subject of legislation.

For the foregoing reason, I am returning House Bill No. 275 without my approval.
