#### FIFTY-EIGHTH DAY

#### Thursday, April 25, 1991

The Senate of the Sixteenth Legislature of the State of Hawaii, Regular Session of 1991, convened at 11:43 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by Pastor Larry Kositsin, Seventh-day Adventist Church, after which the Roll was called showing all Senators present with the exception of Senator Yamasaki who was excused.

The President announced that he had read and approved the Journal of the Fifty-Seventh Day.

The following introductions were then made to the members of the Senate:

Senator Koki, on behalf of Senators George, McCartney and himself, introduced a group of 15 fourth grade students from Trinity Christian School in Kailua, their teacher, Mrs. Nancy Sober, and parent-chaperone, Mrs. Diane Lim, who were seated in the gallery.

Senator Hagino introduced to the members of the Senate Mr. Chin Kuk Chang of the Republic of Korea, who was seated on the floor of the Senate, as follows:

"Mr. President, it is a great honor for me to introduce an individual from the Republic of Korea who is visiting our state to see how our form of state and city government operates. What is special about this individual is that he is one of the few persons who has been recently elected into public office in March of this year. The public office which he was elected to is equivalent to that of our city council. This election is the first free election in local politics in the Republic of

Mr. Chang rose to be recognized and was welcomed to the Senate with a lei by Senator Tungpalan.

STATEMENT OF OBJECTIONS TO HOUSE BILL NO.

Honorable Members Sixteenth Legislature State of Hawaii

Pursuant to Section 16 of Article III of the Constitution of the State of Hawaii, I am returning herewith, without my approval, House Bill No. 7, entitled 'A Bill for an Act Relating to Driver Education.'

The purpose of House Bill No. 7 is to delete the time restrictions of the motor vehicle driver education and training program operated by the Department of Education and to open enrollment in the program to public and private high school students.

Section 1 of Article X of the Constitution of the State of Hawaii prohibits the appropriation of public funds for the support or benefit of sectarian or private schools. In Spears v. Honda, 51 Haw. 1 (1968), the Hawaii Supreme Court considered but rejected the argument that the provision is not violated when funds are spent to defray costs incurred by private school students and not their Accordingly, because House Bill No. 7 opens participation in the Department of Education student driver education program to private high school students, I believe it violates the Hawaii State Constitution.

For the foregoing reason, I am returning House Bill No. 7 without my approval.

#### ADVISE AND CONSENT

Ldr. Com. Rep. No. 1440 (Gov. Msg. No. 57):

Senator A. Kobayashi moved that Ldr. Com. Rep. No. 1440 be received and placed on file, seconded by Senator Hagino and carried.

Senator A. Kobayashi then moved that the Senate advise and consent to the nomination of Yukio Kitagawa for Chairman, Board of Agriculture, term to expire December 31, 1994, seconded by Senator Hagino.

Senator A. Kobayashi rose to speak in support of the nominee as follows:

"Mr. President, I rise to speak in favor of this nomination.

"Mr. President, we have had many talks with Mr. Kitagawa. He knows our focus is on making agriculture the No. 1 industry in our state, equal to tourism, perhaps. I think this could be accomplished with the right focus and with aggressive marketing. We should be helping our farmers not just regulating them. We also should be helping the aquaculture industry, especially after the last flood. We should help the aquaculture farm on the other side of the island get back on its feet. We should also be supporting our coffee industry and supporting our milk-processing plants, not just one. I am sure that with Mr. Kitagawa's leadership, many of these could be

accomplished and we look forward to working with Mr. Kitagawa.

"I urge your confirmation."

Senator Chang also supported the nomination and said:

"Mr. President, I rise to speak in favor of this appointment and confirmation.

"I have had the opportunity to travel throughout the state with Mr. Kitagawa and have watched him work with members of our agricultural community. I can say from personal observation that the farmers of our state know that Mr. Kitagawa has their best interest at heart. They feel that he's one of their own. He is, after all, from a rural community himself and I really believe that he has a feeling about him, a warmth that comforts the farmers and makes them comfortable that he will do his best for their interests. Thank you."

Senator Matsuura added his support and said:

"Mr. President, I would like to make a few comments about Yukio Kitagawa.

"If there is anything that he has failed, he has failed in helping us pass the 'unagi' bill, so that's one of the things that he didn't accomplish.

"I have known Mr. Kitagawa since the days I was an ag coordinator. I can say that very few people who occupy a professorship at the university or head a department of agriculture can go out and farm and be a success of it. I think that Yukio is one of them, the rare example.

"He has promised me that he's going to start the 'green revolution' in the next four years. Coffee is going to be one of the crops that we're going to start with for the 'green revolution.'

"He's made all kinds of promises so I'm going to hold him to it. With that, I want all of my colleagues to give him a chance and I'm hoping that he will give me a chance and testify in favor of the 'unagi' bill when Senator Yamasaki introduces it again next session. Thank you."

Senator Hagino added his support of the nominee and remarked:

"Mr. President, I rise to speak on behalf of our nominee Yukio Kitagawa whose confirmation as chairperson of the Department of Agriculture is before us today.

"Yuki received his education at Honokaa High School, the University of Hawaii, and Oregon State University where he received a Master of Science degree. He has in the past had experience as an instructor with the Department of Education, a generalist with the Cooperative Extension Service in the College of Tropical Agriculture and Human Resources at the University of Hawaii. He served as deputy chairman of the Oahu County Cooperative Extension Service, deputy to the chairman of the Board of Agriculture, assistant director of the Cooperative Extension Service, and most recently as chairperson of the Board of Agriculture.

"Yuki's academic and professional qualifications speak for themselves and are a matter of record. His nomination for the position of chair of the Department of Agriculture affirms the confidence placed in his demonstrated capabilities. I have known him for a number of years as a fellow resident of Wahiawa, as well as in his professional capability. I have always held him in highest esteem and continue to do so.

"Personally, Mr. President, I would like to thank Mr. Kitagawa for his efforts in getting the livestock agriculture park moving. It has been talked about for many years and, hopefully, it will be implemented in the coming years.

"At this time, I would like to take this opportunity to express my absolute support for the confirmation of Mr. Yukio Kitagawa and ask my colleagues to join me in supporting him. Thank you."

Senator Solomon added her support and said:

"Mr. Kitagawa is a 'keiki o ka aina.' His record of public service is outstanding and has continued to this day

"True, we have not always agreed with some of his positions as legislators, nevertheless, overall, we agree that it has been, for the most part, good for Hawaii. He, like all of us here today, in spite of and above all, is committed to what is best for Hawaii.

"In my judgment, his track record confirms that he is capable and qualified to serve as chairman of the Board of Agriculture. I am confident he will carry out the duties of that office, and we can expect positive results."

Senator A. Kobayashi rose to speak in favor of the confirmation of Mr. Towill and said:

"Mr. President, Murray Towill is the 'new kid on the block' but he has a lot of experience in that department. He also has a great deal of commitment to making that department the no. 1 department in the state. He wants to move it forward, I'm sure, and making sure our business development and tourism flourish. For those reasons, I urge you to confirm Murray Towill for Director of Business, Economic Development, and Tourism."

Senator Matsuura added his support as follows:

"Mr. President, I endorse the appointment of Murray Towill.

"Murray has been in office for a few months but I can assure you that this gentleman is going to start the 'blue revolution' for Hawaii. It's called the 'blue revolution 2,000.' Now, how are you going to get the 'blue revolution 2,000' started? This is his plan. He's going to get the closed cycle OTEC plant operational, provided that our Ways and Means chairman gives him enough money to start it. And he's going to get the 'mahimahi' growing rapidly so we can feed the world. You may think I'm joking but I can assure you the blueprint has been established, and Murray is part of that blueprint.

"Murray is also going to start the 'red revolution.' He doesn't know too much about this revolution but we're going to make sure that he supports the Senate position on the 'red revolution' and he has so far agreed to cooperate as much as possible and I can assure you this person is one person with vision. He is one of those doers and I think he's going to make a fantastic director, somebody that will be remembered.

"I urge all of you to please vote in favor of Murray Towill because we will never find another person like him. Thank you."

Senator McMurdo added her support of Mr. Towill and said:

"Mr. President, I rise in support of this nomination.

"In all the years that I've been on the Tourism Committee, and although Murray is new as director he's been with the Business and Economic Development Department for quite a while, I have always found him easy to talk to. He will listen and he is responsive. I will back him fully. Thank you."

Senator McCartney also supported the nominee and stated:

"Mr. President, I rise in favor of the nomination.

"I would like to say that Mr. Towill is cool, calm and collected. He has a lot of vision. He has a lot of foresight. I think he has a lot of credibility and integrity and he's going to do an excellent job as director of the department. I support his nomination. Thank you."

Senator Holt then rose to speak in support of the appointment and said:

"Mr. President, to explain why I asked for the deferral. It is because today is not Aloha Friday and Mr. Towill has an aloha shirt on. I asked him if he was going to wear a suit today and he said, 'My name is not Yuki Takemoto.' (Laughter.)

"More seriously, I've known Murray for just a short while. It's been since I chaired the Tourism Committee and had to deal with him in the planning area while he was working for Harold Masumoto. Incidentally, if we don't confirm him today, Harold has kept his position open so he can return. (Laughter.)

"Seriously, I've become very close to Murray. He's become a good friend; he's a hard worker; he's a strong leader. He's going to make a great contribution to the state and, despite my relationship with him, I urge you not to hold it against him. Thank you."

Senator Hagino also added his support of Mr. Towill and said:

"Mr. President, I rise to speak in favor of the nominee.

"Several years ago, while serving as chairman of the Planning and Environment Committee, the Office of State Planning was created, and during the process of drafting the bill I looked at the qualifications of the director of that office and I wanted to make sure that Murray qualified for that position. So I asked him and he said, 'Yes, I have the qualifications.' It was a great disappointment when his name was not submitted to us as director of the Office of State Planning.

"Fortunately, as it is said, good things do come to people who are patient and, hopefully, today we will show our confidence in Murray by voting positively for him. If not, he's going to have to wait a little longer. But Murray, good things do come. Thank you."

Senator George also supported the nominee and stated:

"I wonder, Mr. President, if I may collect all of the high flown adjectives from all of the previous speakers and incorporate them as my own. Thank you."

"We've heard about the 'green revolution,' the 'blue revolution,' and Mr. Towill, you will experience the 'black and blue revolution.'" (Laughter.)
