Friday, April 10, 1992

The Senate of the Sixteenth Legislature of the State of Hawaii, Regular Session of 1992, convened at 11:24 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by Sister Joan Chatfield, Chaminade University, Honolulu, after which the Roll was called showing all Senators present with the exception of Senator Ikeda who was excused.

The Chair announced that he had read and approved the Journal of the Forty-Ninth Day.
