At 9:13 o'clock a.m., on motion by Senator Chang, seconded by Senator Reed and carried, the Senate stood in recess subject to the call of the Chair to meet in Joint Session with the House of Representatives, in accordance with Senate Concurrent Resolution No. 11, to receive the Governor's state of the state address.

JOINT SESSION

The Joint Session of the Senate and the House of Representatives of the Seventeenth Legislature of the State of Hawaii, Regular Session of 1994, was called to order at 10:13 o'clock a.m., by the Honorable Joseph Souki, Speaker of the House of Representatives.

At this time, the Speaker welcomed and introduced the following distinguished guests to the members of the Seventeenth Legislature:

Mrs. Lynne Waihee, First Lady of the State of Hawaii. She was presented leis by Senator Matt Matsunaga and Representative Les Ihara;

The Honorable Benjamin J. Cayetano, Lieutenant Governor of Hawaii. He was presented leis by Senator Ann Kobayashi and Representative Paula Ishii-Morikami;

The Honorable Ronald T.Y. Moon, Chief Justice, Hawaii State Supreme Court;

The Honorable Frank F. Fasi, Mayor of the City and County of Honolulu;

The Honorable Stephen Yamashiro, Mayor of the County of Hawaii;

Major General Marvin Hopgood, representing Admiral Charles Larson, Commander in Chief, U.S. Pacific Command;

Admiral Robert Kelly, Commander in Chief, U.S. Pacific Fleet;

Rear Admiral Howard Gehring, District Commander, 14th Coast Guard District; and

The Honorable Daniel Kihano, former Speaker of the House of Representatives, and Mrs. Kihano.

The Speaker then appointed Senators Malama Solomon, Anthony Chang and Mary George, on behalf of the Senate, and Representatives Jackie Young, Tom Okamura and Gene Ward, on behalf of the House of Representatives, to escort the Honorable John Waihee, Governor of Hawaii, to the rostrum.

Senator Lehua Fernandes Salling and Representative Bertha Kawakami presented Governor Waihee with maile-iliima leis.

The Speaker then presented the Honorable John Waihee, Governor of Hawaii, to the members of the Seventeenth Legislature.

The Governor addressed the Joint Session, as follows:

"Thank you.

"Mr. President, Mr. Speaker, members of the Seventeenth Legislature, honored guests, ladies and gentlemen:

"Before I begin my formal remarks, I would like to take advantage of this time to do two things.

"First of all, to notice that even at my last state of the state, the Mayor of the City and County of Honolulu would attempt to mar my entrance ... welcome, Mr. Mayor.

"I would also like to express my deepest appreciation to all of you who have offered your prayers to my family upon the passing of my mother. Many of us, myself included, have a tendency to use words, too often lightly or casually, in our daily conversations so that when you really want to express something that you feel deeply about or passionately for you find yourself struggling in a sea of cliches. I find myself in that very position this morning as I try to express to you how much your warm support has meant. I only know that your thoughts of concern kept translating into one word -- Aloha. My family and I would like to extend to you that same Aloha. Thank you very much.

"It has been seven years since my first state of the state address -- seven years of dramatic changes for the world, for the nation, and for our state.

"We came in as an activist administration, and we have been innovative and non-traditional in our efforts to achieve results.

"Over the last seven years, I have used the state of the state to outline our hopes and our dreams.

"They have been bold forums upon which we have presented programs to address not only today's needs, but also our needs for the twenty-first century.

"You responded, and together, we have made significant accomplishments.

"But, my friends, we have unfinished business. It exists because you and I have always looked beyond the horizon of this administration's eight-year tenure.

"The challenge remaining before us is to position this state for that final leap that will take us into the next millennium.

"To reinvent government, to invest our resources wisely, and to commit ourselves to the goals and dreams of our citizens.

"Since coming to office, this administration has constantly looked for ways of making government more efficient, accountable, and responsive to the needs of our people. In short, we've sought to reinvent government.

"Last year, you asked us to intensify our reinvention efforts. Consequently, we formed a 'redesign team' chaired by my Administrative Director, Joshua Aagsalud, which responded to your request with a report on how we might be able to do even more.

"While the buzz word may be new, the concept is not. Reinvention centers around an essential willingness to change.

"With the impact of the recession, the after effects of Hurricane Iniki, and the restructuring of our sugar industry, that willingness to change is even more imperative.

"As Speaker Souki noted in his opening day remarks, 'The prognosis is better, but there are still plenty of symptoms of the economic flu.'

"And if there is anything that will immediately force someone to look at new ways of doing things, it is not having enough money to get things done the old way.

"That's one compelling reason to reinvent government. Making it more accountable and more responsive are two others.

"The first and most important area that requires a willingness to change relates to restoring the public's trust.

"I was reminded recently that the public's trust is not a given, it is earned, and that past accomplishments are a foundation, and not a shrine.

"In spite of our pride in public service, there is discontent, distrust and dismay over where we find ourselves today.

"I know it, and I am very troubled by it too.

"It seems to me that part of what we are going through as a state and as a government is akin to middle-age crisis. And yes, there are some worn out paths and tired feet.

"The question is whether our hearts are as tired as our feet. The answer is no.

"I stand here today to rededicate both myself and the people who work for me to the same activist spirit where I began in 1986.

"If together we can open up public records and tackle reforms in one of the most entrenched instruments of government -- our procurement system -- then we can tackle other areas as well.

"On a number of occasions, I have talked about leveling the playing field by restricting all political contributions and instituting public financing of state political campaigns.

"No one has taken me up on the challenge. I can understand why. This is a painful area where tinkering around the edges is a lot more comfortable than a major overhaul.

"I know this as much as anyone. When I began my career, I was an outsider. As Governor, I find myself the ultimate insider. Having come all this way, I believe now what I believed then, and that is the only way to fix the system is to turn it upside down.

"Until we remove the suspicion that campaign contributions and government actions are somehow linked, it will be very difficult to restore public trust.

"I believe we need two things:

"First, to sever both the real and perceived links between the candidate and the contributor, and

"Second, to rebuild broader based participation in the electoral process.

"To achieve these goals, I propose that we institute mandatory public financing of campaigns. I suggest we begin in the next electoral cycle, not the upcoming, the next electoral cycle, with the races for Governor, Lieutenant Governor, and Mayors of the four counties.

"To facilitate this, we recommend dropping the limit on individual contributions from two thousand dollars to two hundred, and establishing qualifying contribution thresholds.

"I know that one of the criticisms of public financing is the use of taxpayers' dollars. We can partially address that by allowing for private contributions into the public fund, in addition to the taxpayers' checkoff.

"Also, to address the growing concern of the influence of lobbyists, I propose tougher rules for lobbyist registration by the Ethics Commission.

"If we are truly interested in restoring public trust in government, then now is the time to move boldly.

"The second area for reinvention relates to how we educate our children, how we allocate and spend our resources, and how we measure the performance of our schools.

"As President Mizuguchi noted in his opening day remarks, the most striking example of the reinvention process in government in Hawaii is the reform going on within our schools.

"We've shifted responsibility and resources down to the schools, where it counts, through school/community-based management.

"Project Ke Au Hou will further collapse the education bureaucracy so that all levels of the system are oriented to the schools.

"We are reviewing new performance standards to make our goal of creating a 'results-driven' system meaningful. You cannot be results driven if you don't have standards to measure those results.

"These are revolutionary changes, but what is missing is accountability in governance.

"That responsibility is currently diluted among the Legislature, the Board of Education, the Superintendent, and the Governor. It is a situation that leaves the accountability picture muddled.

"We've talked about clearing up governance of our education system for seven years now. It's time to fish or cut bait.

"Personally, I have always preferred an appointed Board of Education because it clearly makes the Governor accountable.

"But, apparently, that opinion may be shared only by myself and a few newspaper editorial writers.

"Therefore, I propose that we go the other direction and have a truly independent Board of Education, with the ability to raise its own revenues for its own programs.

"In order to do this, we need to know how much we spend on education.

"Right now, the DOE's operating budget is about \$687-million. But when you include the capital improvement and maintenance costs, personnel, and some pretty significant employee benefits costs, the real price of education is about on billion dollars. That's 33 percent of our total general fund revenues.

"My friends, that's a level of funding that is almost twice as large as the City and County of Honolulu's budget. When you are that large, perhaps you ought to be independent -- subject, of course, to laws of general application.

"So, I am submitting a constitutional amendment to allow the voters to create an independent Board of

Education, and transfer the personal income tax -- which makes up about 33 percent of our general funds -- to the Board of Education.

"If passed by the voters, an education restructuring commission would have two years to flesh out the many details associated with such a significant change.

"In short, if public education is the responsibility of the Board of Education, let them be clearly responsible.

"The issue, after all, is accountability.

"A word about the role that technology plays in education and educational reform. Computer literacy is no longer a luxury. It's a requirement.

"High tech enhances teaching and learning, from electronic highways that bring together far-flung teachers and students to tracking students performance.

"Computers and information systems are so important that Superintendent Toguchi calls it one of the three pillars of education reform -- reform on a scale that would not have been possible without the tools that high technology has provided us.

"I call on the Board of Education and my colleagues here in the Legislature to strongly support technology in our schools.

"We all want the best school facilities possible for our children. That's why we created the 'Super Fund' for school facilities, providing our schools each year with \$90-million.

"So why do we still hear of students in makeshift classrooms? Obviously, because our educational needs are so large and we need more money. But there is another reason as well.

"We are not spending all the money we have.

"In fact the DOE spends less than \$55-million each year for facilities and currently has over \$200-million in authorized but unspent funds.

"There is no need, or should be no need, for any child in this state to make do in sub-standard or makeshift classrooms -- and certainly not while we are accumulating millions of dollars specifically for those needs.

"DAGS, Budget and Finance and the DOE are working right now, with a little encouragement, to reduce the bottlenecks and drastically cut that processing time for school facilities. By the next fiscal year, the DOE will be able to use all of its annual super fund allocation to build and upgrade school facilities.

"Back in 1986, we agreed the University of Hawaii should be more autonomous, and gave the Board of Regents flexibility to allocate funds among programs. I now propose we make that flexibility permanent.

"I also propose that we increase that flexibility by lump-sum budgeting and allow the University to carry over five percent of appropriations beyond the fiscal year.

"It is also time to allow the University to handle all of their own personnel matters.

"By the way, I was very pleased that the Board of Regents selected Kapolei as the site for the West Oahu campus. I think, like you, it's the appropriate choice and I ask for your support on that endeavor.

"Hawaii's health care system is the envy of the nation, and the credit should be rightly shared by Hawaii's leaders, past and present, in both the legislative and executive branches, as well as the private sector.

"It has been a partnership effort of the highest quality. Yet it is still not the seamless health care delivery system we all desire.

"Consequently, we have continued to put the way we deliver health care services under the microscope of reinvention.

"As a result, we created Project Quest, which will overhaul our medicaid system by consolidating three programs into one and privatizing it.

"Quest has already been approved by the Federal Government and is nearly ready for implementation. The last step is to transfer the state health insurance program from the Department of Health to the Department of Human Services. I ask for your support in implementing Project Quest.

"While we are working to contain costs in public health care programs, we also need to help the private sector do the same.

"The creation of a health alliance would do just that. A health alliance -- composed of government, businesses and individuals -- could:

- Form a pool for negotiating strength with insurance companies and help control costs;
- Ensure a broader range of health care choices;
- Provide consumer information on health care quality and costs; and, at some future date,
- Coordinate long-term care financing, and consolidate workers' compensation, no-fault auto, and health care coverage.

"The fourth area of reinvention relates to the stewardship of our resources. It includes reforming our land-use law, fundamentally changing how we perceive and support agriculture, and consolidating our environmental and conservation activities throughout the state.

"Session after session, you and I have had to deal with the 'tension' between the state and counties on who is responsible for land-use decisions. Under the current system, the task is duplicated.

"I believe the state should move away from parcel-by-parcel decision-making, leaving that to the counties. The more appropriate role for us is to refocus on the development of an overall land-use plan.

"The legislation we are submitting will eliminate that duplication.

"We need the same kind of shift in our approach to agriculture.

"Times are changing. The plantation lifestyle I grew up in is quickly disappearing, and it is a painful transition. Obviously, we need to help our affected communities in any way we can. But that transition also has the seeds of opportunity.

"Large tracts of prime ag lands -- with water, roads and other infrastructure -- are becoming available. New

farmers -- small agribusiness -- can and will want to use this land, but they need our support.

"And we can help in two ways:

- By strengthening the role of the Department of Agriculture and consolidating resources; and
- By creating an agribusiness development authority to assist and promote the development of new agricultural enterprises -- as we do for high technology ventures.

"Such an authority would bring together the elements of land, infrastructure and marketing -- in short, the same things we do to attract new business to Hawaii.

"Our farmers deserve the same break.

"In this light, the proposed land exchange between the Galbraith Trust and the state makes sense. The exchange gives us the opportunity to preserve ag land, protect historic sites, and facilitate housing where it ought to be -- in the city of Kapolei.

"In the past, when we sought to protect and conserve natural areas, we appropriated funds. How do we continue our efforts in tighter economic times?

"By shifting from traditional solutions to more creative methods.

"For example, I proposed, four years ago, the creation of a seven-mile shoreline park from Mahaiula to Kua Bay in North Kona.

"The last parcel we need to complete that park is Makalawena. We are now negotiating a lease, which will place the land immediately in the public domain, then, later when funds become available and if we choose, we can buy it.

"You decided last year that Olomana's pristine east face needs to be protected, and I propose that we accomplish that through a land exchange.

"On Maui at Makena Beach, we are forming a partnership with the Federal Government, Maui County, and a private landowner to acquire additional lands to expand the existing Makena Bay State Park at no cost to the state.

"Just as we change the way we manage our lands and agricultural resources, we also need to change the way in which we protect our environmental resources.

"Therefore, I am proposing that we establish a new Department of Environment.

"The increasing environmental emphasis and mandates at the federal level, as well as our efforts to make government more responsive, make it an ideal time to begin that process.

"By taking these actions to reinvent government, we put ourselves in a position to continue to invest wisely in our future.

"As we move to streamline government and re-identify priorities, we will find a much stronger justification for the areas where government can and should be the primary provider of services -- those areas where compassion, not profit, is the bottom line.

"In these tough economic times, we need to also avoid the temptation of being 'penny wise and pound foolish.'

Sound and timely investments in our people, housing, economy, and transportation system will more than pay for themselves.

"Our investments for the future should also include correcting past wrongs, such as making our trust with native Hawaiians whole again.

"Investment in housing has been one of our highest priorities. When I first took office, our goal was to provide 64,000 affordable homes by the year 2000.

"Between 1988 and 1992, the state, with your help and private developers, have built more than 21,000 affordable and market-priced homes, with the current supply of affordable housing at a thirty-year high.

"Kapolei, one of our three master-planned communities, is proving to be one of our best investments in the future. It was planned to provide us with five thousand homes by the year 2000. We all know that is not fast enough.

"That's why we are accelerating the bidding process and, by the end of next year, we will have about 4,500 homes built or under construction at Kapolei. (We don't have to wait till the year 2000.)

"We also need the assurance that our homes are secure. Last year, we create the Hawaii Hurricane Relief Fund to encourage new insurance companies to come to Hawaii.

"They told us that if we put a relief fund in place, they could sell in this market. Well, we've done it.

"We created the relief fund which caps their liability by providing an equitable cost sharing scheme. We repealed the take-all-comers provision in our auto insurance law, and we reduced red tape for doing business.

"Yet some mainland-based insurance companies are considering leaving the state and making decisions that impact Hawaii policy holders, without recognizing the existence of our reforms.

"It's time they do their part. In the long run, insurance will only be available and affordable again if we re-establish healthy competition. Let's work together on this task.

"One of the biggest challenges is our ability and determination to invest in the well-being of our children and families in Hawaii, especially those at-risk.

"Our focus is on preventive measures and early intervention to reduce future costs and, more importantly, help these individuals break out of the cycle of dependence.

"Consequently, I am requesting in our budget:

- Three million dollars for our nationally recognized Healthy Start Program to cover an additional 1,200 families;
- Three million dollars for adolescents in need of in-patient mental health care;
- Three million dollars for school-based, early-intervention mental health services to reach about 4,800 children and adolescents with severe emotional disturbances; and
- 4.8-million dollars to continue the family preservation program.

"We also want to expand Hawaii's jobs program -- now at capacity with about 3,000 welfare recipients -- to help another 1,500 return to the world of work.

"I have requested 900,000 dollars, to be matched with federal funds to get this 'investment' in our families up and running.

"Universal early childhood education by the year 2000 was one of our goals when we first entered office. Today, 40 percent of the 83,000 children under five in Hawaii now receive education and care outside the home. We know we need to reach more.

"How do we do it? We do it by combining resources, an effort started by the Hawaii Business Roundtable, private agencies, and the state.

"An interim committee, which I am establishing, will take us another step closer to our goal. With leadership from this committee, we hope to leverage private sector efforts in early education by providing standards and a more comprehensive support framework.

"Long-term care for Hawaii's elders becomes even more important as long-term care costs continue to rise. As I've noted in the past, these costs are often as hard on the families of the elderly, as on the elders themselves.

"If we don't take action now, our projected long-term care costs will grow by more than two billion dollars by the year 2020.

"I am proposing the adoption of our Family Hope Program which will establish a long-term care plan and long-term care trust fund.

"Our approach will tie it to elements of President Clinton's national health care reform, with our own health alliance providing a future home for this program.

"One of our success stories in assisting our families has been our partnership with private social service agencies.

"To strengthen these partnerships, I am proposing multi-year contracts in the purchase of health and human services. This simple change will result in more attention to services, and less to administrative paperwork. Our families will be the winners.

"We have also got to continue to strongly invest in our economy, especially in these tough economic times.

"The engine that drives our economy is tourism. We're taking aggressive steps to get tourism back on track.

"After years of debate, this past summer, we made the tough decision on selecting a convention center site to help us capture new market segments. Before this year is over, we will have selected a contractor and will be on our way in developing a world-class convention center. Thank you for your support on this issue.

"We also need to promote more aggressively.

"Over the past seven years, you and I have significantly increased the promotion dollars for tourism. In fact, last year, we increased funds for tourism promotion by 9.5 million dollars.

"We must continue to promote Hawaii. But, in these tough times, we need to do it more effectively.

"In the past year, we've joined forces with the private sector, pooling resources to get a bigger bang for our

buck. We did it with our 'Focus on Hawaii' and 'Aloha on Tour' campaigns.

"I believe that we need to build and can build on that private/public partnership.

"I ask you to support a new ten-million-dollar campaign, specifically for our key markets in North America, Asia and Europe to help kick start the industry.

"The state would provide five million dollars for tourism marketing, which the industry would match on a dollar-for-dollar basis.

"Investing in our future also means providing more opportunities for new industries.

"In the past, we've encouraged investments in high tech, alternative energy, film, sports, and other areas as a way of diversifying our economy.

"To capitalize on Hawaii's profile as a leader in health care, I am suggesting that we invest a modest amount to establish a temporary commission to create a strategic plan for development of a 'wellness industry.'

"And what better place for this industry than in Kakaako.

"There, our waterfront park, the redevelopment of Aloha Tower, and the creation of more than 800 rental housing units have brought families back to Kakaako -- making it a center for people once more.

"With your help, we can also make it a center for the wellness industry in Hawaii.

"For this to happen, we need the proper infrastructure to support such activity. That's why I am requesting 13 million dollars for infrastructure improvements.

"Reinvesting in our future also means making sure that the backbone of our economy, small business, is afforded the greatest opportunity to succeed. Small businesses are hurting in these tough times.

"One of the major costs of doing business is workers compensation. We need to deal with this issue.

"No one is arguing that a worker who is injured should be denied timely medical care and benefits. Yet, we have to look more closely at the system when it appears that costs are skyrocketing.

"Medical costs have risen from 46 million dollars in 1985 to 116 million dollars in 1992.

"In addition, the program has evolved from a simple administrative process to a cumbersome one. Today, workers' compensation is bogged down in mountains of paper. It is a process, by the way, made even more costly when lawyers get involved (in this complex mess ... with all due respect to my colleagues).

"We must bring 'prudent administration' back into the system, by simplifying the process, minimizing delays, and closely monitoring medical costs. The Department of Labor and Industrial Relations is developing administrative procedures and will be submitting legislation to you for your consideration.

"However, we cannot do it alone. We stand ready to work with you, business, labor and the insurance industry to resolve this very important issue. (It had to happen sooner or later.)

"Mass transit. When we first proposed some form of mass transit four years ago, our streets on Oahu were already in gridlock. Today, it is worse and we still have not come to grips with the problem.

"I know it is a tough issue, but sooner or later, we have got to face up to the reality that we need a mass transit system on Oahu -- one that eventually connects the University's Manoa campus with the proposed West Oahu campus at Kapolei, with feeder routes to Waikiki and Mililani.

"We have the ability to plan for this system by using existing federal funds. And it would be very easy for me to propose just that and stop right here.

"But I would be remiss if I didn't bring to your attention that our 600 million dollar federal authorization hangs in the balance. This Spring, Congress will decide on whether to keep the authorization for Hawaii or re-program the money for other cities.

"With due deference to the Speaker, whose opinion I highly respect. Unfortunately, this is a touchy issue where the discussion of taxes cannot be avoided.

"If we don't make a decision on mass transit this year, we will not only lose the authorization, but we will have to go to the end of the line.

"As you know, we tried this before as a partnership between the state, the city, and the Federal Government. It didn't work. Therefore, I am proposing that the partnership be redefined between the state and the Federal Government.

"This time, it will take more than a promise (it will take much more than a promise) to secure federal dollars and a favorable matching formula. Dedicated local financing is an absolute requirement. Therefore, we are asking for authorization for a half percent excise tax -- a tax that won't kick in unless we receive fifty percent federal funding.

"I believe that it is an idea whose time has still not passed.

"Investing in our future also means passing laws that ensure our sense of community and individual safety.

"As a community, we need to feel secure and safe on our streets and in our homes. Because we are an island state, we have a golden opportunity to control the spread of handguns in Hawaii. The law enforcement coalition and Senator Grauly have advocated it, and I believe that we should support such a move.

"Honolulu is not yet in a situation that many cities on the mainland find themselves. Let's not allow it to happen here. We owe it to ourselves and to our children to have the courage to keep Hawaii a safe place in which to grow up and live.

"It would be impossible for me to conclude a state of the state without addressing Hawaiian issues. This imperative has much less to do with who I am, than who we -- Hawaiians and non-Hawaiians alike -- who we are.

"We are an island community who count Hawaiians one in five among us. More than numbers, it is clear that the future of all our peoples are intertwined.

"Our collective future depends on the justice, persistence, and creativity which we apply to long-standing and difficult issues.

"In 1993, sovereignty was front and center in a year of recognition and reflection.

"1994 brings the necessity of action. Clearly, there are few today (in my mind) who truly doubt that sovereignty will happen. It is a matter of how, when, and in what form.

"The Hawaiian Sovereignty Advisory Commission has been working on a process for Hawaiians to make those determinations, and they deserve our continued support.

"As you know, the state cannot confer sovereignty. That is the kuleana of the Federal Government, with many steps yet to be taken.

"However, there is progress to report. In particular, thanks are due to our congressional delegation for the long overdue formal apology of the United States to native Hawaiians. And yes, Auntie Frenchy, Kaho'olawe will be returned this year.

"Now is the time to press even harder on the federal front. At long last, talks have begun with the Department of Interior on land claims, political status, and trust responsibility.

"Meanwhile, back at home, we must continue to clean up and uphold our own trust responsibilities.

"Nowhere is that need more evident than with Hawaiian Home Lands.

"The 1921 Act of Congress created a Hawaiian Home Lands trust of 203,500 acres. It also created a deceptively simple term -- 'more or less.'

"The impact of those three words was best described by a young Hawaiian on the waiting list, Randall Lindsey, testifying before Senator Inouye's committee.

"He told the Senator how the 1921 Act said four thousand acres, more or less, were set aside as available lands in Waimanalo.

"Yet, less than 2,000 acres can be accounted for. The same discrepancies were to be found throughout the act, wherever the words 'more or less' were used. Mr. Lindsey asked the panel, 'What happened to these lands?'

"Yes, Mr. Lindsey, what happened to those lands, to over 16,000 acres of these lands?

"The task force I established in 1991 to resolve the hundreds of Hawaiian Home Lands claims has made tremendous progress.

"But remaining issues will not be as easily resolved as the 9.7 million dollars in past due rent paid last year with your support.

"Now is the time to move boldly and restore the trust while we still have the will and the means.

"I have asked the Board of Land and Natural Resources to turn over this year 16,518 acres of state lands to Hawaiian Home Lands.

"We will continue our obligation to resolve specific claims. And as they are resolved, credits will be made against the lands that we have already transferred. But we will not wait on the attorneys (to keep discussing and discussing and discussing and discussing the issues).

"By the way, my instructions are to turn over good lands for homes, farm lots, and income generation.

"If the land is there, then people must be put on the land. We have been playing catch-up with over 115 million dollars of roads, sewers and other infrastructure needs in the last six years alone.

"We will continue this commitment, but it is clearly not enough.

"It is time to 'shift' from the mindset of dependency and involve the beneficiaries to a greater extent in control over the pace and settlement of the land. That is the powerful message behind three new programs launched by the Hawaiian Homes Commission.

"This shift begins with sharing development responsibilities with the beneficiaries in a program that gleans the best of the acceleration program while learning from its shortcomings.

- Kuleana Hou, starts with three projects at Kawaihae, Lalamilo, and Kahikinui for a total of 1,162 undeveloped homesteading lots;
- Laulima, a twenty-three lot beneficiary developed residential project at Papakolea; and
- Kupuna elderly rentals.

"I urge you to support the 3.5 million dollars to begin these projects, not only for the homesteading opportunities they will provide, but as another important step in the process of self-determination as well.

"Finally, if you will allow me a few moments on a more personal note.

"All of our plans are of no value unless they are anchored with a commitment to fulfilling the hopes and dreams of our people.

"As I mentioned at the start of this address, this will be the last time I stand before a joint session of this Legislature as your Governor.

"Together, we have moved aggressively on a number of fronts.

"It is a fact, however, that our greatest achievements have happened when we have all been able to work together -- when we have placed all of our energies in the same direction.

"If we continue to work together as we have in the past, by the year 2000, I believe:

- We will have built an economy which withstood hard times and grew evenly and diversely to meet the needs of working people.
- We will have revitalized our schools, empowered our communities, and readied our children for the challenge of any day.
- We will have opened lands statewide for housing and provided more than 64,000 affordable homes.
- We will have created a support system for our families who need a helping hand that moves them toward financial independence rather than trapping them in programs of social dependence.
- We will have provided a seamless system of health care for all of our citizens under a strong

supportive alliance involving both the private and public sectors.

- We will have respected and supported the rights of native Hawaiians and all of our people, always striving for tolerance -- unique, special and ours. The best way to correct yesterday's wrongs is to make tomorrow right.

- And, we will have saved forever priceless lands, an inheritance for all generations.

"The last seven years, to say the least, have been a journey of exhilarating highs as well as lows. If you are driven to doing the best job possible, if you feel as strongly about our islands and our people as I do, you cannot help but respond to this job intensely.

"I regret neither highs nor lows. They have given me the opportunity to learn and grow and contribute something to the home that nurtures and sustains me.

"In addition, you cannot become Governor of Hawaii and represent our people without having the experience intimately change who you are.

"My affection and appreciation for the richness of our history, our cultures and our people have increased many fold. And I wish I could thank individually all who have been responsible for that gift.

"I would like to thank all of you for your counsel and your insights. If, at times, we have differed on the means, we have always shared a common purpose and goals.

"I always knew, down deep, what was in your hearts. And you always knew what was in mine -- Hawaii -- Hawaii -- Hawaii.

"And while my administration will end this year, the business of government is never finished. As indicated by our ambitious list of legislative proposals, we have no intention of turning off the lights any sooner than twelve noon on December 5, 1994 (unless, of course, you want to amend the State Constitution and extend my stay. Don't worry, that reform is not on the agenda).

"I pledge, as resolutely as day one, to work with you for the benefit of this extraordinary place and all who call it home.

"For that is what is in our hearts.

"Thank you and Aloha!"

Senate President Mizuguchi then rose to state:

"Thank you, Governor, for a sterling review of the state of the state.

"The agenda you propose is ambitious and thought provoking. We, the Legislature, will give it our serious consideration. Many issues will come before this session requiring the full resolve of your administration and the Legislature. I am confident that we will emerge from this session with a legislative product we can be proud of.

"There being no further business, I declare this Joint Session of the Hawaii State Legislature adjourned."

At 11:11 o'clock a.m., the President declared the Joint Session adjourned.
