# THIRD READING

The Senate reconvened at 11:47 o'clock a.m.

Senator Tungpalan, on behalf of the Senators, extended Happy Birthday wishes to Senator Malama Solomon.

Senator Koki then rose on a point of personal privilege, as follows:

"Mr. President I stand on a point of personal privilege.

"For six years I have had the honor of serving in this body and representing the interests and concerns of Oahu's Windward residents.

"During that time, I have witnessed debate on a wide variety of issues. And I have come to appreciate how decisions made on this floor will affect not only those who voted for us, but also the destiny of generations yet unborn.

"That is why I want to take just a moment to discuss two issues that will soon be debated and decided in this room ... issues that will have an irreversible impact on our culture and on our future.

"The first is the legalization of gambling. At first glance, offshore gambling seems harmless enough ... a way to perhaps attract more tourists ... a way of keeping money spent in Las Vegas here in Hawaii ... a way of raising money for education or some other good cause.

"I wish it were all that simple. Unfortunately, it is not.

"First of all, no one is sure how much money will actually go into state coffers. When gambling was introduced into Atlantic City, other retail and service sector businesses saw a reduction in revenue. I don't want to be the one to tell the tour operator or Waitkis shop owner that gambling will siphon away business they now have. But that is exactly what will happen. And the result will be more tax dollars from gambling but fewer tax dollars from other businesses.

"Furthermore, unless we require all gambling enterprises be owned by local residents, most of the profits will go out of state to those who run the gambling operations.

"Shipboard gambling will not stop Hawaii's people from going to the Mainland to gamble. Only full-fledged 24-hour gambling casinos on-shore can do that. Is that what we really want?

"There are those who say that we are already gambling ... illegal gambling. So why not accept it, legalize it and tax it? Or two reasons: first of all, HPD predicts that with the introduction of legal gambling, the amount of illegal gambling also increases because gambling is considered acceptable behavior. So we're not solving the problem. We're only making it bigger.

"But second and more importantly, what are we telling our children and grandchildren? Vice is okay as long as you make money? Is that the principle we want to build our society on?

"Once gambling becomes a part of our culture, it will be hard if not impossible to eradicate.

"The same is true of another important issue ... samesex marriage. If we allow the State Supreme Court to sanction same-sex marriage, we will abdicate our role as legislators and set in motion a cultural change that may very likely produce unforeseen and unfavorable consequences. "We need to affirm traditional marriage in the Legislature and protect the family structure. Let's send a message to the Supreme Court to leave legislating to us.

"We are deciding a future that we will not live to see. Let's not make that decision lightly or give our responsibility over to a co-equal branch. Thank you."

Senator Solomon rose on a point of personal privilege, as follows:

"Mr. President, I also rise on a point of personal privilege.

"As you know, we've had numerous articles in the newspapers in regard to our tourism industry in Hawaii. There have been pros and cons of HVB as far as promoting tourism is concerned. Mr. President, your Committee on Tourism, as well as your Committee on Transportation, have been working very conscientiously in trying to make sense of what is happening to our tourism promotion.

"We have come to the conclusion that there is, Mr. President, ineffective tourism promotion -- spending \$20 million and not getting our money's worth. DBEDT does not exercise its responsibility of supervising the promotion activities of the Hawaii Visitors Bureau, but at the same time it's promoting its own projects, like Hawaii on Tour, etc. The contract between the Hawaii Visitors Bureau and DBEDT provides that HVB may not assign its duties under the contract without written authorization from DBEDT. In other words, Mr. President, the buck stops with the Office of Tourism, which is under the jurisdiction of DBEDT.

"Now, we find that the Hawaii Visitors Bureau has, in fact, contracted with companies owned or controlled by Mr. Tom Kieley, providing for those companies to perform Hawaii Visitors Bureau responsibilities. Kieley's companies are to receive an excess of \$300,000 of tourism promotion funds. We have not been able to find out whether DBEDT has authorized these contracts, and if so, why? If not, why not? We have evidence of financial indulgence, waste, and the worst kinds of conflicts of interest on the part of the Hawaii Visitors Bureau. Where is DBEDT in monitoring all this?

"We must deal with the problem of increasing tourist arrivals by increasing the number of seats bound for Hawaii. Your Transportation Committee is working very conscientiously on this and we're trying to work with the airlines and air charter companies to create an aerial highway to Hawaii. This means the level of landing fees has to be related to maximizing tourist arrivals, not to supporting the Airports Division of the Department of Transportation. We must work to encourage and assist tour companies (such as Ed Hogan's Pleasant Hawaiian Holidays) in their efforts to bring visitors by air tour operations. Mr. President, where was DBEDT on these negotiations? Nowhere!

"Third, we must rationalize the ground transportation system to free it of monopoly pricing and related practices. As you know, Mr. President, early in this session we did have a hearing on that very issue.

"The bottom line is that our Airports Division is 100% larger than Los Angeles and San Francisco. Many attractions in Hawaii are at the mercy of Roberts Tours and they must pay whatever the company demands for each visitor delivered, and that's just the start.

"Mr. President, with the demise of sugar and pineapple and the fact that our diversified agriculture industries

have remained almost flat for the past two years or so and with marginal prospects for growth, there's no doubt in my mind, as your Majority Leader, that we in this Legislature, for the remainder of this session, must concentrate our efforts on trying to bring in more competition to level the playing field, so that our tourism industry can, in fact, blossom and grow. Thank you."

Senator Chang also rose and said:

"Mr. President, in brief response to the Senator from Kaneohe, I believe that we all share his concerns and I believe that the Majority, the leadership, and the committee chairmen are diligently pursuing the different issues and questions that arise for each of these proposals.

"I would take small difference with one item in his point of personal privilege. The element of gambling has been a persistent and somewhat substantial part of the many different cultures that exist in Hawaii. The proposal for shipboard gambling represents an entry of the state into what has heretofore been a private matter, and as we all can imagine, there are complexities and delicacies that arise by this precedent setting proposal.

"Similarly, with respect to the issues of same gender marriage, there are many different kinds of questions that have arisen as a result of a changing society, one in which we have both traditional populations and new populations all clamoring for recognition of their rights and privileges.

"I believe that the Judiciary chairman has embarked in the right direction by promoting full dialogue, not only with the different communities represented by these issues, but also with the members of the judiciary branch in ensuring we have a full discussion with the branch that has thrust this issue upon us.

"I'd like to assure the Senator from Kaneohe that the leadership and the committee chairmen are working diligently to address his concerns. Thank you."

Senator Reed, rising in response to the previous speaker, then said:

"Mr. President, just a brief follow-up to the previous speaker. I find the debate on these controversial issues refreshing and would like to underscore the importance of this and hope again that the Majority will debate these issues openly on the floor, rather than in caucus. Thank you."

The Chair responded:

"I'm quite sure we will. Thank you, Senator."

At this time, Senator Kanno, for the Committee on Labor and Employment, in accordance with Rule 21 of the Rules of the Senate, requested a waiver of the 72-hour notice of a public hearing on S.B. No. 3171, relating to worker's compensation.

The Chair then granted the waiver.

Senator Holt, for the Committee on Consumer Protection and the Committee on Ways and Means, also requested a waiver of the 72-hour notice of a public hearing on S.B. No. 1122, relating to taxation, and S.B. No. 3193, relating to newspapers, and the Chair granted the waiver.

Senator Tungpalan rose on a point of personal privilege and said:

"Mr. President, I rise to support all efforts that are being made to secure the return of the two sacred ka'ai that were taken from the Bishop Museum.

"Our Legislature has been very closely tied to these sacred ka'ais. In 1991, we passed legislation which allowed for the repatriation of these two ka'ai to the Royal Mausoleum. The monies were transferred to the Office of Hawaiian Affairs and it was matched, in fact, by this organization, so we have great interest in securing these ka'ais, which unfortunately were taken. We still continue our support of the return of the ka'ais, and your committee, Mr. President, will be looking into the matter of the disappearance and personally talking to people who may have knowledge of their being taken.

"I would like to encourage those who know about this to call my office with any information. We would like to be able to see that these two ka'ai remain safe in the museum until they are repatriated. Thank you."

#### **ADJOURNMENT**
