#### Thursday, April 13, 1995

# APPOINTMENT OF CONFEREES

# S.B. No. 1868, S.D. 1 (H.D. 1):

In accordance with the disagreement of the Senate to the amendments proposed by the House to S.B. No. 1868, S.D. 1, and the request for a conference on the subject matter thereof, the President appointed Senators

Chumbley, chairman, Kawamoto, Matsunaga as managers on the part of the Senate at such conference.

Senator Matsuura rose on a point of personal privilege as follows:

"Mr. President, I rise on a point of personal privilege.

"Mr. President, I introduced S.C.R. No. 120, and as all of you know, I hate to be the person who is always trying to call attention to GTE Hawaiian Tel. The reason I do this is primarily because as a Senator, I have to make sure that the ratepayers, which are the citizens of Hawaii, are treated fairly. GTE Hawaiian Tel has not come in for a rate increase for many, many years. They came in finally, and what that did was to trigger an automatic audit. Now they have come in with a second rate increase.

"One of the things that I have always wanted to do (and I have the support of the PUC and the Consumer Advocate) was to take a look at the so-called nonregulated side of GTE Hawaiian Tel businesses. As all of you know, Hawaiian Tel is the only local exchange company in the United States that is allowed to do interstate services as well as international services. These nonregulated services are monitored and audited by the Unfortunately, the FCC has never audited those nonregulated businesses that include the selling of the telephone instruments, the yellow pages and the interstate and international services. The problem that I have is when GTE Hawaiian Tel comes in for its rate increase and when the PUC audits the company, the PUC should examine their nonregulated activity because the ratepayers may be paying for some of the costs of the nonregulated activities. The profit may be going to the so-called nonregulated businesses of GTE Hawaiian Tel. ratepayers may be subsidizing the cost of the nonregulated businesses of GTE Hawaiian Tel. That's one of the reasons why the PUC and the Consumer Advocate have supported S.C.R. No. 120 and the Chair knows how much I begged to have a hearing on S.C.R. No. 120.

"The reason why I am standing on a point of personal privilege and I don't care if S.C.R. No. 120 gets heard or not is because the deadline has passed. But the real problem that I have now is that I just learned today that GTE Hawaiian Tel has filed with the U.S. Justice Department to set aside their consent decree. This consent decree was entered to ensure that General Telephone would not be able to use its monopoly local exchange services to impair competition in the competitive market. The decree required GTE to form a fully separate subsidiary if it wanted to enter into the competitive long-distance interstate market. It also provided protection to the information market.

"This is a significant move on GTE's part and it will have a lasting impact on the future of telecommunication competition in Hawaii. If GTE Hawaiian Tel is permitted to enter the competitive market with its monopoly power in tact, the monopoly ratepayers (that's you and I) will pay. And we will pay dearly. You have to understand that GTE Hawaiian Tel gross revenues exceed \$600 million a year.

"S.C.R. No. 120 would have required, had it passed, that the PUC protect the ratepayers from supporting GTE's competitive ventures. If the Justice Department allows this consent decree to be set aside, we will have no protection against the profit subsidy of GTE Hawaiian Tel's competitive services.

"I also stood up just a few days ago when this body passed H.B. No. 471, H.D. 2, S.D. 1, that would have required the PUC to allow GTE Hawaiian Tel to be

flexibly regulated. They would no longer be rate of return regulated. This rate of return regulation is the only protection the ratepayers would have against paying for Hawaiian Telephone's entry into competitive markets.

"Well, to make the story short, Mr. President, the thing that really upsets me is that the deadline for passage of S.C.R. No. 120 was yesterday. GTE Hawaiian Tel filed today. Had we passed S.C.R. No. 120, at least the ratepayers would have had a big impact from its findings when it comes before the Justice Department. Now it appears that it is too late. If the Justice Department sets aside this consent decree, it will be very difficult, and some of you lawyers can verify that, to get information regarding cross-subsidy, etc. They tell me it will be very difficult, if not impossible. S.C.R. No. 120 was a reasonable request to the PUC to protect the basic telephone ratepayer. This was the only measure standing between the Justice Department and H.B. No. 471 and the consumers.

"Unfortunately it's kind of too late already. The Senate deadline for resolutions was yesterday and GTE Hawaiian Tel filed in Washington today. I can't do anything more, but in the future some of these things in which the PUC and the Consumer Advocate were all in favor of, we should have had at least a hearing so we could have heard the testimonies from everyone. Because S.C.R. No. 120 had no hearing, we have no record. All that I can do is to put my comments into the Journal and let future historians evaluate our actions.

"Thank you very much."

Senator Fukunaga responded as follows:

"Mr. President, I do have a couple of remarks in response to the prior speaker.

"I would just like to note for the journal that the topic of S.C.R. No. 120 was discussed in a CPU hearing that we held last week. According to the PUC staff, the impact of GTE's reorganization on its regulated as well as unregulated subsidiaries is currently the subject of a pending PUC docket. The PUC staff that my colleague referred to has also confirmed that the PUC does have the jurisdiction and authority to order the kind of audits that are being requested during the course of that docket. They fully intend to exercise their jurisdiction. Thank you."

Senator Matsuura rose again and responded:

"Mr. President, just as a rebuttal, those are the same questions that I asked these people and they told me it is going to be difficult. Maybe some of you lawyers can explain some of these things -- I don't know -- but they tell me it is going to be very difficult."

At this time, Senator Baker, on behalf of the Senate, extended Happy Birthday wishes to Senator Kawamoto.

At 12:38 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

# RECONSIDERATION OF ACTIONS TAKEN

#### Senator Ikeda explained:

"Mr. President, the House just made what really amounts to technical amendments in a way. They spelled out Chapter 305, which is community colleges; Chapter 306, which is U.H. projects; and Chapter 308, which is U.H. parking, as agencies allowed to increase or decrease fees for non-tax revenues."

The motion was put by the Chair and carried, the Senate agreed to the amendments proposed by the House to S.B. No. 893, S.D. 1 and S.B. No. 893, S.D. 1, H.D. 1, entitled: "A BILL FOR AN ACT RELATING TO STATE SERVICE FEES," was placed on the calendar for Final Reading on Monday, April 17, 1995.
