"Just out of curiosity, Mr. Chairman, (I apologize because I did miss the caucus) can we do this if these people are elected to office; i.e., can we kind of control and tell them what they can or cannot include in their agenda?"

Senator Aki responded:

"Mr. President, I'll be glad to answer that question.

"This body enacted legislation to create OHA and therefore we do have that authority. But more than that, I just wanted to explain what this bill does. Basically, this bill allows greater access to members on the board to bring matters that are important in their view for resolvement on the board level. Presently there is a lot of rancor on the part of the members of the board, and this bill addresses that problem. It does not take away the responsibility or the prerogative of the chairman of the board.

"What this bill does, specifically, is it allows the trustee to first go before the committee to address their problems and if that trustee cannot resolve the problems at that level, then that person has the ability to bring that matter to the attention of the entire board. The committee felt that this was a reasonable solution to the problems that are internal in nature, at the present time.

"And with that, I hope I have answered the concern raised by the Senator from the Big Island."

Senator Solomon then stated:

"Thank you, Mr. President. I'd like to thank the chairman of Hawaiian Affairs.

"Mr. President, just for the record, I will be supporting the chairman because of his explanation, but I just don't want to be setting a precedent here where the Legislature is asked to interfere whenever there is controversy among members, especially in cases where members are elected such as the Board of Education. I don't want to see a bill in front of us next session which states what the board can or cannot put on their agenda. And I'm hoping that this doesn't have a spill-over effect where community groups tell the Legislature what it can discuss or cannot discuss.

"I guess the bottom line is I just don't appreciate disgruntled persons, who are part of the organizations, coming to the Legislature and asking us to interfere with their business simply because they cannot get their agendas aired. These are just some of my personal concerns.

"Thank you, Mr. President."

Senator Iwase added his comments as follows:

"Mr. President, I'd like to echo the comments of the Senator from the Big Island.

"I'm going to support the bill with the greatest reluctance in order to move the bill along for the purpose of discussion, but I am, like the Senator from the Big Island, deeply concerned about us intruding ourselves into the operations of independently elected administrative agencies. If they have difficulty dealing with the issues, one would hope that they would learn as the fights go along, or as peace comes, how to solve problems without rancor. And I don't think us getting involved with this agency or any other agency is going to be fruitful to the process of an agency developing some maturity as it deals with issues.

"I'm going to support it with the greatest reluctance. Thank you." $\,$
