Senator Anderson rose on a point of personal privilege as follows:

"Mr. President, I stand on a point of personal privilege.

"Mr. President, yesterday we had a symposium that was attended by about 50 people throughout the community. They were retail merchants; they were cattlemen; they were a diverse group, and we had a lot of publicity as far as the television media went. What bothered me, Mr. President, was that we spent a lot of time the other day on things such as same-sex marriages and things that are happening in this state, but the economy is not one of them. And that meeting yesterday was because we had asked for a study of the Federal Maritime Regulatory Scheme because it cost each household approximately \$2,000 per annum and neither press picked it up. About two-thirds of your household cost on food is taken up because of the cost of goods that come into this state are regulated by federal shipping laws. If you are a renter and you are paying roughly \$600 a month, that's three month's rent that's being considered. I thought it was an important part because 97 percent of all goods that come into Hawaii come in through our harbors. We are an island state. We should be doing a study and looking at what the federal shipping laws are costing us and why it's costing us that. And that didn't happen.

"Now the Star-Bulletin did print something that came from the Associated Press, but there was nothing in the Advertiser and nothing written by the Star-Bulletin. And it's important because it's the economy that we're looking at. That's what we're here for -- to help our constituents. So I would wish that we would all look at what's beneficial for all of us -- each and every one of us -- and how we are going to work for the constituency of this state.

"Thank you very much for your time and I wish my colleagues a very good day. Mahalo, Mr. President."

Senator Solomon also rose on a point of personal privilege and stated:

"Mr. President, I also rise on a point of personal privilege.

"First, Mr. President, I would like to thank my colleague who just gave his remarks for his support of the letter to the editor in the paper regarding our parimutuel bill. Thank you very much for supporting the neighbor islands for parimutuel activities.

"Mr. President, there's an editorial that appeared in today's Honolulu Advertiser which says 'Hostage cases; Sign of social disintegration?' Although, Mr. President, I think that the editorial is appropriate, I would like to add that while the editorial ends as: 'Clearly we are not doing enough. What will curtailing public assistance programs for families that are unraveling? What will our "revolving door" penal system be for repeat offenders? What will failure to fund drug treatment programs do for career criminals from dysfunctional families who regularly fry their brains with "ice"? A Hawaii that gets a handle on these problems is a Hawaii that won't have to worry about social disintegration.'



"I just would like to add for the record, Mr. President, that these hostage cases are not only a sign of social disintegration, but also a sign of economic disintegration. We have an obligation to look at: What are we doing about job creation? What are we doing about the growing gap between the very rich and the very poor in our state? What are we doing to insure corporations' responsibilities to their employees, the state and the environment?"

"Mr. President, we spent the first part of this Legislature dealing with the many, many issues that confront our economy and the social impacts, but I feel now we have to shift gears and start to focus for the last part of our session on economic development, job creation, deal with the problems of the budget and come up with programs that touch people's lives that we are able to provide those kinds of services so that we no longer have to have these kinds of editorials in our newspapers.

"With this, Mr. President, I'm hoping that your committees will start to work in unity to come up with a package that makes sense for our Hawaii. Thank you."

The Chair commented:

"Thank you, Senator. Your point is well taken."

Senator Matsuura, rising on a point of personal privilege, then said:

"Mr. President, I also would like to rise on a point of personal privilege.

"Since we're talking about doom and gloom this morning, I might as well add to it. I don't think that many of us realize the cost implication of taking care of our senior citizens. The elderly care is going to become such a financial burden for all of us that unless we prepare now, those costs are going to start hitting us from next year. We need these facilities to be built now. Believe me, I know. I chair the Human Services Committee. This is not a warning. This is a promise. It's going to happen. Unless we build these facilities and get those long-term care people out of the hospitals and nursing care homes, we're going to be in financial problems. All of us who have grandparents that need this kind of help, we're going to bankrupt them.

"We need economic development. We had this kind of opportunity and we still do. Telecommunications has always been the focal point of the Economic Development Committee. We could have opened up the telecommunication industry long ago. We missed the window of opportunity, but the window is still open. Telecommunications is one area in which the State of Hawaii has a great advantage. We terminated the telecommunications satellite launching project -- that's understandable. Geothermal has always been a big factor in alternative energy self sufficiency. There was a lot of opposition, but we still survived and we are still pushing to generate more electricity by geothermal energy.

"I have pushed for a large water line from Hilo to Waimea, Kona, etc. We sit on an ocean of fresh water in Hilo. If we can move that water over the Saddle and ring the water lines around Mauna Kea and Mauna Loa, you will see economic development that would be mind-boggling. Once you provide water to all of these arid lands, the future of Hawaii is secured. Water is the future for Hawaii. Thank God we have the water resource.

"We have missed a lot of opportunities, but the worst is yet to come. My program area takes care of people on drugs. Ice is totally out of control in Hawaii. I know it and the police confirm it. We have to move on this problem come hell or high water.

"You are going to be seeing a resolution to get Midway Island to become a drug treatment island. I don't care what it's going to take, but I'm going to try to make it happen. They already have the facilities built there. I'm going to introduce another resolution to take one of those mothballed ships or a ship that's going to be mothballed and take it to Midway to provide staff quarters. We have to take some radical steps and believe me what you have heard today is true. We're in trouble and we have to take some calculated chances now. We have to go for broke. Thank you."

#### ADJOURNMENT
