The Senate of the Eighteenth Legislature of the State of Hawaii, Regular Session of 1996, convened at 11:36 o'clock a.m. with the President in the Chair.

Senator Kanno, chairman of the Committee on Agriculture, Labor, and Employment, requested a waiver of the 72-hour Notice of a Public Hearing on H.B. No. 3498, and the Chair granted the waiver.

Senator Baker rose on a point of personal privilege and stated:

"Mr. President, I'd like to rise on a point of personal privilege.

"Mr. President, after seeing this morning's Advertiser editorial entitled, "High-three," I feel compelled to rise to set the record straight. The Senate has been unfairly and unjustly maligned. The editorial writer criticizes legislators, in general, for their so-called arrogance at continuing the pension-padding, and then criticizes the Senate, in particular, for the so-called 'feeble "high-five" entry.'

"Mr. President, I'm not thin-skinned, nor are any of my colleagues, and we certainly don't mind being criticized if it's deserved. However, I must admonish the Advertiser editorial writer to get the facts straight! The Senate took the initiative this session to eliminate the legislative 'high-three' retirement benefit early in the session, Mr. President. On February 1st, the tenth legislative day of our session, to be exact, the Senate passed on third reading a bill to eliminate such a benefit. It was then transmitted to the House for their consideration, and it was the House that amended it to become a 'high-five' idea. It was not the Senate that attempted to monkey-around with it. The Senate did, in fact, pass a measure to eliminate the 'high three.'

"Once again, Mr. President, I think it's important that when reporting items, coming from this body or elsewhere, that our papers manage to get the facts straight.

"Thank you, Mr. President."
