# RE-REFERRAL OF HOUSE CONCURRENT RESOLUTIONS

Senator Anderson rose on a point of personal privilege as follows:

"Mr. President, I rise on a point of personal privilege.

"Mr. President, I have an article from this morning's paper that states from the Majority Leader and I take exception to a couple of statements. One of them was, it says that 'Baker said the Democratic leadership decided to send the bill back to its original committee to remove any cloud over the process.' We fought a process because we believe that Article 51 in the Constitution was wrong ... not wrong, but that we were looking at it wrong, and the process was being circumvented. So that was the reason that we fought. It wasn't for anything else other than the process and there was a cloud because the Constitution was not being adhered to.

"Also it says, 'Senate Majority Leader Roz Baker said she doesn't think so. "Quite frankly, those guys don't have the votes."' Now we didn't do anything for votes. There's only two of us, the Minority Leader and myself. I don't think that we are naive enough to think that we have the votes, but 'those guys' ... now, those guys, I don't know which Senators they're talking about. That's kind of unclear. (Laughter.) So that's where I take exception to something like that.

"But while I'm up, Mr. President, and it's very seldom that I stand on this floor, as you well know. (Laughter.) I think that we have a Senator that's rather innovative and creative and I normally don't stick up for the Democratic Party Senators and say how great they are, but I think Senator Holt, if anybody here, should have objections to the way the news media has treated him. I think Senator Holt should object to cartoons and articles that he is more or less a self-serving type of person. Now you may disagree or agree with Senator Holt or any bill that any of us put in. Each one of us has put in bills because somebody has asked for it; there's a need for it, and you stick with that bill. And I think that Senator

Holt, when I first met him in the House of Representatives, was one of the most creative people that I've seen. He represented his district very well. They wanted cock-fighting and he put in a bill and I told some people in cruelty to animals, and my Minority Leader came up and she said, 'Did you vote for Representative Holt's bill. Did you sign it?' I said, 'Of course, it was cruelty to animals.' So what he did was he left out the cock, and we would have had legalized cock-fighting. And I thought that was creative, innovative. I never held that against him.

"And that's what we have over here. You either have to work and try to work for the constituents that you have, the best way you know how. And I think we've all forgotten that. So when we disagree with somebody, we get angry. And I don't want you to be angry. I want you to be creative and innovative.

"I thank you so very much for your time, Mr. President."
