TWENTY-FOURTH DAY

Friday, March 4, 2016

The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2016, convened at 11:46 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators English, Nishihara, and Ruderman who were excused.

The President announced that he had read and approved the Journal of the Twenty-Third Day.

At this time, Senator Taniguchi welcomed a group of eleventh-grade students from Mid-Pacific Institute, who were seated in the gallery with their teachers, Suzanne Acord and Mohala Boncales.

Senator Gabbard honored and commended Hawai'i Green Growth, and presented the following remarks:

"Good morning, Mr. President, colleagues. We have with us today representatives from the Hawai'i Green Growth partnership. Hawai'i Green Growth is an innovative public-private partnership platform that coordinates across government, non-governmental, cultural organizations, business, academia, and philanthropy to advance sustainability. Recognizing the need for coordinated solutions across sectors to support sustainability and resilience, Hawai'i Green Growth was launched in 2011 on the margins of the APEC Summit in Honolulu.

"On July 7, 2014, Hawai'i Green Growth launched the Aloha+ Challenge, a statewide commitment to sustainable development and partnership, and with the leadership of the governor, four county mayors, and the Office of Hawaiian Affairs, the State Legislature unanimously endorsed the Aloha+ Challenge through S.C.R. 69, introduced by our senator from Hāna, who is excused today, that same year. The Aloha+ Challenge builds on Hawai'i's track record and early leadership on sustainable development and outlines six ambitious sustainability goals for 2030, including clean energy, local food production, natural resource management, solid waste reduction, smart sustainable communities, climate-resilience, and green workforce education. Hawai'i Green Growth currently serves as the de facto backbone of the Aloha+ Challenge to catalyze collaboration, action, and system-level change and is developing shared measures and a comprehensive policy and action agenda to drive implementation of Hawai'i's 2030 goals.

"Hawai'i Green Growth's strength lies in building a statewide network that fosters change, action, and innovation, and leveraging the capacity and expertise of its partners. Hawai'i and the U.S. Department of State jointly announced the Aloha+ Challenge as an example of U.S. action for green growth and a model that could be replicated regionally and globally at the 2014 United Nations Conference on Small Island Developing States in Samoa.

"And the reason I'm so stoked about Hawai'i Green Growth is just the holistic approach. We talk a lot about sustainability, but the fact is that you have government, non-government, the business sector, everybody, the kākou thing, working together, getting out of our silos and working together to achieve – here are our goals; here are these six goals; here's the target date; let's do this. That's why I'm so excited about the work that these guys do.

"As host of the 2016 World Conservation Congress in early September, which, as many of you know, is the Super Bowl for conservation issues, Hawai'i will be on the world stage to highlight our achievements and commitments in conservation, innovation, resilience, and sustainability. In November of last year, Representatives Lee and Yamane and I cohosted the first Aloha+ Challenge Legislation and Policy Retreat in partnership with Hawai'i Green Growth to develop 2016 policy and legislative actions to help achieve Hawai'i's 2030 goals and build toward the World Conservation Congress. Focused on the action agenda for the World Conservation Congress and the legacy left behind for Hawai'i, Hawai'i Green Growth is leading a process to catalyze and launch transformational, innovative signature initiatives that will advance our 2030 goals and showcase Hawai'i's leadership to the world.

"So, we have several Hawai'i Green Growth members and partners who are here today, representing the diversity of this partnership, and I want to acknowledge their leadership and commitment to a sustainable and resilient future for Hawai'i. First is Celeste Connors, who's the executive director for Hawai'i Green Growth; next is Breanna Rose, operations and partnerships manager for HGG; Dr. Kamana'opono Crabbe, CEO for the Office of Hawaiian Affairs, representing the Aloha+ Challenge signatories; Rob Parsons, the environmental coordinator for the County of Maui, representing the counties; Piia Aarma, president for Pineapple Tweed marketing and public relations, representing the private sector partners; and Matt Lynch, sustainability coordinator, University of Hawai'i, representing academia and youth engagement. Audrey Newman, who's the senior advisor to HGG, could not be with us today because she's traveling, but I would like to acknowledge her visionary leadership in founding the partnership five years ago. On behalf of the Senate, mahalo to Hawai'i Green Growth for your innovative efforts to help achieve Hawai'i's 2030 sustainability goals. You are truly a bright spot in our island state-determined efforts for green growth. So, Mr. President and colleagues, would you please recognize the team from Hawai'i Green Growth. Mahalo.

"And finally, also in the gallery with us are other Hawai'i Green Growth partners. I want to acknowledge their leadership and ask that they stand and be recognized: First is Suzanne Case, the chair of the Board of Land and Natural Resources; Deanna Spooner, Pacific Islands Climate Change Cooperative; Sylvia Yuen, Research Corporation of the University of Hawai'i; Christin Reynolds from Hawai'i Green Growth; Bitsy Kelley from Outrigger Enterprises Group; Kelvin Sewake from UH CTAHR; Kealoha Fox from OHA; Sharon Moriwaki and Mike Hamnett from the Hawai'i Energy Policy Forum; Laura McIntyre from the Department of Health; Emma Yuen and Katie Ersbak from DLNR; Brandon Lee from Ulupono Initiative; and there are many others; and last but not least, James Parish - that is Celeste Connor's son, a first grader at Punahou who is learning about the Hōkūle'a and sustainability and is representing the next generation. Would you all please give them a hand? Aloha and mahalo for all that you guys do. Mahalo."

At 11:54 a.m., the Senate stood in recess subject to the call of the Chair.

"Besides being a student and performer of Hawaiian music, Ms. Kumukahi comes from a family deeply rooted in Hawaiian traditions and knowledge, and conducts lectures for administrators in the DOE on the topics such as the values of a Hawaiian family.

"Mr. President, your committee takes particular note of Ms. Kumukahi's oral testimony that she sees the importance of integrating Hawaiian cultural values into Western thought, that marketing of Hawai'i and Hawaiian culture needs to be more than commercials and advertising, and it needs to be integrated on an international level into the fabric of cultural and social interaction between Hawai'i and the world. And, as mentioned in committee, Hawai'i's culture doesn't need a larger seat at the table because it is **the** table that every part of our visitor continuum can rely on to illustrate the quality that best defines Hawai'i as a premier experience. Therefore, your Committee on Tourism and International Affairs finds the nominee to be qualified and recommends that the Senate advise and consent to the nomination of Ku'uipo Kumukahi to serve on the Board of HTA. Thank you."

"At present, most insurance companies cover a 30- or 90-day supply of prescription contraceptives. This most basic level of access can still present obstacles for women seeking contraceptive coverage. Many communities throughout our state are rural or isolated, with limited numbers of health care providers and pharmacies, making it more difficult to schedule regular visits to the doctor or pick up prescriptions.

"Statewide efforts to expand women's access to prescription contraceptives, including long-acting reproductive contraceptives, lead to better continuity of use, fewer pregnancy tests, fewer unplanned pregnancies, and decreased health care costs for woman. This bill aims to broaden these positive effects by providing a greater number of prescription contraceptive supplies at one time, a practice that is recommended by the American Congress of Obstetricians and Gynecologists.

"The year-long benefits of coverage of prescription contraceptives is supported by women's organizations, the American Association of University Women, Hawai'i; Hawaii Public Health Association; Hawai'i Women's Coalition; Hawai'i State Coalition Against Domestic Violence; Hawai'i State Commission on the Status of Women; Planned Parenthood Votes Northwest and Hawai'i; Hawai'i Medical Association; Healthy Mothers, Healthy Babies; CVS Health as well as the Centers for Disease Control and the Hawai'i Department of Health

"I urge my colleagues to join me in supporting S.B. 2319, S.D. 1, which will increase access to prescription contraceptives for women across the State of Hawai'i. Mahalo."

"S.B. 2320, S.D. 1 will expand access to prescription contraceptives by authorizing pharmacists to prescribe and dispense self-administered hormonal contraceptives to persons 18 years of age or older, and requiring insurers in the State to reimburse pharmacists who prescribe and dispense contraceptive supplies.

"This bill will ensure that patients can readily access preventative contraceptive care. Research indicates that the incidence of unintended pregnancy decreases dramatically when barriers to contraceptive access are removed. According to the American Congress of Obstetricians and Gynecologists, studies have indicated that women can accurately identify conditions using a simple checklist to determine whether the use of certain contraceptives are appropriate their use.

"Medical expenses associated with unintended pregnancy cost American taxpayers an estimated \$11.1 billion annually. In 2010, 56 percent of all 16,000 pregnancies in Hawai'i were unplanned. According to the Hawai'i Public Health Association, barriers to access to the contraceptives that would offer women autonomy to plan their pregnancies in Hawai'i include scheduling issues, costs of care and not wanting an invasive and uncomfortable full gynecological examination to obtain a doctor's prescription. This bill removes a major access to care obstacle which is a particularly prevalent issue here, especially in rural areas on O'ahu and the neighbor islands, areas designated as medically underserved. Allowing pharmacists to prescribe self-administered hormonal contraceptives will give women across our state the opportunity to make personal health decisions of their own accord, rather than being unduly constrained by logistical and other factors that diminish access

"Your Committee on Commerce, Consumer Protection, and Health received overwhelmingly supportive testimony from obstetricians, gynecologists, private health care organizations, and state agencies expressly stating that the benefits of increasing access to self-administered hormonal contraceptives far outweigh any risks. I urge my colleagues to join me in supporting S.B. 2320, S.D. 1, which will increase access to contraception for Hawaii's women. Mahalo."

Testimony from the Director of Telehealth at Queen's Medical Center made it clear that their services would not be financially possible without federal grants.

"This bill also ensures that medical professionals will be covered under their professional liability or malpractice insurance when practicing virtually.

"Your committee received testimony in support of this measure from a broad range of the health care community, including Queen's, the UH College of Social Sciences, the Healthcare Association of Hawai'i, and HMSA. By passing this bill we will continue to improve access to care throughout
