

FORTY-FIRST DAY

Monday, April 4, 2016

The Senate of the Twenty-Eighth Legislature of the State of Hawai'i, Regular Session of 2016, convened at 11:39 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senator Thielen who was excused.

The President announced that he had read and approved the Journal of the Fortieth Day.

At this time, Senator Chun Oakland remarked on the work of child abuse and neglect prevention advocates and community organizations, noting that April is National Child Abuse Prevention Awareness month, and that in 2008, Prevent Child Abuse America introduced the pinwheel as the new national symbol for child abuse prevention through Pinwheels for Prevention. Senator Chun Oakland commented on the members' support and longstanding commitment, with the passage of the Hawai'i Children's Trust Fund in 1993; the creation of the Blueprint for Change process in 1994, involving over 600 organizations and individuals committed to child abuse prevention and neglect and improving the child protective services system, as well as commitment to the statewide home visiting and other community-based family services; and the decades of community and governmental organizations' dedication to improve the wellbeing of children. Senator Chun Oakland then shared some of the positive outcomes for young people that have resulted from the implementation of many of the Blueprint for Change recommendations: In the last 10 years, with the full implementation, there has been a significant reduction in the number of confirmed cases of abuse and neglect statewide. From 2004 to 2013, psychological abuse has decreased by 82 percent; neglect has decreased by 67 percent; threatened harm has gone down by 63 percent; physical and sexual abuse both decreased by 63 percent; and medical neglect has decreased 58 percent. Senator Chun Oakland noted that the members would be receiving a vase that has the pinwheels as a thank-you from the Child Abuse Prevention Planning Council, Prevent Child Abuse Hawai'i, and the Prevention Partners statewide. Senator Chun Oakland then recognized Aileen Deese and Bob Raasch Barajas from Prevent Child Abuse Hawai'i, Chet Adessa, and other supporters from the Department of Health, Department of Human Services, and other state agencies who were present in the gallery or otherwise engaged in work in the community.

Senator Kim welcomed a group of 156 eighth-grade students from Moanalua Middle School, who were seated in the gallery with teachers Bryantt Bernardo, JoAnn Fu, Tiffanie Rivera, Jarrett Honjiyo and chaperones Dawn Young and Bruce Yonesaki.

Senator Gabbard acknowledged a group of representatives from the Christian community in Hawai'i, and noted that the ad hoc coalition of churches of various denominations designated March 28 through April 4, 2016, as Christian Heritage Week in Hawai'i. The week serves as a reminder to reflect upon and celebrate the significant role that the Christian church has played over the past 196 years in Hawai'i, as well as an encouragement to motivate greater spiritual acts in the daily lives of Christian followers. Senator Gabbard then introduced the following representatives of the Christian community who were present in the gallery: Kahu Fred Welch, Joyful Community Church; Kealoha Benavente, Kawaiha'o Prayer Ministry; Leon Siu, Christian Voice of Hawai'i; Chanel Sibala Bumanglag; Terita Tehutu; Kurt Kamikawa; and Wendy Loh; and Kahu Kurt Kekuna and Cheryl Toyofuku, who were not in attendance.

Senator Galuteria recognized Leon Siu's wife, Malia, who was seated in the gallery, and noted that she used to be a part of the musical duo Leon & Malia.

Senator Kidani commended and congratulated Kumu Hula Hokulani Derego and Halau Hula 'O Hokulani on celebrating 25 years of the Hula 'Oni E Hula Festival, and presented the following remarks:

"Thank you, Mr. President. Colleagues, Senators Inouye and Dela Cruz and I were very, very fortunate to be able to experience the Merrie Monarch Festival in Hilo over the weekend. Those who have been in the audience or otherwise participated in the Festival during its 50-year run know that this is a totally immersive experience. It is an affirmation of Hawaiian culture and the importance of hula in perpetuating that culture through movement, mele, and storytelling.

"Kumu hula take on an almost-sacred responsibility to teach the dance, through which culture and language are passed on through generations. That is certainly the case with our guests on the floor this morning. May I introduce na kumu Hokulani and Larry DeRego, who lead Halau Hula 'O Hokulani. The DeRegos are residents of Waipi'o Gentry in my Senate District 18, and I am so very proud to recognize them as 'neighbors' and constituents.

"Halau Hula 'O Hokulani has participated in the Merrie Monarch Festival in the past, as well as other major events, such as the annual Keiki Hula Festival. The halau has been the hula home to literally hundreds of students over the more than 30 years since the DeRegos committed to their life's work. While their primary mission is to perpetuate our island culture among home-grown dancers, they have also cultivated the necessary resources to share hula with the world. The halau has traveled to Japan, Russia, Poland, Slovakia, Austria, Germany, and to our neighboring Pacific islands of New Zealand and Guam. A little closer to home, they have performed at Carnegie Hall in New York; in Washington, D.C.; and in many other venues in many other states across the U.S. mainland.

"Along the way, the DeRegos established the Hula 'Oni E Hula Festival that this year celebrates the twenty-fifth anniversary of its founding. More than 500 halau have competed in Festival programs from all islands and around the world.

"For all of this, the Senate is pleased to commend Hokulani and Larry DeRego for all they have done to preserve and perpetuate traditional hula and Hawaiian culture. Mahalo for your dedication to perpetuating Hawai'i's culture. Mahalo for the DeRegos and for what they have done for our hula and our Hawaiian culture. Mr. President, at this time, I would like to ask my colleague to introduce the family and halau friends who are here with us this morning."

Senator Dela Cruz rose to present the following remarks:

"Thank you, Mr. President. I'd like to introduce Larry and Hoku's daughters: Nani, on the floor – Nani is a former Miss Aloha Hula contestant – and Kehau is up there with Hoku and Larry's grandkids. And I also want to introduce my older sister, who participated in the Merrie Monarch under Hoku. Thank you, Mr. President."

Senator Kidani rose and stated

"And I wanted to end, Mr. President and colleagues, to make a note that as a result of relationships that the halau established with dancers in Austria, a group of seven dancers from Vienna will be joining Halau Hula 'O Hokulani when they perform as a

part of this year's Lei Day program, Sunday, May 1st, at the Kapi'olani Park bandstand. Thank you, all, who have attended and been here to honor our kumu hula. Mahalo so much."

Senator Galuteria extended an additional welcome to Kumu Hula Derego and Larry Derego, adding that he had introduced Halau Hula 'O Hokolani at its very first performance at the May Day ceremony over 30 years ago at the Kapi'olani Park bandstand.

Senator Baker recognized and honored Legacy of Life Hawai'i, and presented the following remarks:

"Thank you, Mr. President. Colleagues, April is National Donate Life Month. During this time, there are many local, regional, and national activities to help encourage Americans to register as organ, eye, and tissue donors. This is also our opportunity to celebrate those who have saved lives through their gift of organ and tissue donation. A wonderful local organization, Legacy of Life Hawai'i, is dedicated to saving and restoring lives by recovering organs and tissues for transplantation. Its dedicated staff donors, those who have given the precious gift of life, help to educate the public about the urgent need for more people to become donors. I invite each of you to join me and become a donor; you can designate yourself as an organ/tissue donor by checking a box on your driver's license and then informing your family of your wishes.

"Today, we are joined by families of some of those life-giving donors who helped to restore and save the lives of others. Mr. President, on your behalf, I'm going to begin the story of sharing with a story from Kaua'i. With us today are Peter and Wendy Kruse. Thank you. Their daughter, Lokelani Martha Yoshimi Kruse, shone with brilliance, talent, and enthusiasm. She had a mind full of wonder and curiosity, and excelled in math, science, and the arts. All who had the pleasure of knowing her would agree that the sky was the limit for Lokelani. She was only 16 when a tragic car accident took her life, but she had already articulated her stance as an organ and tissue donor. In a high school essay, she stated that she wished to be an organ donor and encouraged others to do so as well. Lokelani's parents bravely honored her wishes to be an organ donor, which enabled her to save two lives and restore sight to two others, thanks to her donation. They continue to honor her legacy through her dedicated service in educating the people of Kaua'i about the importance of organ and tissue donation. Colleagues, please join me and thank Peter and Wendy, and I would also like to acknowledge Peter and Wendy's son, Tyler, in the gallery as well. Thank you, Wendy and Peter, for your dedication and your commitment to honoring your daughter's wishes. And now I yield the floor to Senator Chun Oakland."

Senator Chun Oakland rose to present the following remarks:

"Thank you, Mr. President. It is with great honor that I have the pleasure of introducing Frank and Jessie Ginoza; they are the parents of Steven Mitsuo Ginoza. The youngest of four children, Steven Mitsuo Ginoza was a graduate of the University of Hawai'i at Mānoa and a civil engineer at the Honolulu Board of Water Supply. Steve lived life to the fullest and loved helping people. His decision to become an organ donor allowed him to continue helping others by giving them the opportunity to honor his zest and love for life. He was also the brother of my friend Sandi.

"His parents have been able to look beyond his personal tragedy and see the ways in which Steve's gift of organ donation blessed so many others – thank you so much for what you do. In the gallery, we would also like to recognize Steve's extended 'ohana: his heart recipient, Yolanda Domingo; his kidney recipient, Celita Julian. I would also like to take a brief moment to honor the memory of someone that maybe many of you know: Tony Sagayadoro, Steve's kidney recipient. Tony is

with us in spirit, and we are joined by his wife, Rina, and son, Glenn. We miss Tony a lot, too, very much so. At this time, I would like to yield the floor, Senate President, to our colleague, Senator Wakai. Thank you."

Senator Wakai rose to present the following remarks:

"Thank you, Mr. President. What a great way for all of us to celebrate life. Today, we honor true – true – community heroes. Very few of us can say decisions that we make directly allow others to live and thrive. The medical miracle of organ donation can only happen when a grieving family member says yes. It is my honor to introduce to you a mother who did just that, who said yes: Ladies and gentlemen, I introduce you to Elisa Dannels.

"Elisa's son, Jonathan – pictured in her hands, there – was born in France, and both of them moved to Honolulu when Jonathan was a young child. He had big dreams, and he was willing to work diligently toward them. He was a certified automotive diesel mechanic. Riding his motorcycle, surfing, and hiking brought him endless joy. 'Ohana was the one constant in his life. Although his life was cut short in a vehicle accident, Jonathan gave the gift of sight to two others. That donation helped his grief-stricken mother cope with her loss. Thank you for being here with us today, Elisa, and thank you for your gift of life. In the gallery, I would like to acknowledge Butch; he is Elisa's cousin. Thank you. Thank you to all of you for giving the gift of life. With that, Mr. President, I'd like to hand it over back to Senator Baker."

Senator Baker rose and stated:

"Thank you, Mr. President; thank you, Senator Wakai and Senator Chun Oakland. Mr. President and colleagues, the gift of organ donation saved 30,000 lives nationally in 2015; it was a milestone year. Tissue transplants restore the quality of life to more than a million others, but the need here is very great. There are more than 121,000 patients, including 438 in Hawai'i, waiting for life-saving organs. Asians, Pacific Islanders, and Filipinos – 60 percent of Hawaii's population – are especially at risk for end-stage organ failure. So, we do need organ donors, so if any of you can sign up if you haven't, we encourage you to do so.

"In the gallery today, we are also joined by staff of Legacy of Life, supporters of Legacy of Life programs, as well as recipients of the gift-of-life donations; so if all of the staff and families of donors and recipients could please rise to be recognized, we'd like to honor you as well. Colleagues, we salute all donor families for their efforts to build a healthy and caring Hawai'i. During this Donate Life Month, let us remember Lokelani, Steven, Jonathan, and the thousands of other donors in Hawai'i who have saved and restored the lives of so many. Mahalo."

Senator Kidani recognized members of Halau Hula 'O Hokolani, who were present in the gallery.

At 12:01 p.m., the Senate stood in recess subject to the call of the Chair.

“Mr. President, I rise in support of H.B. 2727, H.D. 1, S.D. 1, Relating to Movie Theaters, which seeks to permanently remove communication barriers for movie audiences who are deaf, hard of hearing, blind or have low vision.

“This measure repeals the sunset date on Act 39, SLH 2015 and makes permanent the motion picture accommodation standards which require a company that owns, leases or operates a motion picture theater in more than two locations in the state to provide open movie captioning and audio descriptions during at least two showings per week. This will ensure that Hawai’i continues to support full access for persons with disabilities and meaningful accessibility requirements for movie goers.

“With Act 39 and this measure, Hawai’i becomes the first state to provide open captioned films in all movie theaters. While movie theaters may currently make captioning available via the use of various assistive devices, these devices are uncomfortable and often difficult to use. With open captioning, which refers to captioning that is seen on the screen by all viewers and audio descriptions, all theater patrons are provided equal access to cinematic entertainment at venues throughout Hawai’i.

“Let Hawai’i continue to be the role model for others to follow. I ask my colleagues to join me in support of H.B. 2727, H.D. 1, S.D. 1.”

The motion was put by the Chair and carried, H.B. No. 2727, H.D. 1, S.D. 1, entitled: “A BILL FOR AN ACT RELATING TO MOVIE THEATERS,” having been read throughout, passed Third Reading on the following showing of Ayes and Noes:
