Monday, April 3, 2017

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2017, convened at 11:40 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senator Ruderman who was excused.

The President announced that he had read and approved the Journal of the Forty-First Day.

At this time, Senator Wakai recognized and congratulated the United States Small Business Administration's State of Hawai'i Small Business Award recipients, and presented the following remarks:

"Small businesses are the backbone of our economy; they provide the resources that give us the opportunity to do the good services we do for the people of this state. And over the last three decades, the Small Business Administration awards have recognized those who have proven their excellence in small business. These awards continue to be the most competitive and comprehensive awards presented in the state, and these winners, who are both entrepreneurs and advocates, have proven they have the creativity and determination to turn adversity into opportunity. I would first like to take the opportunity to introduce the Hawai'i district director of the Small Business Administration, Jane Sawyer. Jane first joined the SBA in 1993 and currently oversees all activities of the federal agency. Her district territory includes the State of Hawai'i, American Samoa, Guam, and other affiliated Pacific islands. Mr. President, with your permission, I'd like to yield my time to my colleague Senator Karl Rhoads for the introduction of our first winner."

Senator Rhoads rose to present the following remarks:

"It's my pleasure today to introduce Patrick Gesik, the 2017 Small Business Administration Young Entrepreneur of the Year. Established in 2013, Gesik Physical Therapy provides orthopedic physical therapy through hands-on manual therapy techniques, exercise prescription, and neuromuscular movement lessons to restore function and relieve pain so patients return to full activity levels in personal and work life. Dr. Patrick Gesik, who was inspired by the physical therapy careers and commitment of his parents, is the driving force behind this young and fast-growing practice.

"Without compromising patient care for profit, Dr. Gesik has demonstrated the ability to grow this thriving business by increasing annual revenues more than tenfold in three years. The growing patient base required relocation to a larger facility with four treatment rooms and a gym space in 2014 and the addition of five full-time licensed therapists. Dr. Gesik secured a Small Business Administration Express Loan to keep this expansion plan moving smoothly ahead. Gesik Physical Therapy continues to grow through positive referrals from physicians and patient satisfaction. In preparation for future growth and employment opportunities for the next generation of physical therapists, Dr. Gesik continues to align evolving patient needs with business growth strategies that offer ways to stay connected with his patients through their healthcare experience. Can we have another round of applause for Dr. Gesik?"

Senator Thielen rose to present the following remarks:

"It's my pleasure to introduce the 2017 Family-Owned Small Business of the Year for the State of Hawai'i, John Mullen & Company, who is represented today by Cyndy Knudson.

Founded in 1959 by John and Margaret Mullen, John Mullen & Company is a third-generation kama'āina company that operates as an insurance adjusting firm, representing companies throughout the State of Hawai'i and the Pacific Basin. Owner and president Terry Mullen has worked in the enterprise for 40 years before being named president and CEO in 1990. Terry's daughter Sara also works in the company, taking on other highlevel management duties in the family business. Under the Mullens' leadership, the 58-year-old family company continues to grow, showing annual increases in revenue, assets, and net worth. Employees are treated like family, a priority that is validated with loyalty and longevity of staff who have worked at the company over 25 years. 'Demonstrating aloha through every task and interaction, whether with a client or a fellow employee, is what we strive for at John Mullen & Company on a daily basis.' I'd also like to recognize Russell Shogren Jr. of First Hawaiian Bank, who had nominated the company; thank you. And another round of applause for Cyndy Knudson and John Mullen & Company."

Senator Harimoto rose to present the following remarks:

"Today, it's my privilege to recognize Maria A.F. Etrata as the 2017 SBA Small Business Advocate for Minorities. Maria has demonstrated an extraordinary commitment not only to the minority and women business owners in home health care, but also to the needs of the unfortunate, disabled, and elderly, who are the patients and clients of these businesses. Maria founded the Primary Care Providers of Hawaii in 1996 to create a network for the care home industry to provide information and education to its membership and to be a voice on legislation affecting care homes. The association has grown to over 500 members who work together to offer training in the latest practices and find needed services and respite help. In 2002, Maria started Preferred Home & Community Based Services that responded to a new need for daycare services for persons with developmental disabilities that emerged as a result of the closure of Waimano Training School and Hospital. Maria and her husband, Renato, also established the philanthropic Renato and Maria A.F. Etrata Foundation to not only nurture the Filipino spirit but also to improve communities by supporting educational, cultural, and social programs for multiple cultures and faiths from around the world. Maria was unable to be here with us today, so representing her is Nedy Directo, who nominated Maria for this award.'

Senator Chang rose to present the following remarks:

"Each year, the Small Business Administration is pleased to honor Hawai'i's top entrepreneurs and advocates with prestigious annual SBA awards. This year's Small Business Advocate for Financial Services for the State of Hawai'i is Reginald Baker. Beyond the services and support provided by his accountancy practice, Baker has dedicated more than 25 years to promoting and assisting Hawai'i's small business owners with their operations through consulting, training, and other support. Baker has served as a director with the Chamber of Commerce and as a leader of the Small Business Council, drafting and presenting testimony to the State Legislature on key issues impacting small businesses over many years. Representing the State of Hawai'i, he was appointed to SBA's national board for regulatory fairness and selected to chair the Region IX board. In that role, he has convened a Regulatory Fairness Roundtable with the SBA's Office of Advocacy in Washington, D.C., and the regional advocate for SBA in San Francisco. He has also coordinated efforts with SBA and AICPA on national issues on regulatory issues on health care, IRS tax deadlines, and U.S. Department of Labor rules and regulations.

"Together with ThinkTech Hawaii, Baker has hosted over 70 live-streaming shows that focus on small business topics, success stories, and resources, and now serves on that organization's board of directors. Another worthy achievement to benefit from his business acumen and leadership is Junior Achievement of Hawaii, promoting financial literacy and basic business concepts to Hawaiii high school students. Baker is a respected resource and contributor to media outlets locally and on the mainland, including PBN, Star-Advertiser, Hawaii Business magazine, Fox News, KHON, and other radio and news programs. May we please give Reginald Baker another round of applause for all of his accomplishments?"

Senator Green rose to present the following remarks:

"It's my distinct pleasure to announce our 2017 Small Business Advocate for Journalism and Media for the State of Hawai'i; our award winner is Sherry Bracken, and the award will be accepted by Jane Sawyer - Jane, could you stand again for a brief bit of applause for Sherry? So, as we channel Sherry, we'll look at you, Jane. Sherry's a consultant, advocate, educator, and moderator offering awareness to Hawai'i's small business owners and individuals about information, issues, and policies which impact our local community. Sherry Bracken writes, hosts, and produces a daily event program as well as a weekly interview program for two Hawai'i Island stations. She's a contributing news reporter for Hawai'i Public Radio and works with Big Island Video News, giving a voice to stories about business, nonprofit organizations, and people and events all across our Big Island. Sherry has interviewed more than 500 guests, each of whom have impacted Hawai'i's economy and quality of life, from elected officials - which we fear Sherry, on occasion, when she's interviewing us, because she gives great probing interviews - to business leaders, from subject matter experts to students. Storylines have covered issues from our weather to environment, vog and the volcano on Big Island, disease to diversity, and many of the most important issues and controversial challenges of our time.

"Sherry views her role as an advocate for a healthy, robust economy by educating and informing our public to empower change. Bracken is also sought for her services as a moderator; to discuss research topics, she confers with others to frame questions to bring about useful information, often to influence decisions and solutions. On radio, she live-streams Nā Leo television, and as a journalist, Sherry continues to inform our view and vision of Hawai'i. She's a personal friend, and we so appreciate her. Thank you for being here today, Jane. Mr. President, if I may ask for one more round of applause for Jane and Sherry, in this case?"
