FORTY-SECOND DAY

Tuesday, April 3, 2018

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2018, convened at 11:38 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Forty-First Day.

At this time, Senator Shimabukuro welcomed her son and his classmates from Ka Waihona o Ka Naʻauao Public Charter School, who were seated in the gallery with teacher Kapua Belay and chaperones Kalei Sagapolutele, Marie Belai, and Ostey Costales.

Senator Wakai recognized the Moanalua High School Symphony Orchestra, and presented the following remarks:

"Please allow me to get this presentation off to a magnificent start [plays audio recording]. That was a clip of the overture to Morning, Noon, and Night in Vienna, not by the Boston Philharmonic but by our own Moanalua High School symphony in Atlanta just last month. It is with absolute pleasure that I recognize the Moanalua High School Symphony Orchestra and its revered music director, Mr. Elden Seta. Ladies and gentlemen, year after year, this former Milken Award-winning teacher doesn't just rebuild his music program; he reloads it. Last month, Mr. Seta led a group of extraordinary students to this year's American String Teacher Association's National Orchestra Festival. This annual festival brings together renowned orchestras from around the country to receive placement, ratings, comments, and instruction from prolific music leaders. Participation is based upon résumé, credentials, recommendation, and live performance recordings. Moanalua was one of 20 high schools nationwide selected to attend in Atlanta last month. The students' dedication and long rehearsals paid off: The group took first place for the high school full orchestra category and were also named grand champion in the high school division. For decades, Moanalua has distinguished themselves as the premier high school music program in Hawai'i. Now, I've long argued they were probably one of the best in the nation - well, now we have confirmation. This before you, ladies and gentlemen, is the number one music program in America.

"Mr. Seta is joined here by some of his astounding musicians; I'd like to take a moment to recognize them. We have Emiley Hadano, symphony orchestra president; Annika Wong, symphony orchestra vice president; Megan Ganeku, symphony orchestra secretary and concert master; Carissa Miyamoto, symphony orchestra librarian; Brooke Kumasaka, symphony orchestra librarian; Efren Enriquez, symphony orchestra equipment manager; and Raidyn Mendez, symphony orchestra equipment manager. How about a round of applause for all of them? Congratulations on making Moanalua and the State of Hawai'i proud; congratulations to you, Mr. Seta, the maestro of this prolific, legendary program at Moanalua."

Senator Dela Cruz commended the Mililani Town Association on celebrating 50 years of leadership and service, and presented the following remarks:

"Colleagues, with all due respect to you and your home districts, I'd like to declare central O'ahu as the best place to call home in the State of Hawai'i. The intent is not to start a debate, although I can understand if you rise in opposition to this. The intent is to recognize that over the past five decades, the vision of developers of Mililani Town and Mililani Mauka as Hawai'i's largest planned community has been fulfilled. The

vision actually dates back 60 years, when Castle & Cooke first conceived of Mililani. A decade later, in 1968, sales of the community's first 800 homes began, and Mililani Town Association was established to guide property use and ensure a safe and secure living environment for all resident families. It is the association's fiftieth anniversary that we recognize today as we welcome MTA's Board of Directors and general manager to the floor.

"In 1986, the National Municipal League named Mililani Hawai'i's only All-American City. The community has been recognized as one of *Money* magazine's Best Places to Live in the U.S. And we all know that Mililani High School – home of the Trojans – consistently ranks at or near the top in the *U.S. News & World Report* compilation of Hawai'i's Best High Schools

"The list of good things about Mililani and Mililani Mauka could go on and on (besides being the hometown of Senator Kidani). There are 16,000 households and nearly 50,000 residents, 7 recreational centers, and a full calendar of monthly activities for young and old. All of this is the result of careful attention to values cultivated by MTA that encourage positive interactions among neighbors, businesses, and civic organizations.

"Please allow me to introduce MTA's Board of Directors: president Bob Barrett; vice president Senator Michelle Kidani, who has served on the Board for 18 years; board secretary Josie Hart Ka'anehe; and board members Will Kane, Neil Takeda, former State Representative Michael Magaoay, Val Okimoto, Noriko Salangdron, and Glenn Yoshimori — on the board for more than 30 years (Glenn is not able to join us today). Also with us is MTA general manager David O'Neal, and I'd like to take this moment to wish him a happy birthday. I would also like to recognize additional guests in the gallery, MTA staff: Sheryl Kamikawa, executive assistant; Kaleo Perreira, aquatics manager; and Caryn Tangalin, human resources manager. Also with us are Stan and Kaulana Salangdron, husband and daughter of board member Noriko Salangdron.

"Mr. President, the official celebration of the association's fiftieth anniversary will take place on Saturday, April 21, at Mililani High School's football stadium. The program will include music and fireworks, very much in keeping with the town's image as an All-American City. Mahalo to the board, and congratulations to the association."

At 11:48 a.m., the Senate stood in recess subject to the call of the Chair.

Mr. Morikone has been actively involved in the legal community throughout his career, including as a volunteer for appellate advocacy and trial practice courses and as pro bono legal counsel for the Oahu Interscholastic Association. In addition, he has served as the foreclosure commissioner since 2013 and participated in Lawyers League Softball since 2003.
