# Tuesday, April 10, 2018

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2018, convened at 10:12 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senator Harimoto who was excused.

The President announced that he had read and approved the Journal of the Forty-Fifth Day.

At this time, Senator Tokuda noted that it was Equal Pay Day, the day when women catch up in earnings to what their male peers made the previous year, and urged the members to take a moment in the ongoing fight for women and working families to demand equal pay for equal work. Senator Tokuda then recognized representatives from the Women's Coalition and the American Association of University Women, as well as the executive director of the Commission on the Status of Women, and thanked them for their ongoing advocacy.

"However, I also support the process that we have here in our Senate and in our rules and mainly the processes to allow the public the opportunity to have a say and to testify on many of these measures, especially those that have far-reaching effects. In our Rule 23, it says, 'If a bill: (B) Contains any significant or substantial amendment made by a committee other than the last standing committee to which the bill has been referred;' it must have a public hearing, and (C), 'The public has not been provided with an opportunity to submit testimony on the significant or substantial amendment;' and, therefore, there should have been a hearing. On those procedural issues, Mr. President, I will be voting against the amendment, although I agree with it, and then therefore vote against the bill at this point in time.

"I'll also point out that it's not necessarily an emergency in the sense that we didn't realize or know that these are issues that were out there. Unfortunately, we have deadlines, and ideas as to how we can hold them accountable came after the process, unfortunately, but we have to guard the fact that the public needs to have a say on that measure. I reluctantly will vote against this measure. Thank you."

That's because the nature of the community is agricultural-based and it cherishes its clean environment. I understand that this is an electric launching facility; I wonder if they realize that Hawai'i island has one of the most expensive electricity costs in our nation, and I wonder how that's going to work out. I also hope that one day, those who propose and advocate for controversial, lifestyle-changing major projects with environmental and cultural impacts will talk to the people impacted and/or their representatives before they proceed with the proposal. As the senator from the district that this always seems to happen to, I will oppose any such projects. Thank you."

Senator Wakai rose to speak in support of the measure as follows:

"The opportunities for our aerospace growth are limitless, and this measure in front of us simply allows for us to say, 'Go ahead, SpinLaunch: Test your new and innovative way of launching small satellites someplace in Hawai'i.' So, in the Ways and Means committee, there were changes to the language of this measure, which doesn't say that it's going to be on the Big Island, doesn't say it's going to be in Ka'ū, doesn't say it's going to be anywhere specifically in Hawai'i but just simply that we embrace this idea, this innovative approach, and would like to see it, hopefully, tested someplace in the state. So, there's misconception that somehow this particular project will end up in Pohue Bay. It's certainly been made clear to myself and to the proponents of SpinLaunch that that is a highly inappropriate area, but I would hope that my colleagues will see the huge opportunities that stand in front of us with a number of small satellites that will need to be launched into space in the very near future and see that Hawai'i could play a significant role in this for economic benefits as well as scientific discovery. So, rather than being closed-minded to saying, 'Not in one place,' let's be open-minded to say, 'Someplace in the State of Hawai'i.' Thank you, Mr. President.'

Then, instead of it being a pure negative, we can turn it into a motivational tool to help these companies become good citizens and help resolve one of the greatest problems we have in our district. Thank you."

"While the windward district of O'ahu may not have the largest problem in the nation with helicopter noise, I think it does rank up there in the top 10, with the number of tours and other things, and I agree with the comments of the senator from the Big Island and also with the Big Island Mayor: The tax credit should be reserved for responsible corporate citizens and actually to encourage and reward good behavior. I think it's an excellent idea to limit the tax credit to the helicopters that are going to be adopting the quiet technology because we'd actually be giving them a tax break so they can put those saved revenues toward some improvements in their operations, which will provide tremendous relief to our residents. There are also other ideas, such as rewarding corporations that would agree to some type of good-behavior compact, to not run tours during the weekends or the early morning hours or in the late evenings, when it's going to be bothering residents. There are many good-behavior things that many of us have tried for years to get these organizations to adopt that they have not adopted, and I think it's worthwhile to be holding back on any final decisions until we get that change of behavior. Mahalo."

Senator Dela Cruz moved that Stand. Com. Rep. No. 3679 be adopted and H.B. No. 2598, H.D. 2, S.D. 2, having been read throughout, pass Third Reading, seconded by Senator Keith-Agaran.

Senator Ruderman rose to speak in support of the measure with reservations as follows:

"I support the intent of this bill, and I hope we do come out with a paid family leave bill this year. As the employer of more than 200 people, I'm concerned about the uncertainty of what it will look like, and that's why I vote 'with reservations.' I preferred the task force that was going to come back and make suggestions, but I support whatever effort makes this succeed this year, and I appreciate the efforts of the Labor chair in this regard."

Senator Inouye requested that remarks in opposition to the measure be entered into the Journal, and the Chair so ordered.

The Chair having so ordered, Senator Inouye's remarks read as follows:

"Thank you, Mr. President. I rise in opposition to House Bill 2598 – which requires the Department of Labor and Industrial Relations to establish paid family leave for all workers by January 1, 2021, as well as requires reports to the Legislature. I understand the intent of this bill is to allow for paid leave in the workplace, and agree that citizens need to balance the needs of work and family. However, I do not support this bill.

"As many **national rankings** have shown, the cost of doing and running a business is extremely high. With every additional workplace mandate, the competitive distance is increased, which, in turn, affects the ability for employers to sustain and create jobs, as well as provide benefits to employees. In addition, the **implementation board** in this bill has broad authority to implement a program with potentially very little input from employees or businesses.

"Therefore, members of the chamber, **I stand in opposition** to **H.B. 2598**, and thank you for your consideration. Mahalo."

Senator Tokuda rose to speak in support of the measure as follows:

"Paid family leave is about recognizing the importance of our workers and our families. I'd first like to thank, and I truly appreciate, the Ways and Means committee for putting forward the amendments that both Chair Johanson and I have made recommendations for so that we could have a full array of options going into conference.

"The measure before us is a result of a series of conversations and discussions that we have been having with both advocates and businesses, focused on what best practices could create a paid family leave model that most efficiently and effectively delivers benefits to our workers and our families while at the same time ensures that we have the least amount of initial and ongoing costs, which is very important to our taxpayers. While very different from the previous versions of the bill, the measure that we have before us identifies expanded TDI as the established model - a model found in many of the states that have paid family leave - and it was put forward specifically to address the concerns that were identified by business as to that uncertainty that was established in the previous bills because it was going to be the job of the implementation task force and various studies to identify the model and then put it forward in the years to come.

"That being said, as we know, it is going into conference committee, and we will do the due diligence of looking to see what that final outcome is. We appreciate that we now have an array of options to look forward to in terms of being able to, once and for all, make sure that our workers and our families have the dignity and that option of paid family leave to be able to take care of one another going forward, because we know all too well the statistics, and they're very daunting: By 2020, 40 percent of our workforce will be taking care of an aging family; in fact, right now, in our community, over 240,000 individuals have that responsibility that they bear very willingly and lovingly to care for an aging loved one. Paid family leave, the bottom line: It just makes sense. And I thank you for allowing us to keep these measures moving forward so that we can go into conference and, hopefully, at the end of the day, pass a measure that can help us take care of our families and our workers."

H.B. No. 1900, H.D. 1, S.D. 2:

Senator Dela Cruz moved that H.B. No. 1900, H.D. 1, S.D. 2, having been read throughout, pass Third Reading, seconded by Senator Keith-Agaran.

Senator Dela Cruz rose to speak in support of the measure as follows:

"For fiscal years 2019 through 2023, the administration has presented a financial plan and a budget balanced on deficit spending and depending on the carryover funds to cover expenses. With the current state financial plan, we are on a path to deplete our \$1 billion carryover balance by 90 percent. The state is spending more than what it generates. The Senate put together a responsible financial plan; we looked at ways to cut costs, reduce spending, and put forward bills to generate revenue, which have crossed over to the House. These measures will bring the overall state's financial plan in the black by fiscal year 2022, one year earlier compared to the current state financial plan. Act 49, Session Laws of Hawai'i 2017, provides a base budget of \$14.3 billion, of which \$7.421 billion are general funds for fiscal year '19. Including all governor's messages that the Legislature received, the administration proposed to add \$121.3 million to the base budget, of which \$65.6 million are general funds. In addition – or, should I say, subtraction – the Legislature can no longer count on the \$33 million and \$67 million in the out-years of B&B revenue.

"Working with the subject matter committee chairs and putting together the Senate draft, we kept in mind our fixed cost obligations, such as our health benefits, Medicaid, pension, and debt service. These obligations alone account for 49 percent of our supplemental budget spending. The Senate draft of the budget puts forth an additional \$70.7 million in general funds. Of that \$70.7 million, \$65 million in fiscal year '19 are nonrecurring costs and do not add to the base budget. The Senate draft proposes to add \$14.6 million for the base budget for years going forward, of which \$5.6 million are in general funds to pay for programs like Kupuna Care and Medicaid, adult dental health programs – many of these programs are to address Hawai'i's increasing aging population.

"Changes in the Senate draft of the budget and the additional revenue bills that the Senate has passed over to the House include proposed one-time revenue infusions of \$79 million and additional \$120.7 million in recurring revenue going forward. Additionally, per the 2016 state reserve policy, which recommends having 10 percent of the general fund balance on hand, we have invested \$81.4 million into the Emergency and Budget Reserve Fund, the rainy day fund, in order to get that balance up to \$700 million.

"The committee feels it's important to limit the growth of government and reduce duplicative services. Where applicable, departments should be working with each other to provide services to Hawai'i's residents. With that in mind, and incorporating the departments' requests this year for fiscal year '19, the Senate reduced 32 positions to maintain the position ceiling identified in Act 49, Session Laws of Hawai'i 2017.

"There are many competing needs the state must address, and we must prioritize. The committee recognizes the state's role in overseeing and managing a range of services for our kūpuna, addressing issues surrounding homelessness, investing in the development of affordable housing, funding early childhood education and the Hawai'i Promise Program, and making preparations to scale up our farm to school programs statewide. The Senate draft of the state budget includes funding the following priorities: Investing into the development of increasing our affordable housing inventory; supporting programs and services for agriculture; funding to support grants for local businesses to help expand and diversify our economy; providing funding for early childhood education, early college programs, and the Hawai'i Promise Program; funding to protect our natural resources; funding to support critical Medicaid and adult healthcare services, including Kupuna Care and caregiver programs; providing funding for critical programs to address homelessness, such as Housing First, Rapid Re-Housing, and the implementation of ohana zones; and an infusion into the state's rainy day fund.

"The Committee on Ways and Means worked closely with each Senate subject matter committee chair to identify Senate priorities to be included in the Senate draft. For the Department of Agriculture, in working with the Ag chair, we included \$1 million for invasive and hazardous plant mitigation and \$300,000 for environmental protection, pesticide drift buffer zone pilot program. In addition, two positions for farm to table statewide. "In working with the Government Operations chair, we've included \$118,000 for salary increases for the State Procurement Office and \$265,000 for the Hawaii State Digital Archives.

"In working with the ETT chair, we've included \$200,000 for Creative Lab Hawai'i expansion to neighbor islands, \$150,000 for PISCES, \$150,000 for unmanned aerial systems, and \$1.5 million for the accelerator program.

"In working with the Transportation and Energy chair, we've included \$300,000 for the state energy plan. We also reduced \$81 million in debt service payments, retirement payments, and health premium payments in working with the Ways and Means committee.

"In working with the Public Safety chair, we've added two positions for the State Fusion Center and \$1.5 million for repair and maintenance for Homeland Security office, Hawaii State Veterans Cemetery, Hawaii Operations Center, and additional buildings statewide.

"In working with the Education chair, we've added \$2.8 million for the Hawai'i Keiki program; \$1 million for early college; \$1.1 million for alternative teacher route programs; \$1.5 million for complex area superintendents professional development for special projects fund; and \$1 million for Title IX training for equity specialists, principals, and complex area superintendents; \$100,000 for a public library land pilot project; and \$800,000 for hard-to-staff and National Board certified incentives.

"In working with the CPH chair, we've added \$3.8 million for Kupuna Care statewide, \$4 million for Kupuna Caregivers fund, \$3 million for new ambulances on Kaua'i and Hawai'i island, two positions for the Office of Language Access, and, as a result of our WAM site visit to the Big Island, we've added \$1.5 million for the Hilo Medical Center cardiac unit.

"In working with the Human Services chair, we've added \$4.4 million with \$6.6 million federal match to restore adult health Medicaid benefits, \$15.9 million for various homeless initiatives to provide a comprehensive and statewide solution, which provides funds for Housing First, Rapid Re-Housing, Family Assessment Center, outreach and civil legal services, property storage and debris removal, ohana zone pilot project, and for coordinated statewide homeless initiative.

"In working with the Labor chair, we've included two positions for the Hawai'i Labor Relations Board.

"In working with the Water and Land chair, we've added 10 positions and \$4.5 million for lifeguard services, operations, and improvements to state parks; \$1.2 million for state trails; \$1.4 million for ocean safety educational services; and \$5 million, working with the Ag chair and the Water and Land chair, for the Hawaii Interagency Biosecurity Plan. We've added five positions and \$3.1 million for DOCARE training academy dispatch center and safety enforcement at small boat harbors.

"And working with the Judiciary chair, we've added seven positions and \$1 million for the State Historic Preservation office.

"In working with the Transportation chair, we've also added \$824,000 for a new airport access road in Kahului, in addition to shuttle buses and operations and additional money for the consolidated rental car facility.

"In working with the Higher Ed chair and Majority Leader, we've added four positions and \$568,000 for the Center for Pacific Island Studies at UH Mānoa, \$200,000 for rat lung lab research at UH Hilo, eight positions and \$500,000 for health and safety and campus development at UH West O'ahu, and \$700,000 for the Hawai'i Promise Program for UH community colleges, eight positions for student success initiatives, and seven positions and \$1.5 million for repair and maintenance at the UH System.

"I really want to thank the committee members for all their hard work and I would like to acknowledge their efforts, time, and dedication as well as the efforts and hard work that the vice chair put into crafting the CIP budget. Also mahalo to Senate leadership and the members of the Senate, the subject matter chairs, in developing and discussing their priorities and making the hard choices, realizing that we need to live within our means. Lastly, I'd like to thank the Ways and Means staff for their hard work: committee chair Dane Wicker; budget chief Erin Conner and bills chief Duncan Osorio; and budget and bills staff Ardis Zhong, Alika Ke-Paloma, Derek Chan, Janos Palko, Lance Tashima, Robert Nishimoto, Moya Gray, Leiomalama Solomon, Sydney Hart, Ashley Kurisu, Chung Chang, and Weston Yap, and I'd also like to thank Dot Fujinaga, David Cho, and Tina Deitschman, if you can all stand and be recognized. Thank you, Mr. President."

Senator Kahele rose to speak in strong support of the measure as follows:

"Brief comments, Mr. President: I just would like to also thank the senator from Wahiawa, the Ways and Means chair, as well as the senator from Wailuku, the vice chair, and, as previously noted, the Ways and Means staff, who are here in this chamber today, for their incredible hard work to provide a balanced and well-thought-out budget for the state. The Ways and Means chair came up with innovative revenue-generating measures that will help close the gap on the overspending of the state as well as maximize taxpayer dollars to ensure that services that benefit our kupuna, that benefit Housing First and homeless programs, our K-12 education system, the University of Hawai'i, and our healthcare programs - like the \$1.5 million for the Hilo Medical Center's cardiac program – are great, great things that this state's budget does, so I'd like to thank the Ways and Means chair and look forward to voting in strong support of this bill. Mahalo."

Senator Keith-Agaran rose to speak in support of the measure as follows:

"I just wanted to echo some of the remarks of the WAM chair, but I also wanted to add my own personal thanks to members of my own staff: to my office manager, Susan Wong; Danielle Evangelista; as well as the session staff, Justin Fragiao and Pamela Ono. And I especially wanted to thank a guy who probably spent more late hours than I probably expected him to, but I'm glad he did, and that's Robert Nishimoto, who's already been introduced, if he could stand. He was the CIP specialist this year, and you should hang around because there's going to be more work as we go to conference. Thanks."

The Chair remarked:

"I'd just briefly say thank you to the Ways and Means chair, vice chair, and committee for their work, as well as to the staff for their hard work, and especially in the items described by the Ways and Means chair, really reaching, I think, in a very strong and positive way to affirm the goals that were set out by the Senate when we met and identified the priorities that we laid out. So, I thank you for following the roadmap that was put together back in December and early January and coming up with a product that really matches what we hoped to accomplish before we began this session. So, thank you very much."
