The Senate of the Thirtieth Legislature of the State of Hawai'i, Regular Session of 2019, convened at 11:32 a.m. with the President in the Chair.

The President announced that he had read and approved the Journal of the Sixteenth Day.

On behalf of Senate President Kouchi, Senator Taniguchi recognized and congratulated Illinois State Senator Toi Hutchinson and William T. Pound, and presented the following remarks:
