

TWENTY-SIXTH DAY

Thursday, March 7, 2019

The Senate of the Thirtieth Legislature of the State of Hawai'i, Regular Session of 2019, convened at 11:35 a.m. with the Vice President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Harimoto and Thielen who were excused.

The Vice President announced that she had read and approved the Journal of the Twenty-Fifth Day.

At this time, Senator Baker noted that it was the beginning of the celebration of the Celts in Hawai'i, which culminates with Tartan Day on April 6. Senator Baker further noted that The Saint Andrew Society of Hawai'i received Celtic Proclamations from Mayor Caldwell and Governor Ige, and that famous Celts in Hawaiian history included James Campbell and Archibald Scott Cleghorn. Senator Baker then recognized representatives of Celtic organizations in Hawai'i, who were present in the gallery: The Society of the Friends of Saint Patrick in Hawai'i, The Saint Andrew Society of Hawai'i, The Caledonian Society of Hawai'i, the Scottish-American Military Society of Hawai'i, the Celtic Pipes and Drums of Hawai'i, and the Hawaiian Scottish Association.

Senator Baker then remarked that it was the 19th Annual State Council on Developmental Disabilities Day at the Capitol, hosted by the Disability and Communication Access Board, Hawai'i Self-Advocacy Advisory Council, Hawai'i Waiver Providers Association, Hilopa'a Family to Family Health Information Center, Department of Health Developmental Disabilities Division, Assistive Technology Resource Centers of Hawaii, University of Hawai'i Center on Disability Studies, Community Engagement Branch of the Community Children's Council, Hawaii Disability Rights Center, and Special Parent Information Network. Senator Baker welcomed a number of the event participants, who were seated in the gallery, including individuals with developmental disabilities, family members, personal assistants, service providers, and other advocates from across the state, including 68 participants from the neighbor islands.

Senator Rhoads recognized Blane Sardinha, a special friend and longtime constituent, who was seated in the gallery.

Senator Ruderman welcomed Developmental Disabilities Day participants from Hawai'i island, who were seated in the gallery: from Hilo—Kaula Haumea, Gail Yoshige, Maurie Ortaleza, Paul Pascua, and Lisa Aiona; from Puna—Thijs Van den Berg; from Pāhoa—Mar Ortaleza and Ronald McBride; and from Kea'au—Maelisa Evangelista, Cheryl Obrero, Alyssa Marie Vierra, Justin Rossian Legaspi, Eli Macbroom-Fidler, and Brenton Wah-Yick.

Senator Nishihara introduced Sol Ray Duncan, a constituent and member of the Pearl City Neighborhood Board, who was present in the gallery.

Hopf, and Logan Mary Ditty; and from Kailua-Kona—Roy Corpuz.

Senator Ruderman also acknowledged Hawai'i island coordinator Jesse Floyd, who was present in the gallery.

Senator Kahele recognized Sean Galuteria, son of former State Senator Brickwood Galuteria, who was present in the gallery.

Senator Kim recognized Parents and Children Together, and presented the following remarks:

"Madam President, it's my pleasure to recognize Parents and Children Together, better known as PACT, which recently celebrated its fiftieth anniversary of service to the people of Hawai'i. PACT opened its doors in 1968 as the Parent Child Center in Kalihi, and from these very modest beginnings, PACT has grown to meet the needs of our community and today has 400 employees in 18 programs serving 15,000 people a year. The center became a federal Head Start Program 20 years after its founding and has succeeded in the years since thanks to continued support from its government and community partners.

"Today, PACT provides a very impressive range of educational and social services for our most vulnerable families and individuals. The first is early childhood education for pre-qualified parents on O'ahu and Hawai'i island: Early Head Start serves prenatal parents and infants from birth to three years while Head Start is for children ages three to five. Its domestic violence prevention and intervention services help individual families affected by domestic violence through Family Peace Center, a domestic violence shelter; Family Visitation Center, a transition house; and a Trafficking Victim Assistance Program. In the field of child abuse and neglect prevention and treatment, PACT offers comprehensive services to promote positive parenting and healthy child development. Its community-building and economic development efforts include programs geared toward the social, economic, and cultural well-being of individuals and families in need.

"We all know that government can't do it all, and organizations like Parents and Children Together have a vital role in providing holistic care to the needy so they can build a better future for themselves and their children. Celebrating 50 years is an achievement for any organization, and it is a testament to the strength and importance of community and those who have answered the call to help others. Here with us today, Madam President, are Ryan Kusumoto, our president and CEO; Dawn Kurisu, vice president of strategy and innovations; Ben Naki, vice president of early childhood education; Tina Porras-Jones, vice president of community-building programs. Please join me in thanking them and everyone at PACT for their exceptional service. Madam President, we wish them many more years of success."

At 11:48 a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:52 a.m.

The Chair having so ordered, Senator Moriwaki’s remarks read as follows:

“Madam President, with reservations and comments. The United States Army Corps of Engineers has been working with the State and City since 2001 to develop a plan to mitigate flooding in the Ala Wai Watershed in the event of a ‘once in a century’ storm. If such a catastrophic flood were to occur, over 3,000 structures, with over a billion dollars in structural damages alone could severely impact Honolulu’s urban core and Hawai’i’s economy. A 2004 25-year storm flooded Mānoa Valley and caused about \$85 million in damages.

“In an emergency appropriation last July, Congress appropriated \$345 million to plan and construct a flood risk management system, but only if we came up with a local sponsor—either the state or the city—and matching funds of \$125 million. S.B. 77 provides for the local match.

“But the project has not sufficiently engaged community members directly affected by the flood risk management measures. Over a hundred members of the public who live or work in Mānoa, Makiki, Pālolo, McCully/Mō’ili’ili, and Waikīkī oppose going forward with the project. They feel excluded from the planning process. Neighborhood boards in and around the watershed in Mānoa, Makiki, Pālolo, McCully/Mō’ili’ili, Ala Moana/Kaka’ako, and Diamond Head/Kapahulu/St. Louis Heights have adopted or are considering adopting resolutions calling for more public involvement and even for a halt to the State funding of the project.

“Madam President, I believe we can mitigate the flood risk in the Ala Wai watershed while addressing community concerns. We can preserve and restore the surrounding ecosystem while minimizing adverse impacts to the affected properties. During our Ways and Means Committee hearing on S.B. 77, the State, the City and County, and the Army Corps personnel committed to engaging with the community on project design and to communicating status updates to the public. They committed to consider preserving schools and other public institutions with cultural or historical significance, addressing the concerns of private property owners to minimize adverse impacts of the project, and finding opportunities to preserve and restore the Ala Wai ecosystem. University faculty with expertise in engineering, planning, hydrology, climate change, and landscape architecture have since offered their expertise to work on this project if it is approved.

"Given these commitments and for the long-term safety of our community, I believe we should move S.B. 77 forward at this time."

At this time, Senator Dela Cruz rose to recognize bills section staff members of the Committee on Ways and Means, who, under the leadership of committee clerk Dane Wicker and bills chief Duncan Osorio, reviewed all Senate bills for appropriate re-referral, reviewed all testimony submitted, attended hearings held by subject matter committees, and monitored all bills coming from those committees to the Committee on Ways and Means.
