FORTY-FIRST DAY

Friday, March 29, 2019

The Senate of the Thirtieth Legislature of the State of Hawai'i, Regular Session of 2019, convened at 11:35 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Fevella and Kim who were excused.

The President announced that he had read and approved the Journal of the Fortieth Day.

Senator Shimabukuro welcomed guests from Boys & Girls Clubs of Hawai'i, who were present in the gallery: clubhouse director Kekoa Fernandez and student Devaughn Redd from the Nānākuli NFL YET Boys & Girls Club; Claudia "Lala" Fernandez, regional director – Leeward; and from the Wai'anae Boys & Girls Club—students Lei-Shell Kapihe and Loleina Kamaka, Kekaula Tupua, youth development director – teens, and Kaui Mead, staff member.

Senator Keohokalole recognized State Representative Della Au Belatti, who was seated in the gallery.

Senator Keith-Agaran welcomed guests from Boys & Girls Clubs of Maui, who were present in the gallery: students Naomi Farnsworth, Tahiti Ahsam, Lynnea Lopez, and Franco Melgar; Mandy Trella, director of special events and marketing; Stephen Bennett, director of operations; Kelly Pearson, chief executive officer; and Jamee Palomique, Central Club director.

Senator Inouye recognized Councilmember Tim Richards of the Hawai'i County Council, who was seated in the gallery.

Senator Kahele honored the 2019 Boys & Girls Club of Hawaii Youth of the Year finalists, and presented the following remarks:

"Colleagues, today we have the honor of recognizing five special individuals: the finalists for the 2019 Boys & Girls Club of Hawaii state Youth of the Year. The annual Boys & Girls Club's Youth of the Year program offers exceptional teens the opportunity to be recognized for choices and positive behavior that warrants the opportunity to celebrate this. The premier character and leadership program celebrates club members' service to club, community, and family; academic performance; ethical values; life goals; poise and public speaking ability. The program fosters young people's personal growth and leadership qualities.

"Our first Youth of the Year honoree is Kiana Kaneshiro. Kiana is from my district in Hilo, Hawai'i, and has been a member of the Boys & Girls Club for four years. She is an active member of her local clubhouse and actively participates in club programs and activities. Kiana is a high school freshman who maintains a 3.5 grade point average. She is a member of her school's judo and wrestling teams and participates in the Japan club, student council, and as a Special Olympics volunteer. She also volunteers at her church's monthly food drive and spends her summers cooking and serving hot meals to the needy in her community. Kiana, your servant leadership is a shining example for many in our community. Congratulations on your hard work and best of luck representing Hilo and Hawai'i island in the Youth of the Year competition. I would now like to pass the microphone to the senator from Central Maui."

Senator Keith-Agaran rose to present the following remarks:

"I'm pleased to introduce to you the Maui Youth of the Year finalist, Chassen Kosi-Cortez. Chassen is a member of the Boys & Girls Club of Maui – Central Clubhouse and has been

participating in club programs for seven years. At his local clubhouse, he is an active participant in the Keystone Club, Power Hour, and various club sports. Chassen is a sophomore at Maui High School and maintains a 4.0 GPA. He's very active in the community and volunteers regularly with his church and donates his personal time to providing basic needs to those in the community who are less fortunate. Chassen, on behalf of the Maui Senate delegation—Senator English, Senator Baker, and myself—we wish you the best of luck in the competition. I now recognize my colleague from Senate District 12."

Senator Moriwaki rose to present the following remarks:

"I have the distinct pleasure of recognizing another of our Youth of the Year finalists, Anissa Ortiz-Esquivel. She represents the Boys & Girls Club of Hawai'i-Spalding Clubhouse in my district, where she has been a member for five years. Anissa participates in many community service projects through the club's Leaders in Training (LIT) program. She also participated as a junior staff member at the clubhouse, where she assisted in running mentorship programs for youth aged seven to ten. Anissa is a senior at Kaimuki High School and is gaining college credits through the dual credit program at Kapi'olani Community College. Anissa has impressed many with her leadership skills and dedication to service. Through her participation with the LIT program, she has found many ways to give back to the community and impact others through servant leadership. Her advocacy and success will surely inspire all youth who pass through the doors of their local Boys & Girls Club. Anissa, on behalf of my colleagues in the Senate, congratulations on your hard work and for being a finalist in the Youth of the Year competition. Aloha.

"Mr. President, colleagues, on behalf of Senator Kim, who couldn't be here, I also have the honor of introducing Azana Queen, another Youth of the Year finalist. Azana is representing the Fort Shafter Youth Center, where she has been participating in the program for three years. At the Fort Shafter Youth Center, she is actively involved in the Keystone Club, the Pacific Teen Panel, and the Youth Leadership Forum. Azana is a junior at La Pietra Hawaii School for Girls and maintains a 3.76 GPA. She is enrolled in a number of advanced placement courses where she earned college credit and took first place at the 2019 La Pietra American Mathematics Competition. Azana is active in the community and volunteers regularly with the Red Cross Club and the National Honor Society. Colleagues, please join me in recognizing Azana Queen. Thank you. I now turn the mic over to the senator from Salt Lake."

Senator Wakai rose to present the following remarks:

"Colleagues, our last and illustrious finalist is back for her second year in a row competing in the Youth of the Year competition. Ladies and gentlemen, welcome Hannah Bethard. Hannah's here representing the Boys & Girls Club of Hawaii -Joint Base Pearl Harbor Hickam. Hannah has been a member of the Boys & Girls Club for four years. She immerses herself in everything that the club has to offer: more specifically, the SMART Girls program (it's an all-female leadership program). Hannah is a junior who is enrolled in rigorous academic courses, such as advanced placement literature, psychology, and statistics. She also participates in her school's Navy Junior Reserve Officers' Training Corps (JROTC) and has achieved the rank of chief petty officer. Hannah has impressed many with her advocacy for mental health issues. She selflessly gives her time to take on and talk to her peers, members of the club, and other social groups about the importance of seeking help and understanding best mental health practices. Hannah, on behalf of my colleagues, congratulations on being a finalist and best of luck in your future aspirations. Now, I'd like to pass the baton over to our senator from Hilo."

Senator Kahele rose and stated:

"Colleagues, before we end, I would like to recognize some special guests who have also joined us in the gallery. With us today are students who also participated in the Youth of the Year competition on their respective islands. As you know, this is a tough competition and all of the students who compete are outstanding individuals, so please give a round of applause. If you are a Youth of the Year finalist, please stand, and if you participated in the program, please stand to be recognized. Also in the gallery are Gail Hamasu, the resource development director; Valentina Martinez, the grants manager; and from my very own island, Hilo, Hawai'i, the Boys & Girls Club of the Big Island chair Tonya Ozone. Can you please rise, and welcome to the Hawai'i State Senate! Thank you, Mr. President."

I'd also like to thank my colleagues, especially my Big Island colleagues, who have had unwavering and unified support for my community in our time of need. Thank you."

Senator Kahele rose to speak in support of the measure as follows:

"I would also like to enter into the Journal the comments of my colleague from Puna as if they were my own, and I'd also like to add and thank the Senate Ways and Means chair as well as the House Finance chair and the House leadership as well as the members of this chamber who, within a week of the eruption, flew to Hawai'i island at a moment's notice (to include most of you—I'm including you, Mr. President) to see what was happening in lower Puna. Little did we know of the extent of the damage that would come after that visit, so very, very grateful to the House and Senate, and I know Hawai'i island stands with Senator Ruderman and Puna. Mahalo."

The Chair remarked

"I'll just say my opening statement on Opening Day was the relief for the Big Island, so I'm excited that I've gotten at least one thing right on Opening Day. So, to the WAM Chair, the Big Island contingent, and the members, thank you for your hard work; as we go through the last 20 days, we'll see how many other things come to pass."
