### FORTY-SECOND DAY

### Monday, April 1, 2019

The Senate of the Thirtieth Legislature of the State of Hawai'i, Regular Session of 2019, convened at 11:35 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Harimoto and Ruderman who were excused.

The President announced that he had read and approved the Journal of the Forty-First Day.

At this time, Senator Wakai recognized the U.S. Small Business Administration's Small Business Award recipients, and presented the following remarks:

"Good morning, everyone, esteemed colleagues. We are here today to honor winners of the 2019 Small Business Administration's Small Business Awards. We have six of them with us here on the Senate floor. SBA, or the Small Business Administration, is a federal agency whose mission is to aid, counsel, and protect small-business concerns, preserve free competitive enterprise, and bolster our economy. Small businesses don't necessarily mean small impact, however; small businesses are a source of strength for our economy, and it is important that we recognize their significant contributions. I'd like to yield the floor to the senator from Moanalua Gardens to begin our presentations."

Senator Kim rose to present the following remarks:

"I'm very pleased to start off this morning with our introductions, first starting out with Rolf Klein and Alvin Bongolan. They're of Hawaii Energy Systems. These two are this year's recipients of the Small Business Person of the Year award. This award recognizes an individual with the best overall success in business, but, as you can see, this year we're privileged to have two winners. For the past 13 years, Hawaii Energy Systems has served as a leader in the building automation and energy management control systems industry in Hawai'i and the Pacific Rim. With a Small Business Administration 504 Loan, HES built a strong financial foundation and provides quality jobs for nearly 50 skilled employees as well as supports internships to prepare promising workers for Hawai'i's technology industries. The company's work can be seen all over the islands, including office buildings in downtown Honolulu, in O'ahu and Big Island hospitals, hotels across the state, public schools, the University of Hawai'i, military bases, and retail buildings, such as Pearlridge Center. These installations have saved money and increased comfort, productivity, and safety, making the islands one step closer to achieving energy efficiency. Join me, members, in congratulating Rolf and Alvin, Small Business Persons of the Year. Thank you. Mr. President, I now yield the floor to the senator from Hilo."

Senator Kahele rose to present the following remarks:

"I'd like to recognize the Small Business Advocate of the Year, and that would be Mary Begier from Hilo, Hawai'i. Thank you, Mary. Colleagues, Mary is this year's recipient of the Small Business Advocate for Business & Industry, an award which honors individuals who advocate and support small businesses and who understand the critical role of these businesses and how they play in our economy. For over 30 years, Mary has tirelessly advocated and fought for our small-business community. She has dedicated her time and energy to leading efforts to improve the business environment to create a place where mom-and-pop businesses, minority, women-owned, and veteran-owned small businesses could thrive. As a

successful business owner herself, Mary serves on elected boards and appointed task forces, as leadership in chambers, and on appointed boards that are committed to improving the economic outlook and lifestyle for our community. She is a veteran, a real-estate entrepreneur, and a business leader who has broken barriers in business, for women in business, and for veterans. Her involvement has included the Hawai'i Island Chamber, the Rotary, the Honolulu Board of Realtors, the Banyan Drive Redevelopment Authority, and many other organizations. Congratulations, Mary. I'd now like to yield the floor to the senator from Kaka'ako."

Senator Moriwaki rose to present the following remarks:

"I'd like to introduce Max Yoshikawa of McKinley Car Wash and this year's recipient of the SBA Family-Owned Business of the Year award. This award honors a family-owned and operated business with more than a 15-year history and has passed ownership and operational management from one generation to the next. McKinley Car Wash is a full-service car wash, gas station, and convenience store that has served guests from the same location on Kapi'olani Boulevard since 1964. Today, this three-generation family business cleans and fuels more than 550 cars, seven days a week, by a team of 60 fulltime employees. One of the founding brothers who is in his 93rd year continues to talk story with his long-time customers while other family members, sons, son-in-law, and grandsons keep the legacy of service alive. Keeping up with the changing times and need for convenience, the Yoshikawas offer fuel, tire, and oil changes, safety checks, as well as car washing. Even in the tight labor market, McKinley retains employees through training and benefits such as paid vacation and 401(k) benefits. The car wash may be the last business of its type on the Kapi'olani corridor, and the high-quality service and family touch keep the customers lining up and, I hope, they will continue for a long time to come. Congratulations to the Yoshikawas. Thank you, and I now yield the floor to the senator from Kāne'ohe."

Senator Keohokalole rose to present the following remarks:

"Colleagues and guests, it's my pleasure this morning to introduce Omar Sultan, co-founder of Sultan Ventures and one of this year's recipients of the Small Business Advocates for Innovation award. Thanks to their work, Omar and Tarik have made it possible for Hawai'i innovators to compete nationally and internationally. Congratulations. Tarik is up in the audience; can he please stand and be recognized as well? Once again, congratulations, Omar and Tarik, and thank you for all your work. Mr. President, I'd now like to yield the floor to the senator from Wai'anae."

Senator Shimabukuro rose to present the following remarks:

"On behalf of Senator Harimoto, I'd like to introduce Naomi Masuno, vice president and channel sales manager in the retail lending division of Bank of Hawaii. She is this year's recipient of the Makana Ho'okō no Ke Ola, or the SBA Special Award for Lifetime Legacy. For over 25 years, Naomi has constantly demonstrated her true passion for championing the cause of small business and their success. Her commitment to assist small business owners and improve the small business climate in Hawai'i is truly exceptional. As a prominent small business specialist with Bank of Hawaii, she is an enthusiastic organizer, speaker, and promoter for workshops and forums with numerous organizations, including SBA, SCORE, Hawaii Pacific Export Council, Department of Transportation, veteran and Wounded Warrior Project, and more. An ardent advocate for access to capital, she's been among the top SBA lending officers in the state, connecting small business owners with consulting support, training, and financing tools.
