Wednesday, April 19, 2023

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2023, convened at 11:39 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

We'd like to thank our esteemed member, our Judiciary chair, for passing this measure over to the House, which it did see its final adoption in the judiciary in the House. And this measure is in support of the significant gap under existing law as out-of-state victims are prohibited from filing restraining order petitions, even if the offense occurred in the state. This closes the gap to ensure that all persons have access to justice, and I ask my colleagues for support of this measure. Thank you, Mr. President and colleagues."

"You know, at a time when we have hundreds and hundreds of vacant positions, it doesn't make any sense to me to reduce the pay that we give to state employees, and it wasn't that many years ago that we made a major adjustment to the retirement side of post-employment benefits, where we reduced the average pension by about 30 percent, so I think it's going the wrong way. I think we've gone as far as we can realistically go and continue to expect to get good employees. Mahalo."

Senator Fevella rose to speak in strong opposition to the measure as follows:

"Colleagues, we're having a difficult time hiring and retaining talent in state jobs. It is a well-known fact that we may not offer the best pay in some of our jobs that we have here in the state, but the state is among the best for employing and having and offering attractive benefits. The Department of Human Services report that there is a rate of 23 percent of vacancies for nearly 4,000 vacancy positions. How are we supposed to appeal to the new hires when we're cutting back the very benefits that makes us appealing and attractive for work? I ask my colleagues to strongly oppose Senate Bill 1314, and thank you, Senate President. Mahalo and God bless." Senator Moriwaki rose to speak in support of the measure as follows:

"I understand the concerns and the vacancies we have and incentives, but this bill addresses spousal Medicare reimbursement of future retired employees. I ask my colleagues to support this."

Senator Dela Cruz rose to speak in support of the measure as follows:

"What this does is clean up what was originally passed when we did civil service reform quite some time ago. This is for the Part B section of the spouse benefit. Currently, when you retire, for new employees, their spouse is not covered with health benefits, so this tries to clean this up.

"If we're really trying to get better employees and more employees, what we should be focusing on is pay differentials, reclassifications—not necessarily this. I don't think this actually solves the problem of trying to attract new employees. Thank you."

Senator Kidani stated that purple represents a combination of all service colors, including Air Force blue, Army green, Navy blue, Marine red, and Coast Guard blue. Senator Kidani further explained that there are 56 O'ahu public schools on the Department of Education's list of militaryimpacted schools, or schools that have significant numbers of military dependent students on their campuses. Senator Kidani then explained that, thanks to the efforts of the Military Interstate Children's Compact Commission and Joint Venture Education Forum, deserving students and families are provided the support they need to navigate military-impacted transitions and further their studies. Senator Kidani expressed her gratitude to the dedicated officers and servicemen and -women whose efforts to serve their communities, schools, and students has a tremendous impact on those students' academic success.
