THIRTY-SECOND DAY

Thursday, March 14, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 11:34 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Thirty-First Day.

At this time, Senator Lee welcomed a group of eighth graders from 'Iolani School on a civics and education field trip who were seated in the gallery. Senator Lee then acknowledged Martha Saenz from the National Conference of State Legislatures (NCSL), who was present in the gallery. Senator Lee noted that Ms. Saenz had been a resource for the state Senate and that she was joining them on the 50th anniversary of NCSL.

Senator Shimabukuro introduced the Stewart 'ohana, Seated in the gallery were Georgia, Todd, and their son Fritz. Senator Shimabukuro explained that Todd Stewart had last been in Hawai'i with his high school church group in 1957, prior to statehood.

The Chair commented to Senator Kanuha that 1957 had been a very good year.

Senator DeCoite recognized Mr. Jacob Janikowski, a constituent from Lāna'i and intern who was shadowing her that day. Senator DeCoite noted that Mr. Janikowski was a freshman at Northern Arizona University who was home for spring break and spending a day on O'ahu to get a firsthand look at the legislative process. Accompanying him in the gallery were members of Senator DeCoite's staff: office manager Rebecca Crall and Madison Kalahui.

I've enjoyed getting to know him better over the past few months through hearing his personal statement and responses to our questions during the AEN committee hearings, to his regular visits to my office to check with my staff and me on our needs. Colleagues, here's a brief quote from Dexter's questionnaire that I believe truly captures his positive, can-do attitude. He wrote, 'The greatest attributes I bring to the sector are my abilities to approach problems with realistic optimism; collaborate effectively; and, through calculated risk-taking, achieve desired goals.' I've seen Dexter in action and can wholeheartedly agree, so, colleagues, I ask you to join me in supporting G.M. 593. Mahalo."

Senator Richards rose to speak in support of the nominee as follows:

"I fully endorse Mr. Kishida for the position as I've gotten to know him quite well during this session, and he brings that undying optimism from the department that we need to have in agriculture. So I again ask my colleagues for their support."

S.R. No. 144:

By unanimous consent, action on S.R. No. 144, entitled: "SENATE RESOLUTION AMENDING THE RULES OF THE SENATE TO REQUIRE EACH MEMBER TO PLANT AT LEAST ONE FOOD TREE ON STATE LAND," was deferred until Friday, March 15, 2024.

At this time, Senator Fevella rose to speak on a point of personal privilege as follows:

362

"Today, colleagues, I had the privilege in going to Ka'imiloa Elementary School. It was probably the second school that invited me to read and share my experience on not only being here at the Capitol but also being a community leader. I shared with them that titles and accolades in this building means nothing without hard work and the understanding of why we're here. We had a good discussion on one of the main topicslegalizing recreational marijuana. These fifth graders were very concerned of their welfare and health going forward, because I explained to them about marijuana being a gateway-while growing up-being a gateway to higher drugs and higher crime. One of the students stood up and told me, 'Not just crimedeath.' A fifth grader told me that in the classroom. It was hard for me to understand for us to move this recreational marijuana bill and be reckless with other people's lives because we think it's okay. It wasn't okay in the '60s; it wasn't okay in the '70s; it wasn't okay in the '80s. What makes you think decades and decades of people going to jail and serving time for marijuana-that now, it's okay? 'It's okay, guys. I'm sorry that you had spent time in jail-because now, it's legal.' It's not okay for fifth graders in my community, and I will do everything in my power to not get this passed. And if we do, colleagues, I'll make sure-I'll put out a bill next year that all legislators have to go through some kind of sobriety test before we start session in making laws for our community, to ensure that we are not under any influence while we are doing the people's work. Thank you, Senate President."

Senator Shimabukuro reminded the members of the collection of menstrual products for the Ma'i Movement in honor of International Women's Day. Senator Shimabukuro explained that donations of new menstrual products could be dropped off at her office or at the office of Representative Rachele F. Lamosao until the following midday.

Senator Inouye announced that the members had been asked to wear blue in honor of Ocean Day the following day.

Senator DeCoite reminded the members that Easter baskets were being collected for a good cause and that March 26th would feature the Easter bunny and chick.

Senator Lee noted that partners at NCSL who were visiting for the organization's 50th anniversary had provided the Senate with pins meant for members of the organization, which were on their desks. Senator Lee then invited the members to a lunch hosted by NCSL in Conference Room 329 following session.

The Chair made the following comments:

"I didn't intend to say anything, but in all seriousness, Senator Shimabukuro, thank you for the announcement. It's been almost two years that, in all restrooms controlled by the Senate, we are providing free menstrual products. Our clerk, Carol Taniguchi; and the deputy sergeant-at-arms, Park; and those who have assisted them, they have made sure that we have replenished supplies. The clerk actually found a local producer who made the plastic dispensers at half the cost that they were securing them from the mainland while using a local business. And two years ago, when this started, part of the goal was to normalize the conversation, and the fact that we are here talking about it and advertising and seeking to continue to help those who may be in need of menstrual products and just don't have the economic ability to do it, I think, shows how far the Ma'i Movement has gone in the last two years here in Hawai'i. So, again, thank you."
