THIRTY-FIFTH DAY

Tuesday, March 19, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 11:33 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Thirty-Fourth Day.

At this time, Senator Keohokalole welcomed residents from District 24 who had joined his office for a constituent field trip that day. Senator Keohokalole explained that the group had sat in on the Committee on Commerce and Consumer Protection's hearing that morning and had met with the lieutenant governor and would also be going on a tour of the Capitol and eating lunch. Present in the gallery were Alika Rivera, Kailua neighborhood board chair Bill Hicks, Debra Bohol, Annette Chiyo Tashiro, Donald Sakamoto, Ann Elizabeth Lemke, Sean O'Connor, Katrena and Randy Kennedy, and Ms. Lemke's companion Daisy.

Senator Lee introduced members of the Planned Parenthood Teen Council who were seated in the gallery: Emi, Flora, Gray, Delilah, Mack, Vivienne, Cerese, and Anela.

notably in creating a course on implicit bias, microaggressions, and stereotypes. Outside the classroom, she is a Hawaii State Teacher Fellow, a fellow of both the National Education Association and Hawaii State Teachers Association Early Leadership Institute, and a liaison for the Hawaii Association of Filipino Educators.

Senator Inouye rose to present the following remarks:

"Christopher Pike, an esteemed fifth-grade teacher, has dedicated the last decade to shaping young minds at Honaunau Elementary and Chiefess Kapi'olani Elementary. His teaching philosophy is deeply rooted in place-based and culturally relevant education, aiming to amplify student voices and foster a deep connection with their environment and heritage. Christopher's commitment to environmental stewardship and education was nationally recognized in 2021, when he was honored as the National Educator of the Year for Environmental Stewardship by the National Park Trust. His innovative teaching methods and dedication to excellence in science education led to his nomination as a finalist for the Presidential Award for Excellence in Science Teaching in 2022.

Senator DeCoite rose to present the following remarks:

"It is with great pride and aloha that I acknowledge the 2024 Hāna-Lahainaluna-Lāna'i-Moloka'i Complex Area Teacher of the Year, David 'Kawika' Gonzales.

"David 'Kawika' Gonzales, a respected educator at Kaunakakai Elementary School on Moloka'i, has dedicated the last 23 years to teaching fifth grade at his elementary alma mater. His leadership in STEM was recognized with the Czechowicz Award by the Maui Economic Development Board in 2019 and a finalist position for the Burniske Award in 2021. Beyond his classroom responsibilities, Kawika serves as the computer science coordinator, math chairperson, and is a key player in the school's leadership team. Kawika and his students have been spotlighted in local media and local conferences for their groundbreaking work in virtual reality and computer science.

"I now yield the floor over to Senator Kidani."

Senator Kidani rose to present the following remarks:

"On behalf of Senate President, I would like to recognize Kara Kitamura, Teacher of the Year for our Kaua'i District Kapa'a-Kaua'i-Waimea Complex.

"Kara Kitamura has dedicated 26 years to nurturing the minds of future health professionals. Senator Dela Cruz rose to present the following remarks:

"I'd like to recognize Brittnie Caraulia as our 2023 Hawai'i State Counselor of the Year.

"Brittnie Caraulia has been a devoted school counselor at Helemano Elementary in Whitmore Village since 2015. She has been pivotal in implementing schoolwide social—emotional learning initiatives. Her collaborative efforts with teachers and administration are evident in the integration of social—emotional learning into the core curriculum and the establishment of an effective referral system for data-informed decision-making. Brittnie's membership in local and national chapters of the American School Counselor Association further underscores her commitment to the counseling profession. Brittnie's deep care for her school community and her passion for nurturing and supporting her students highlight her as an outstanding school counselor, truly deserving of this accolade.
