## TWENTY-FIFTH DAY

# Tuesday, March 4, 2025

The Senate of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 9:46 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Twenty-Fourth Day.

At this time, Senator San Buenaventura noted that the following day would be the Hawai'i State Council on Developmental Disabilities' (DD Council's) 25th Annual Day at the Capitol, a celebration of the community contributions made by individuals with developmental disabilities. Senator San Buenaventura explained that March was Developmental Disabilities Awareness Month, a nationwide campaign dedicated to raising public awareness of the abilities, strengths, and achievements of individuals with developmental disabilities. Senator San Buenaventura added that selfadvocates from across the state had chosen their own theme to mark the occasion: "Respect yourself and all people with disabilities." Senator San Buenaventura announced that the following day, attendees of the event would have the opportunity to engage directly with their district state legislators and deepen their understanding of the legislative process as they advocated for issues affecting their communities. Senator San Buenaventura encouraged the members to visit the resource table that would be on the fourth floor, noting that their engagement made a difference in advancing inclusivity and accessibility for all. Senator San Buenaventura then introduced the advocates and self-advocates of the DD Council who were seated in the gallery, including Daintry Bartoldus and Sierra Whiteside, before reminding the members to wear orange the following day.

Senator Kanuha recognized advocates from West Hawai'i from the Arc of Kona who were present in the gallery and requested that the list of their names be entered into the Journal, and the Chair so ordered. Senator Kanuha also welcomed Dennett Sonoda and "Aunty Cookie" Ford from Full Life Hawai'i, who were seated in the gallery.

The Chair having so ordered, the names of the advocates from the Arc of Kona read as follows:

- (2) The sum appropriated and authorized for expenditure for fiscal year 2026-2027 pursuant to this section shall be derived solely from moneys received by the State as a gift or grant from private sources.

The sums appropriated shall be expended by the stadium authority of the department of business, economic development, and tourism for the purposes of this Act; provided that if the new aloha stadium entertainment district project is terminated before completion, then all moneys remaining in the stadium development special fund that are not expended or encumbered shall lapse to the general fund."
