The Senate Committees on Health and Human Services and Education and Technology and the House Committees on Health, Education, and Human Services and Housing will hold a joint informational briefing for the purpose of giving State agencies, providers, and consumers an opportunity to discuss the issues and budget requests relating to the Felix Consent Decree. The State Departments of Education and Health, the State Attorney General's Office, and the Felix Operational Management Team will present a brief overview of the Felix Consent Decree and the State's response to it. Provider and consumer representatives of the State Community Children's Council will speak about some of their experiences relating to the Consent Decree. The Office of the State Auditor will discuss the findings and recommendations

contained in State Auditor's Report No. 98-20, "Assessments of the State's Efforts Relating to the Felix Consent Decree."

A question and answer period for legislators will follow these presentations. Questions from the public may be asked by writing such questions on index cards. The Chairs will ask these questions, time permitting.
