# A BILL FOR AN ACT

RELATING TO BAIL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 804-2, Hawaii Revised Statutes, is  
2 amended to read as follows:  
3 "§804-2 Unclaimed bail money. All money deposited by way  
4 of bail or bond, in any proceeding before any court, [~~which~~  
5 that has not been declared forfeited, and not claimed within two  
6 years after the final disposition of the cause of action in  
7 which the money was deposited, shall ~~[, after due notice to the~~  
8 ~~person who has deposited the same, by the then custodian of the~~  
9 ~~money and upon order of court, be paid over to the director of~~  
10 ~~finance of the State as a state government realization.] be  
11 presumed abandoned under chapter 523A."~~

12 SECTION 2. This Act shall apply to all bail money held at  
13 the time of its enactment, or at any time thereafter.

14 SECTION 3. Statutory material to be repealed is bracketed  
15 and stricken. New statutory material is underscored.

16 SECTION 4. This Act shall take effect upon its approval.




