
HOUSE CONCURRENT RESOLUTION

REQUESTING THE HOUSE AND SENATE COMMITTEES ON HUMAN SERVICES TO
CONDUCT A JOINT STUDY OF THE DEPARTMENT OF HUMAN SERVICES'
REUNIFICATION AND KINSHIP PLACEMENT POLICIES AND PROCEDURES

1 WHEREAS, infants and children removed from their parents
2 because of abuse or neglect deserve the diligent care and
3 protection of the State; and
4

5 WHEREAS, the Department of Human Services has reported a
6 number of cases of repeated abuse directed to harmed children
7 reunified with the parent who perpetrated the harm; and
8

9 WHEREAS, the Hawaii Foster Parent Association has reported
10 a number of instances in which infants and children have been
11 harmed further because of inappropriate placement with kin; and
12

13 WHEREAS, the Office of Hawaiian Affairs and other Hawaiian
14 advocacy groups have expressed concerns about the
15 over-representation of Native Hawaiian children in the child
16 welfare service population and the lack of appropriate family
17 and kin placement for these children; and
18

19 WHEREAS, social workers, guardians ad litem, child
20 psychologists, public health nurses, pediatricians, child
21 advocates, and judges have not had the opportunity to describe
22 to the State the impact that the Department of Human Services'
23 current reunification and kinship placement policies have on
24 children; and
25

26 WHEREAS, the research literature on reunification and
27 kinship placement, although limited in general applicability to
28 Hawaii, suggests a number of safety issues relating to these
29 policies; now, therefore,
30

31 BE IT RESOLVED by the House of Representatives of the
32 Twenty-third Legislature of the State of Hawaii, Regular Session
33 of 2006, the Senate concurring, that the House and Senate



1 Committees on Human Services are requested to conduct a joint
2 study of the impact that the Department of Human Services'
3 current reunification and kinship placement policies and
4 procedures have on harmed infants and children; and
5

6 BE IT FURTHER RESOLVED that, as part of their joint study,
7 the House and Senate Committees on Human Services are requested
8 to solicit testimony from social workers, guardians ad litem,
9 child psychologists, public health nurses, pediatricians, child
10 advocates, and judges regarding the impact of the Department of
11 Human Services' reunification and kinship placement policies on
12 harmed infants and children; and
13

14 BE IT FURTHER RESOLVED that, as part of their joint study,
15 the House and Senate Committees on Human Services are requested
16 to solicit the testimony of the Director of Human Services, the
17 Director of Health, and of representatives from the following:
18 the Hawaii Foster Parents Association; the Volunteer Guardian Ad
19 Litem Program; the Hawaii Family Forum; Legal Aid Society of
20 Hawaii; the National Association of Social Workers, Hawaii
21 Chapter; Hawaii Behavioral Health; the Sex Abuse Treatment
22 Center; and other organizations serving the child welfare
23 population; and
24

25 BE IT FURTHER RESOLVED that the Director of Human Services
26 is requested to provide the following summarized data, or an
27 explanation of why the requested data is unavailable, for fiscal
28 years 2005 and 2006:
29

- 30 (1) An unduplicated count of the children entering the
31 child welfare services population for the first time,
32 classified by gender, ethnicity, and type of harm
33 suffered, e.g., neglect, harm, physical abuse, sexual
34 abuse, or drug exposure;
35
- 36 (2) The number of cases closed in the fiscal year,
37 classified by the number of days the case was active
38 and the type of closing, e.g., adoption by kin or
39 non-kin, guardianship by kin or non-kin, long-term
40 foster placement, or reunification with parents;
41
- 42 (3) An unduplicated count of the number of children
43 re-entering the child welfare services population
44 subsequent to a case closing, classified by gender,



1 ethnicity, and type of harm, with a description of the
2 type of closing and of the type of harm that prompted
3 the child's re-entry into the child welfare system;

4
5 (4) The number of subsequent placements, classified by
6 gender, age, ethnicity, and type of placement, for all
7 children re-entering the child welfare system
8 subsequent to a case closing, except children
9 reunified with parents;

10
11 (5) The number of monitoring visits made by social workers
12 for each month the case was active for all children in
13 the child welfare system population;

14
15 (6) The number of supervised parental visits made during
16 each month the case was active for all children in the
17 child welfare system population;

18
19 (7) For all children in the child welfare system
20 population, the number of placements that have been
21 subject to an administrative review and the results of
22 the reviews;

23
24 (8) For current active cases, the total number of children
25 involved, as they are identified in court documents,
26 the number of caseworkers serving these children, and
27 copies of any grievances, complaints, or
28 recommendations regarding active cases that have been
29 received by the Department of Human Services from any
30 source, with any personal identifying information
31 redacted; and

32
33 (9) Complete copies of all research relating to
34 reunification and kinship placement that the
35 Department of Human Services administrators personally
36 have reviewed; and

37
38 BE IT FURTHER RESOLVED that the Committees are requested to
39 report their findings to the Legislature no later than twenty
40 days before the convening of the Regular Session of 2007; and

41
42 BE IT FURTHER RESOLVED that certified copies of this
43 Concurrent Resolution be transmitted to the Chairs of the House



1 and Senate Committees on Human Services, the Governor, and the
2 Director of Human Services.



