
HOUSE CONCURRENT RESOLUTION

REQUESTING THE HAWAII STATE BAR ASSOCIATION TO CONVENE A TASK
FORCE TO CONDUCT A STUDY ON WHETHER A FOURTH CIRCUIT COURT
SHOULD BE ESTABLISHED ON OAHU FOR THE KAPOLEI DISTRICT.

1 WHEREAS, approximately seventy per cent of the State's
2 population resides on the island of Oahu, and is served by the
3 first judicial circuit, comprised of twenty-five authorized
4 circuit court judges, and the remaining thirty per cent of the
5 State's population is served by the second judicial circuit
6 (Maui), with four circuit court judges; the third judicial
7 circuit (Hawaii), with four circuit court judges; and the fifth
8 judicial circuit (Kauai), with two circuit court judges; and
9

10 WHEREAS, the citizens of Central and Leeward Oahu,
11 representing twenty-two percent of the State's population and
12 thirty percent of the Oahu's population, have no dedicated
13 circuit court; and
14

15 WHEREAS, Act 110, Session Laws of Hawaii 2005, made an
16 appropriation for the design, construction, and equipment for a
17 new judiciary complex in Kapolei; and
18

19 WHEREAS, Act 110 grew out of the concern that the most
20 efficient way to provide equal access to justice, promote the
21 most effective delivery of legal services, and better serve the
22 needs of the entire population of Oahu is to construct a new
23 court complex in Kapolei; and
24

25 WHEREAS, the creation of an additional circuit, to be
26 designated the fourth judicial circuit, at the Kapolei court
27 complex, is a natural outgrowth of a new court complex in
28 Kapolei; and
29

30 WHEREAS, Kapolei has been designated as the "Second City"
31 to Honolulu and as such deserves each type of government
32 services, including a full-service court as an essential element
33 of a second city; and



1 WHEREAS, the Judiciary has expressed its desire to provide
2 a full service court operation, including a new juvenile
3 detention facility, at Kapolei appropriate to a major urban area
4 in order to serve the present and future needs of the growing
5 Kapolei region; and

6
7 WHEREAS, it is the policy of the Judiciary to ensure that
8 judicial services are convenient and available to everyone; and

9
10 WHEREAS, Act 110 appropriated \$95,000,000 for the Kapolei
11 court complex, which will be a full service court with circuit
12 court capacity to house the district, circuit, and family
13 courts; and

14
15 WHEREAS, a prudent policy in public spending is to ensure
16 that money spent on capital improvement projects will adequately
17 serve the public fifty years into the future, when balanced
18 against the amount of the expenditure and the public necessity
19 for the improvements; and

20
21 WHEREAS, the legal profession and the public should have
22 input in determining whether or not a fourth judicial circuit
23 should be created to serve Central Oahu, Windward Oahu, and the
24 Leeward coast communities with their burgeoning populations; and

25
26 WHEREAS, the Hawaii State Bar Association is ideally suited
27 to convene a task force to make recommendations to the
28 Legislature on whether to establish a fourth judicial circuit at
29 Kapolei; now, therefore,

30
31 BE IT RESOLVED by the House of Representatives of the
32 Twenty-third Legislature of the State of Hawaii, Regular Session
33 of 2006, the Senate concurring, that the Hawaii State Bar
34 Association is requested to convene a task force to study,
35 evaluate, and make recommendations on the creation of a new
36 judicial fourth circuit at Kapolei on Oahu; and

38 BE IT FURTHER RESOLVED that the task force be composed of
39 one representative from each of the following offices,
40 organizations, and entities:

43 by the Board of Directors of the Hawaii State Bar

- 32 Boards of Ko`olauloa, Kahalu`u, Kaneohe, Kailua,
- 33 Waimanalo, to be elected by those boards;

- 35 (14) One member representing collectively the Neighborhood
- 36 Boards of Hawaii Kai, Kulioulou-Kalani Iki,
- 37 Waiialae-Kahala, Kaimuki and Diamond Head/Kapahulu/St.
- 38 Louis, to be elected by those boards;

- 40 (15) One member representing collectively the Neighborhood
- 41 Boards of Palolo, Manoa, McCully-Mo`ilili,
- 42 Makiki-Tantalus, and Waikiki, to be elected by those

- 1 (16) One member representing collectively the Neighborhood
2 Boards of Ala Moana-Kaka`ako, Nu`uanu-Punchbowl, and
3 Downtown, to be elected by those boards;

- 5 (17) One member representing collectively the Neighborhood
6 Boards of Liliha/Alewa, Kalihi-Palama, Kalihi Valley,
7 and Aliamanu-Salt Lake, to be elected by those boards;

- 9 (18) One member representing collectively the Neighborhood
10 Boards of Aiea, Pearl City, Waipahu, Ewa, and Waianae,
11 to be elected by those boards;

- 13 (19) One member representing collectively the Neighborhood
14 Boards of Mililani-Waipio, Mililani Mauka/Launani
15 Valley, Wahiawa, and North Shore, to elected by those
16 boards;

- 18 (20) The general public, to be appointed by the Governor;

- 20 (21) The Hawaii State Senate, to be appointed by the Senate
21 President;

39 BE IT FURTHER RESOLVED that the task force determine
40 whether a fourth judicial circuit should be established at
41 Kapolei on Oahu, and:

- 1 (1) Determine the level of usage of court services on Oahu
- 2 in the various district, circuit (civil and criminal),
- 3 and family courts;

- 5 (2) Determine the present and projected population growth
- 6 for the Central, Leeward, Windward, and Honolulu
- 7 districts;

- 9 (3) Determine the advisability of providing a full range
- 10 of court services at Kapolei;
- 11
- 12 (4) Ascertain the availability of land for construction of
- 13 a court complex at Kapolei;
- 14
- 15 (5) Determine whether a fourth circuit at Kapolei should
- 16 include a juvenile detention facility;
- 17
- 18 (6) Determine the jurisdiction and venue of a fourth
- 19 circuit;

- 21 (7) Determine the numerical population from which a jury
- 22 pool could be summoned in a fourth circuit; and

- 24 (8) Consider any other relevant matters to the
- 25 establishing a fourth circuit;

29 BE IT FURTHER RESOLVED that the Hawaii State Bar
30 Association is requested to provide the facilities and staffing,
31 and pay for expenses of the task force; and

33 BE IT FURTHER RESOLVED that the Hawaii State Bar
34 Association, on behalf of the task force, report findings and
35 recommendations, including proposed legislation, to the
36 Legislature no later than twenty days prior to the convening of
37 the Regular Session of 2007; and

39 BE IT FURTHER RESOLVED that certified copies of this
40 Concurrent Resolution be transmitted to the Governor, Mayor of
41 Honolulu, Chief Justice, President of the Hawaii State Senate,
42 Speaker of the Hawaii State House of Representatives, President
43 of the Hawaii State Bar Association, State Attorney General,
44 Honolulu Prosecuting Attorney, State Public Defender, Hawaii
