
HOUSE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF EDUCATION TO STUDY THE AIR COOLING NEEDS OF EACH SCHOOL COMPLEX AND TO REVIEW THE FEASIBILITY OF USING ALTERNATIVE AIR COOLING METHODS SUCH AS FANS, HEAT REDUCTION, INSULATION, AND ENERGY EFFICIENT INDIVIDUAL AIR CONDITIONING WALL UNITS.

1 WHEREAS, students need to have the most conducive,
2 comfortable learning environment in order to achieve the
3 educational standards set for them; and

5 WHEREAS, the Legislature finds that a physical learning
6 environment that is free of unnecessary distractions from heat
7 or outside noise is crucial to student learning; and

8
9 WHEREAS, given Hawaii's tropical environment and heat, many
10 classrooms need to be equipped with air conditioning or
11 alternative air cooling methods; and

12
13 WHEREAS, despite a tremendous backlog of repair and
14 maintenance items and the need for new schools and facilities,
15 it is important to include air conditioning costs as part of a
16 comprehensive priority list of critical budget items for the
17 Department of Education; and

19 WHEREAS, the Department of Education has projected that the
20 provision of necessary air conditioning to each school and
21 school complex will cost \$1,000,000,000 over the next five
22 years; now, therefore,

24 BE IT RESOLVED by the House of Representatives of the
25 Twenty-third Legislature of the State of Hawaii, Regular Session
26 of 2006, the Senate concurring, that the Department of Education
27 is requested to study the air cooling needs of each school
28 complex and review the feasibility of using alternative air
29 cooling methods such as fans, heat reduction, insulation, and
30 energy efficient individual air conditioning wall units; and

BE IT FURTHER RESOLVED that the Department of Education is requested to submit a report of its findings and recommendations to the Legislature not later than twenty days prior to the convening of the Regular Session of 2007; and

BE IT FURTHER RESOLVED that certified copies of this Concurrent Resolution be transmitted to the Superintendent of Education and the Chair of the Board of Education.
