
HOUSE CONCURRENT RESOLUTION

REQUESTING THAT SIGN LANGUAGE INSTRUCTION BE COORDINATED.

1 WHEREAS, some children may require augmentative
2 communication, especially when speech is not an effective mode
3 of communication for the child; and
4

5 WHEREAS, American Sign Language is a beautiful
6 visual-spatial language that provides many benefits to those who
7 are deaf and hard of hearing as well as for hearing children;
8 and
9

10 WHEREAS, American Sign Language provides another avenue of
11 communication for children with special needs such as Down
12 Syndrome, Autism, speech delays, and other physical and mental
13 developmental defects; and
14

15 WHEREAS, meeting the nutritional needs of an infant or
16 young child is an integral part of caring for their growth and
17 development; and
18

19 WHEREAS, oral-motor mechanisms are involved in the feeding,
20 sensory integration, postural tone, and overall health of the
21 child, which is sometimes a challenge for children with
22 oral-motor deficits, or swallowing disorders; and
23

24 WHEREAS, one of the primary goals of oral-motor treatment
25 for children with oral-motor deficits is efficient and safe oral
26 feeding for nutrition and the prevention of aspiration, as well
27 as the development of coordinated movements for communication;
28 and

30 WHEREAS, the American Speech-Language Hearing Association
31 certification requirements recommend mandatory training for
32 speech-language students in dysphagia or swallowing disorder
33 therapy, as well as sign language instruction to benefit
34 communication and services for the development and education of
35 children who use sign language; now, therefore,

 2 BE IT RESOLVED by the House of Representatives of the
 3 Twenty-third Legislature of the State of Hawaii, Regular Session
 4 of 2006, the Senate concurring, that the University of Hawaii,
 5 the Department of Education, and the Department of Health are
 6 requested to coordinate sign language instruction within the
 7 University's special education, early childhood education, early
 8 intervention, and medical degree and certificate programs, with
 9 service providers and programs; and

 11 BE IT FURTHER RESOLVED that the University of Hawaii is
 12 requested to continue the progress made with the cooperation of
 13 Kapiolani Community College's sign language interpreter
 14 education program and the University's Speech-Language and
 15 Pathology Departments; and

16
 17 BE IT FURTHER RESOLVED that the Department of Education is
 18 requested to authorize funds to expand Teleschool, especially
 19 for eligible preschool special education students who need time
 20 to develop at home in addition to receiving special education
 21 services; and

22
 23 BE IT FURTHER RESOLVED that the Department of Education
 24 provide video programs and curriculum such as Signing Time! to
 25 teach sign language with videos geared toward infants, toddlers,
 26 and young children, their families, and professionals; and

27
 28 BE IT FURTHER RESOLVED that certified copies of this
 29 Concurrent Resolution be transmitted to the President of the
 30 University of Hawaii, the Superintendent of Education, and the
 31 Director of Health.
