
HOUSE RESOLUTION

REQUESTING THE DEPARTMENT OF EDUCATION, DEPARTMENT OF HEALTH,
AND DEPARTMENT OF HUMAN SERVICES TO IMPLEMENT A PUBLIC-
PRIVATE PARTNERSHIP PILOT PROJECT WITH THE STUDENT FUTURE
AWARENESS PROGRAM TO PROVIDE EARLY INTERVENTION SERVICES TO
MINIMIZE DRUG USE, GANG ACTIVITY, AND VIOLENCE AMONG
HAWAII'S SCHOOL-AGE YOUTH.

1 WHEREAS, instances of substance abuse, bullying, gang
2 activity, violence, and disrespect for authority have reached
3 alarming proportions in Hawaii's elementary, middle, and high
4 schools; and

6 WHEREAS, school administrators, personnel, and support
7 staff struggle to maintain workloads and achieve standards that
8 focus only on educational goals; and

9
10 WHEREAS, the Student Future Awareness Program educates
11 students about the consequences of negative involvement with
12 gangs, violence, and drugs; and

13
14 WHEREAS, the program teaches students the links between
15 issues that include: negative peer pressure, drug use, gang
16 violence, sexuality, runaways, and youth living on the streets;
17 and

19 WHEREAS, the program assists students with choosing
20 alternate strategies to deal with negative peer pressure, home
21 problems, and school stress by encouraging them to make
22 decisions that lead to positive recognition and enhanced
23 acceptance among their peers and community members; and

25 WHEREAS, the program honors students' freedom to make life
26 choices that will result in positive outcomes and will help them
27 to become law-abiding, successful citizens; and

29 WHEREAS, the Student Future Awareness Program proposes to
30 bring its program to all students at the elementary, middle, and
31 high school grade levels; and

2 WHEREAS, the Department of Health provides education,
3 outreach, and awareness to school-age youth on drug abstinence,
4 sexually transmitted diseases, cessation of tobacco use, and
5 healthy lifestyles; and

7 WHEREAS, the Department of Human Services provides
8 training, education, and public awareness programs affecting the
9 capacity of Hawaii youth to be productive members of society;
10 now, therefore,
11

12 BE IT RESOLVED by the House of Representatives of the
13 Twenty-third Legislature of the State of Hawaii, Regular Session
14 of 2006, that the Department of Education, Department of Health,
15 and Department of Human Services, are requested to implement a
16 public-private partnership pilot project with the Student Future
17 Awareness Program to provide early intervention services to
18 minimize drug use, gang activity, and violence among Hawaii's
19 school-age youth; and

21 BE IT FURTHER RESOLVED that the public-private partnership
22 pilot project is requested to adopt the goal of providing
23 services to all elementary, middle, and high school students on
24 the island of Oahu within the 2006-2007 school year; and

26 BE IT FURTHER RESOLVED that the Department of Education,
27 Department of Health, Department of Human Services, and the
28 Future Student Awareness Program are requested to submit a
29 report on the status of the pilot project, including proposed
30 legislation, if any, no later than twenty days prior to the
31 convening of the Regular Session of 2008; and

 2 Resolution be transmitted to the Chairperson of the Board of
 3 Education, the Superintendent of Education, the Director of
 4 Health, the Director of Human Services, and the Executive
 5 Director of the Student Future Awareness Program.
