# A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR CAREER CRIMINAL PROSECUTION UNITS AND  
VICTIM WITNESS ASSISTANCE PROGRAMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1       SECTION 1. There is appropriated out of the general  
2 revenues of the State of Hawaii the sum of \$                    or so  
3 much thereof as may be necessary for fiscal year 2006-2007 for a  
4 grant-in-aid to the department of the prosecuting attorney of  
5 the city and county of Honolulu for the career criminal  
6 prosecution unit, including the hiring of necessary staff.

7       SECTION 2. There is appropriated out of the general  
8 revenues of the State of Hawaii the sum of \$                    or so  
9 much thereof as may be necessary for fiscal year 2006-2007 for a  
10 grant-in-aid to the department of the prosecuting attorney of  
11 the city and county of Honolulu for the victim witness  
12 assistance program, including the hiring of necessary staff.

13       SECTION 3. The sums appropriated in sections 1 and 2 shall  
14 be expended by the city and county of Honolulu for the purposes  
15 of this Act.

16       SECTION 4. There is appropriated out of the general  
17 revenues of the State of Hawaii the sum of \$                    or so



1 much thereof as may be necessary for fiscal year 2006-2007 for a  
2 grant-in-aid to the department of the prosecuting attorney of  
3 the county of Maui for the career criminal prosecution unit,  
4 including the hiring of necessary staff.

5 SECTION 5. There is appropriated out of the general  
6 revenues of the State of Hawaii the sum of \$ or so  
7 much thereof as may be necessary for fiscal year 2006-2007 for a  
8 grant-in-aid to the department of the prosecuting attorney of  
9 the county of Maui for the victim witness assistance program,  
10 including the hiring of necessary staff.

11 SECTION 6. The sums appropriated in sections 4 and 5 shall  
12 be expended by the county of Maui for the purposes of this Act.

13 SECTION 7. There is appropriated out of the general  
14 revenues of the State of Hawaii the sum of \$ or so  
15 much thereof as may be necessary for fiscal year 2006-2007 for a  
16 grant-in-aid to the office of the prosecuting attorney of the  
17 county of Kauai for the career criminal prosecution unit,  
18 including the hiring of necessary staff.

19 SECTION 8. There is appropriated out of the general  
20 revenues of the State of Hawaii the sum of \$ or so  
21 much thereof as may be necessary for fiscal year 2006-2007 for a  
22 grant-in-aid to the office of the prosecuting attorney of the

1 county of Kauai for the victim witness assistance program,  
2 including the hiring of necessary staff.

3 SECTION 9. The sums appropriated in sections 7 and 8 shall  
4 be expended by the county of Kauai for the purposes of this Act.

5 SECTION 10. There is appropriated out of the general  
6 revenues of the State of Hawaii the sum of \$ or so  
7 much thereof as may be necessary for fiscal year 2006-2007 for a  
8 grant-in-aid to the office of the prosecuting attorney of the  
9 county of Hawaii for the career criminal prosecution unit,  
10 including the hiring of necessary staff.

11 SECTION 11. There is appropriated out of the general  
12 revenues of the State of Hawaii the sum of \$ or so  
13 much thereof as may be necessary for fiscal year 2006-2007 for a  
14 grant-in-aid to the office of the prosecuting attorney of the  
15 county of Hawaii for the victim witness assistance program,  
16 including the hiring of necessary staff.

17 SECTION 12. The sums appropriated in sections 10 and 11  
18 shall be expended by the county of Hawaii for the purposes of  
19 this Act.

20 SECTION 13. This Act shall take effect on July 1, 2020.
