
A BILL FOR AN ACT

MAKING AN APPROPRIATION FOR THE COMMUNITY WORK DAY PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The litter control office, established by
2 chapter 339, Hawaii Revised Statutes, existed from 1977 until
3 1996 when it was administratively closed due to budgetary
4 constraints. The legislature finds that the office provided a
5 critical, necessary, and strategic service to the public in
6 serving as the focal point to plan, coordinate, and implement
7 litter control efforts.

8 The litter control office was very successful in its
9 efforts to clean up, prevent, and educate the public about
10 litter. Among its accomplishments were:

- 11 (1) An annual statewide recycling campaign, including a
12 fundraising program for businesses;
13 (2) An annual statewide litter campaign;
14 (3) Involvement of volunteers from organizations;
15 (4) A training program for volunteers;
16 (5) Resolution of complaints of littered sites, including
17 abandoned vehicles;
18 (6) Fundraising from organizations and individuals;



1 (7) Establishment of partnerships with civic and community
2 groups, school and other youth organizations, and
3 businesses;

4 (8) The community work day program; and

5 (9) A shoreline and coastal cleanup.

6 The community work day program is part of the national
7 "Keep America Beautiful" program which partners with businesses
8 and uses in-kind donations to create successful education and
9 action-oriented programs for island-wide cleanups, roadside
10 beautification programs, recycling and waste reduction, and
11 cleanup of polluted water bodies, among other clean environment
12 efforts.

13 The purpose of this Act is to make an appropriation from
14 the general revenues of the State of Hawaii for the community
15 work day program.

16 SECTION 2. There is appropriated out of the general
17 revenues of the State of Hawaii, for recycling education and
18 demonstration projects pursuant to section 342G-104(b)(2),
19 Hawaii Revised Statutes, the following sums or so much thereof
20 as may be necessary for fiscal year 2006-2007 for the community
21 work day programs in the various counties:

6 The sums appropriated shall be expended by the department
7 of health for the purposes of this Act.
