
A BILL FOR AN ACT

RELATING TO ENERGY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. In May 2002, the University of Hawaii gathered
2 major energy and policy stakeholders in Hawaii to convene as the
3 Hawaii energy policy forum. The purpose of the policy forum was
4 to develop an energy vision for Hawaii through the year 2030 and
5 to formulate strategies consistent with implementing that
6 vision. Accordingly, facilitated discussions were conducted on
7 Hawaii's preferred energy future and the issues and constraints
8 that would be encountered in achieving that preferred future.
9 Incorporating a science- and fact-based approach, policy studies
10 were conducted to provide baseline information and review of
11 various environmental, regulatory, economic, social, and
12 cultural issues relating to Hawaii's energy future.

13 In December 2003, the policy forum convened a policy summit
14 to provide a community-based forum for review of its work and
15 recommendations. The final report of the policy forum, "Hawaii
16 at the Crossroads: A Long Term Energy Strategy," sets forth
17 recommended guiding principles and policy options to meet
18 Hawaii's long term energy needs.



1 The purpose of this Act is to appropriate funds to
 2 reconvene the policy forum for the purpose of implementing the
 3 vision, concepts, and recommendations of the policy forum's
 4 final report, and the resulting "Ten Point Plan" to meet
 5 Hawaii's energy goals. This will provide a unique opportunity
 6 for stakeholders to continue their work from planning to
 7 implementation and for further engagement of policy- and
 8 decision-makers and consumers on issues relevant to creating
 9 Hawaii's preferred energy future.

10 SECTION 2. There is appropriated out of the general
 11 revenues of the State of Hawaii the sum of \$, or so
 12 much thereof as may be necessary for fiscal year 2006-2007 to
 13 reconvene the Hawaii energy policy forum for the purpose of:

- 14 (1) Developing a detailed action plan and timeline to
 15 implement the recommendations of the Hawaii energy
 16 policy forum's "Ten Point Plan" to meet Hawaii's
 17 energy goals;
- 18 (2) Developing tangible goals, objectives, desired
 19 outcomes, and actions to implement the energy vision
 20 and strategy of the Hawaii energy policy forum;
- 21 (3) Developing benchmarks for measuring outcomes of energy
 22 implementation strategies;



1 (4) Further engaging Hawaii's business, government, labor,
2 and community leaders and integrating them into the
3 policy activities and discussions of the Hawaii energy
4 policy forum;

5 (5) Developing greater community and public awareness
6 about Hawaii's energy needs and the goals and
7 activities of the Hawaii energy policy forum; and

8 (6) Seeking additional funding for statewide
9 implementation of, and public education regarding, the
10 recommendations and goals of the Hawaii energy policy
11 forum.

12 The sum appropriated shall be expended by the department of
13 business, economic development, and tourism for the Hawaii
14 energy policy forum administered by the social sciences public
15 policy center, University of Hawaii at Manoa, to implement the
16 purposes of this Act.

17 SECTION 3. The Hawaii energy policy forum shall submit a
18 report on the detailed action plan and timeline to the
19 legislature no later than twenty days prior to the convening of
20 the regular session of 2007.

21 SECTION 4. This Act shall take effect on July 1, 2050.
