
A BILL FOR AN ACT

RELATING TO DISASTER PLANNING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. People with disabilities are self-sufficient
2 under normal circumstances, but may have to rely upon the help
3 and assistance of others in a disaster. For example:

4 (1) People with disabilities and older people often need
5 more time than others to make necessary preparation in
6 an emergency;

7 (2) People who are deaf or hard of hearing may not receive
8 early disaster warnings and emergency instructions
9 which are normally disseminated audibly by siren,
10 radio, and television;

11 (3) People who are blind or visually-impaired,
12 particularly the elderly, may be extremely reluctant
13 to leave familiar surroundings in an evacuation;

14 (4) Guide dogs could become confused or disoriented in a
15 disaster, leaving their dependent owners at greater
16 risk;

17 (5) Guide dogs may not be allowed to stay at shelters to
18 assist their dependent owners;



- 1 (6) People with impaired mobility are concerned about
2 being lifted, carried, and then dropped, causing them
3 injury and further impairment;
- 4 (7) People with mental retardation are not always able to
5 understand an emergency situation and could become
6 disoriented and confused;
- 7 (8) People with respiratory illness could require oxygen
8 and respiratory equipment in an emergency; and
- 9 (9) People with epilepsy, Parkinson's disease, and other
10 conditions have very individualized medication
11 regimens that cannot be interrupted without serious
12 consequences.

13 The legislature finds that an unusually high concentration
14 of this population resides in the Moiliili-McCully area of Oahu.

15 The purpose of this Act is to create and make an
16 appropriation for a pilot program to be known as the disaster
17 planning and preparation for at-risk individuals in the
18 community.

19 SECTION 2. (a) There is created a pilot program to be
20 known as the disaster planning and preparation program for
21 at-risk individuals in the community. The department of health
22 shall administer the program through the executive office on



1 aging. The program shall target the population with
2 disabilities living in the Moiliili-McCully area of Oahu.

3 (b) For purposes of subsection (a), the executive office
4 on aging shall consult with interested community entities
5 including, but not limited to, Project DANA, Lanakila Meals on
6 Wheels, Alu Like Inc., American Association of Retired Persons,
7 Catholic Charities, Hawaii Council of Association of Apartment
8 Owners, RSVP Helping Hands Hawaii, Hawaii Meals on Wheels,
9 Moiliili Community Center, Na Lei Aloha, and St. Clement's
10 Church.

11 (c) This section shall be repealed on June 30, 2008.


12 SECTION 3. There is appropriated out of the general
13 revenues of the State of Hawaii the sum of \$50,000, or so much
14 thereof as may be necessary for fiscal year 2006-2007, for the
15 disaster planning and preparation program for at-risk
16 individuals in the community.

17 SECTION 4. The sum appropriated shall be expended by the
18 department of health for the purposes of this Act.

19 SECTION 5. This Act shall take effect on July 1, 2006.
