A BILL FOR AN ACT

RELATING TO WASTEWATER MANAGEMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The county of Hawaii's department of
2 environmental management wastewater division (department) shall
3 conduct a feasibility study for: a wastewater treatment
4 facility for the Kapoho Vacationland Estates and Farmlots, and
5 public restrooms at the Wai O Pae marine life conservation
6 district within the Kapoho Vacationland Estates. The study
7 shall:

- 8 (1) Evaluate various wastewater treatment techniques used
9 in coastal communities;
- 10 (2) Perform a cost-benefit analysis of the different
11 wastewater treatment technologies;
- 12 (3) Determine which wastewater treatment technology is
13 best suited for the Kapoho Vacationland Estates and
14 Farmlots area;
- 15 (4) Examine different financing methods for the wastewater
16 treatment facility;



1 (5) Establish a community-outreach process, which shall
2 include informational meetings for the Kapoho
3 community;

4 (6) Determine whether shoreline certifications are
5 required for constructing the restrooms at Wai O Pae
6 marine life conservation district; and

7 (7) Evaluate the proper design and construction for the
8 restroom facilities at the Wai O Pae marine life
9 conservation district.

10 The department shall prepare a report that includes the
11 feasibility study's findings and recommendations and shall
12 submit the report to the legislature no later than twenty days
13 before the convening of the regular session of 2007.

14 SECTION 2. There is appropriated out of the general
15 revenues of the State of Hawaii the sum of \$, or so
16 much thereof as may be necessary for fiscal year 2006-2007, for
17 a grant-in-aid to the county of Hawaii's department of
18 environmental management wastewater division to conduct a
19 feasibility study for a wastewater treatment facility for the
20 Kapoho Vacationland Estates and Farmlots, and public restrooms
21 at the Wai O Pae marine life conservation district located
22 within the Kapoho Vacationland Estates.

1 SECTION 3. The sum appropriated shall be expended by the
2 county of Hawaii for the purposes of this Act.

3 SECTION 4. This Act shall take effect on July 1, 2006.
