# A BILL FOR AN ACT

RELATING TO THE ONE CALL CENTER ADVISORY COMMITTEE.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. Section 269E-4, Hawaii Revised Statutes, is  
2 amended by amending subsection (a) to read as follows:

3 "[+] (a) [+] The commission shall establish a one call  
4 center advisory committee as a governmental entity as defined  
5 under chapter 662D to advise the commission in implementing this  
6 chapter. The committee shall consist of [~~fifteen~~] seventeen  
7 voting members and one ex officio nonvoting member. Of the  
8 voting members:

9 (1) [~~Nine~~] Eleven shall be appointed by the commission to  
10 serve until successors are appointed by the  
11 commission. The appointments shall be as follows:

- 12 (A) One from the gas utility industry;  
13 (B) One from the electric utility industry;  
14 (C) One from the telecommunications utility industry;  
15 (D) One from the pipeline operator industry;  
16 (E) Two from the General Contractors Association of  
17 Hawaii;



- 1 (F) Two from the Building Industry Association of
- 2 Hawaii; [~~and~~]
- 3 (G) One from the cable service industry;
- 4 (H) One from the water utility industry; and
- 5 (I) One from the wastewater industry.
- 6 (2) One shall be the representative of the city and county
- 7 of Honolulu designated by the mayor of the city and
- 8 county of Honolulu;
- 9 (3) One shall be the representative of the county of
- 10 Hawaii designated by the mayor of the county of
- 11 Hawaii;
- 12 (4) One shall be the representative of the county of Maui
- 13 designated by the mayor of the county of Maui;
- 14 (5) One shall be the representative of the county of Kauai
- 15 designated by the mayor of the county of Kauai;
- 16 (6) One shall be the director of the state department of
- 17 transportation, or the director's representative; and
- 18 (7) One shall be the executive director of the division of
- 19 consumer advocacy, department of commerce and consumer
- 20 affairs, or the executive director's representative.
- 21 A representative of the center shall serve as an ex officio
- 22 nonvoting member of the committee."

1 SECTION 2. Statutory material to be repealed is bracketed  
2 and stricken. New statutory material is underscored.  
3 SECTION 3. This Act shall take effect upon approval.

**Report Title:**

One Call Center; Advisory Committee

**Description:**

Increases voting members on one call center advisory committee from fifteen to seventeen members. Includes among the voting members one person from the water utility industry and one person from the wastewater industry. Effective upon approval.
