
SENATE CONCURRENT RESOLUTION

REQUESTING THAT THE FEDERAL GOVERNMENT ALLOW NATIONAL GUARD
MEMBERS AND MILITARY RESERVISTS WITH TWENTY OR MORE YEARS
OF SERVICE TO RETIRE WITH FULL RETIREMENT BENEFITS.

1 WHEREAS, the terrorist attacks of September 11, 2001,
2 continue to have repercussions today; and

3
4 WHEREAS, thousands of military service members and their
5 families are in the midst of coping with troop deployments to
6 dangerous, volatile, and unstable areas of the world, such as
7 Iraq and Afghanistan; and

8
9 WHEREAS, in addition, many of those who have already
10 completed one tour of duty face re-deployment in what the United
11 States Department of Defense describes as the largest series of
12 troop rotations since World War II; and

13
14 WHEREAS, for instance, approximately eighty-five thousand
15 regular, United States reserves, and national guard troops have
16 been or will be deployed to Iraq as part of the rotation; and

17
18 WHEREAS, such a massive mobilization and deployment of
19 United States forces has not left Hawaii untouched; and

20
21 WHEREAS, the assigned strength of the Hawaii Army National
22 Guard and Hawaii Air National Guard stands at around three
23 thousand and twenty-five hundred, respectively; and

24
25 WHEREAS, as of January 2005, over eighty per cent of the
26 Hawaii Army National Guard, including the entire 29th Brigade
27 Combat Team, had been mobilized for deployment to either Iraq or
28 Afghanistan; and

30 WHEREAS, even beyond the sheer numbers, however, the
31 effects of the call-up of the national guard were substantial;
32 and



1 WHEREAS, although national guard and reserve members
2 recognize their duty and are willing to serve their nation, the
3 disruption to their personal and professional lives cannot be
4 denied; and

5
6 WHEREAS, individuals from all walks of life--from college
7 students and engineers to physicians and public servants--are
8 plucked from their daily routines and sent overseas under
9 hostile conditions; and

10
11 WHEREAS, for many, active service in the Hawaii National
12 Guard and military reserves entails a significant disruption in
13 their life plans; and

14
15 WHEREAS, as beneficiaries of their courageous and dedicated
16 service, the people of this State bear a special responsibility
17 toward United States military forces, but particularly toward
18 our citizen-soldiers in the Hawaii National Guard and military
19 reserves; and

20
21 WHEREAS, the Legislature finds that these patriotic men and
22 women deserve the full support of the State and the nation; and

23
24 WHEREAS, the Legislature believes that one way government
25 can express its appreciation to its citizen soldiers is by
26 providing them with enhanced retirement benefits; now,
27 therefore,

28
29 BE IT RESOLVED by the Senate of the Twenty-third
30 Legislature of the State of Hawaii, Regular Session of 2006, the
31 House of Representatives concurring, that the federal government
32 is requested to allow national guard members and military
33 reservists who satisfactorily serve for twenty years or more in
34 such military service to retire with full retirement benefits;
