# SENATE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO STUDY  
THE POSSIBILITY OF THE STATE DEVELOPING AND OPERATING  
MANUFACTURED-HOUSING PARKS TO HELP ALLEVIATE HAWAII'S  
AFFORDABLE HOUSING CRISIS.

1           WHEREAS, Hawaii's housing costs are among the highest in  
2 the nation; and

3  
4           WHEREAS, Hawaii has long suffered from a lack of affordable  
5 housing for its residents; and

6  
7           WHEREAS, in Hawaii, the only options for residents are to  
8 rent or own real property in the form of single- or multi-family  
9 dwelling units; and

10  
11           WHEREAS, the purchase price of fee simple single-family  
12 dwellings in Hawaii often exceeds \$500,000; and

13  
14           WHEREAS, the monthly rental expense for single-family  
15 dwellings in Hawaii often exceeds \$2,000; and

16  
17           WHEREAS, the cost of owning or renting a home in Hawaii far  
18 exceeds the ability of average working or retired residents to  
19 pay; and

20  
21           WHEREAS, the development of subdivided land parcels for  
22 construction of single- and multi-family dwellings requires  
23 substantial site preparation work that can cost in excess of  
24 \$150,000 per lot, without considering the additional cost of  
25 constructing the dwelling units; and

26  
27           WHEREAS, in many other American locations, manufactured-  
28 housing parks provide an affordable intermediate level of  
29 housing between market-priced rental dwellings, condominium  
30 ownership, and single-family home ownership, for working and  
31 retired taxpayers with low to moderate incomes; and



1           WHEREAS, the cost of site preparation for a manufactured-  
2 housing park is substantially less than the cost of land  
3 subdivision for the construction of condominiums and single-  
4 family homes; and

5  
6           WHEREAS, properly and responsibly developed and operated  
7 manufactured-housing parks can be aesthetically pleasing and  
8 well integrated with surrounding communities that are currently  
9 developed to their highest and best use; and

10  
11           WHEREAS, a series of state-developed and state-operated  
12 manufactured-housing parks would help to solve Hawaii's  
13 affordable housing crisis, and would ultimately generate revenue  
14 for the State of Hawaii; now, therefore,

15  
16           BE IT RESOLVED by the Senate of the Twenty-third  
17 Legislature of the State of Hawaii, Regular Session of 2006, the  
18 House of Representatives concurring, that the Department of Land  
19 and Natural Resources, in consultation with the Housing and  
20 Community Development Corporation of Hawaii, the Department of  
21 Hawaiian Home Lands, the Office of Hawaiian Affairs, each branch  
22 of the United States Armed Forces in Hawaii, and the Planning  
23 Director of each county, is requested to study the feasibility  
24 and usefulness of manufactured-housing parks as one possible  
25 element in the Legislature's efforts to solve the State's  
26 affordable housing crisis; and

27  
28           BE IT FURTHER RESOLVED that each county is requested to  
29 consider the adoption by ordinance of appropriate zoning and  
30 building standards to allow manufactured-housing parks as a  
31 permitted land use; and

32  
33           BE IT FURTHER RESOLVED that the Chairperson of the Board of  
34 Land and Natural Resources is requested to report findings and  
35 recommendations to the Legislature at least twenty days before  
36 the convening of the Regular Session of 2007; and

38           BE IT FURTHER RESOLVED that certified copies of this  
39 Concurrent Resolution be transmitted to the Chairperson of the  
40 Board of Land and Natural Resources, the Executive Director of  
41 the Housing and Community Development Corporation of Hawaii, the  
42 Chairperson of the Hawaiian Homes Commission, the Chairperson of  
43 the Board of Trustees of the Office of Hawaiian Affairs, the
