The purpose of this bill is to provide more time for the
Hawaii 2050 Sustainability Task Force (Task Force) to continue its
efforts by:

- (1) Extending the deadline for the Auditor to submit the
Hawaii 2050 Sustainability Plan by an additional year;
and
- (2) Extending the authority of the Task Force to June 30,
2008.

The Department of Business, Economic Development, and Tourism
testified in support of this bill.

As affirmed by the record of votes of the members of your
Committee on Economic Development & Business Concerns that is
attached to this report, your Committee is in accord with the
intent and purpose of S.B. No. 2493, S.D. 1, and recommends that
it pass Second Reading and be referred to the Committee on
Finance.


