Your Committee on Health, to which was referred S.B. No. 2082
entitled:

"A BILL FOR AN ACT RELATING TO HEALTH INSURANCE,"

begs leave to report as follows:

The purpose of this measure is to establish circumstances
under which insurers, mutual benefit societies, and health
maintenance organizations are required to provide employers with
employer-sponsored group health claims experience.

Testimony in support of this measure was submitted by the
Department of Commerce and Consumer Affairs, the Kaiser
Permanente, Hawaii Medical Service Association, and Summerlin Life
and Health Insurance Company.


Your Committee finds that it is in the best interest of the
entire community that individual privacy be both valued and
protected. Sensitive information should be safeguarded and
individuals should not be penalized for their respective health
conditions. This measure specifies the type of health care
information that may be provided to employer groups and the
circumstances under which it may be provided.

As affirmed by the record of votes of the members of your
Committee on Health that is attached to this report, your
Committee is in accord with the intent and purpose of S.B.
No. 2082 and recommends that it pass Second Reading and be
referred to the Committee on Commerce, Consumer Protection, and
Housing.


